## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pioneer College Caterers, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year then ended December 31, 2024, and the related notes to the financial statements (modified cash basis) (the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS (MODIFIED CASH BASIS) AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

### 1. DESCRIPTION OF THE PLAN AND RELATED INFORMATION

The following description of Pioneer College Caterers, Inc. (the “Company” or “Plan Administrator”) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

**General**—The Plan is a defined contribution profit-sharing plan created on July 1, 1981, for the benefit of the Company’s employees. Effective July 1, 1998, the Plan was expanded to include a Section 401(k) feature as a means for eligible employees to defer a portion of their salary and select certain investment options. Employees are eligible for participation in the profit-sharing feature of the Plan after completion of one year of service, attainment of 21 years of age, and employed on December 31 of each year. Employees are eligible for participation in the 401(k) feature of the Plan after completion of one year of service and attaining the age of 21. A year of service for eligibility purposes is computed as completing not less than 1,000 hours of service during the 12-consecutive-month period beginning on the employment commencement date. Eligible employees may enroll in the Plan on January 1 or July 1. Principal Life Financial Group (“Principal Life”) serves as the trustee of the Plan and provides administrative services to the Plan. Principal Life Insurance Company and Principal Trust Company are members of Principal Life and have certified certain financial information related to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**—The Company makes an annual discretionary contribution to the Plan for the profit-sharing feature. Employer contributions are invested in the same manner that each participant has elected to invest their employee contributions. In circumstances where employees have elected not to participate in the 401(k) feature, employer contributions can be invested in any of the funds offered. If no fund is chosen, the employer contribution will be invested in the Principal Stable Value Fund. Additionally, past employer contributions can be invested in any of the available funds. As participants are fully vested in both their 401(k) contributions and discretionary contributions received, participants are not subject to forfeitures.

Each year, participants may contribute from 1% to 100% of their pretax annual compensation into the 401(k) feature of the Plan, subject to certain limitations as described in the Plan. The Company does not match any of these employee contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Transfers from other qualified plans are permitted from any employee even if the employee is not an eligible Plan participant.

Contributions may be subject to time or other restrictions based on investments selected with respect to withdrawals or transfers.

**Participant Accounts**—Each participant’s account, for the profit-sharing feature, is credited with the allocation of the Company’s contributions, Plan earnings, and Plan expenses. Allocations of the Company’s contributions are based on the participant’s compensation, as defined in the Plan document.

For the 401(k) feature, participant accounts are credited with the participant’s contributions and an allocation of Plan earnings thereon. Plan earnings are allocated daily to the participant’s account based on the participant’s unit value.

**Investments**—Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, pooled separate accounts, and a stable value fund as investment options for participants.

**Vesting**—Participants are vested immediately in their contributions and in Company contributions, plus actual earnings thereon, net of expenses.

**Payment of Benefits**—Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant’s interest in his or her account. Distributions are made following the earlier of (1) age 70 1/2 or (2) Plan or employee termination date. Participants have up to 60 days to determine whether to receive balances less than \$5,000 as either a lump-sum distribution or a rollover to another qualified plan. A participant with an account balance greater than \$5,000 may choose to receive benefits in the form of a lump-sum distribution, a rollover to another qualified plan, or an annuity.

If there is no participant decision after 60 days, the Plan Administrator will distribute balances less than or equal to \$1,000 as a lump-sum payment to the participant, while balances greater than \$1,000 will be distributed as a direct rollover to an individual retirement plan designated by the Plan Administrator. A charge or restriction may apply for some investment options if all or part of the benefits are received in a single sum.

Additionally, in-service withdrawals are available for a participant upon attainment of age 59 1/2.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements (modified cash basis) have been prepared on the modified cash basis of accounting, whereby contributions and interest income are recognized when received.

**Use of Estimates**—The preparation of financial statements (modified cash basis) in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Risks and Uncertainties**—The Plan provides for various investment options in common stocks, a money market fund, a guaranteed interest account, and in registered investment companies which invest in combinations of stocks, bonds, fixed-income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

**Investment Valuation and Income Recognition**—The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Realized gains or losses on investments sold and unrealized gains or losses on investments held are reflected in the statement of changes in net assets available for benefits (modified cash basis) as the net appreciation or depreciation in the fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on the cash basis of accounting.

**Administrative Expenses**—Administrative expenses included in the financial statements (modified cash basis) are contract administrator fees charged by Principal Life. These expenses are allocated among participant balances on a pro rata basis and totaled \$77,116 for the year ended December 31, 2024.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution.

**Excess Contributions Payable**—The Plan is required to return contributions received during the Plan year in excess of the Internal Revenue Code (IRC) limits. Any excess contributions would be reflected as a reconciling item in Note 8 evidencing the rollforward between the financials herein (which are on a modified cash basis) and the Form 5500 (which is on an accrual (Generally Accepted Accounting Principles “GAAP”) basis.

### 3. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques**—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual Funds**—Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are actively traded open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Pooled Separate Accounts and Collective Trust Funds**—These investments are primarily invested in domestic stocks and mutual funds. The pooled separate accounts are valued at the daily closing price as reported or published by the fund. These accounts have been determined to have a readily determinable fair value based on the published price and transact at that price.

**Stable Value Fund**—The Principal Stable Value Fund (the “Fund”) is a collective trust fund in which the beneficial interest of each participant is represented by units. Units may be issued daily at the Fund’s current NAV. Distribution to the Fund’s unitholders is declared daily from the net investment income and automatically reinvested in the Fund. The Fund seeks current income by investing primarily in insurance contracts issued by insurance companies and investments from other financial institutions that offer stability of principal. It is the policy of the Fund to use its best efforts to maintain a stable NAV, although there is no guarantee that the Fund will be able to maintain this value. The Fund is valued at the daily closing price as reported or published. This Fund has been determined to have a readily determinable fair value based on the published price and transacts at that price.

The following tables set forth by level within the fair value hierarchy a summary of the Plan’s investments measured at fair value on a recurring basis at December 31, 2024 and 2023:

#### 4. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Plan investments in the Fund and separate accounts are managed by the Plan’s trustee, Principal Life, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for the investment management services were \$77,116 for the year ended December 31, 2024.

#### 5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

## 6. FEDERAL INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by Principal Life Insurance Company. Principal Life Insurance Company received an opinion letter from the Internal Revenue Service (“IRS”), dated August 8, 2014, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements (modified cash basis).

## 7. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements (modified cash basis) and supplemental schedule (modified cash basis), that was prepared by or derived from information prepared by Principal Life, the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that such information is complete and accurate.
