Independent Auditor's Report

To the Plan Administrator
The Baltimore Life 401(k) Benefit Plan

Opinion

We have audited the financial statements of The Baltimore Life 401(k) Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of the Plan

The following description of The Baltimore Life 401(k) Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of The Baltimore Life Insurance Company (the "Company" or "Plan Sponsor") who have one month of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by the Company. The Plan's assets are held in the custody of T. Rowe Price Trust Company ("T. Rowe"). T. Rowe Price Retirement Plan Services, Inc. also serves as the Plan record keeper.

Contributions

Each year, participants may contribute up to 15% (subject to Internal Revenue Service ("IRS") limitations) of pre-tax annual compensation as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. New employees are automatically enrolled at a pre-tax deferral rate of 4% of eligible compensation, unless and until the employee opts out, after one month of service. The Company contributes a 100% match on each dollar contributed by the participant up to the first 4% of a participant's eligible compensation as defined by the Plan agreement. In addition to this, the Company will contribute 2% of an employee's annual pay, each year, to 401(k) accounts of all eligible employees whether they contribute to the Plan or not.

Participant accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and allocations of Plan earnings and is charged with an allocation of administrative expenses. General administrative expenses not associated with specific participant transactions (loans, rebalancing, etc.) are not charged against participant accounts but are instead paid by the Company. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. The following presents the Company's schedule of vesting:

Investment options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in 24 investment options managed by an affiliate of the custodian, T. Rowe. Participants may change their investment options at any time.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of (a) \$50,000 reduced by the participant's highest outstanding Plan loan balance during the year preceding the date of the loan or (b) one-half of the value of their vested interest in their account. The loan interest rate is set at 1% above the prime rate. As of December 31, 2024 and 2023, interest rates ranged from 4.25% to 9.50%, respectively. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of benefits

On termination of service due to termination of employment, death, disability, severe financial hardship (as defined by the IRS) or retirement, a participant may elect to receive a lump-sum distribution or delay taking the vested benefits until as late as the participant's "Required Beginning Date". The Required Beginning Date for all employees is the April 1 following the end of the calendar year in which the participant reaches age 73 (or age 70½ if you were born before July 1, 1949). If the value of the participant's account is less than \$1,000, a lump-sum distribution will automatically be made.

Forfeited accounts

Under the Plan agreement, forfeited balances on terminated participants' nonvested accounts are used to reduce future employer contributions or pay administrative expenses. During 2024, \$72,486 was used to reduce employer contributions and \$19,482 was used to pay administrative expenses. At December 31, 2024 and 2023, the balance of forfeited accounts available to reduce future employer contributions is \$2,017 and \$97, respectively.

Note 2 - Summary accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent asset and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payments of benefits

Benefits payments to participants are recorded upon distribution.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

Material subsequent events have been considered for disclosure and recognition in these financial statements through June 25, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trusts: Valued at the net asset value ("NAV") of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The primary objectives of the TRP Stable Value Fund are to maximize current income consistent with preserving principal and accumulating earnings.

The investment objective of the Equity Index Trust Class C Fund is to provide investment results that correspond to the total return performance of common stocks publicly traded in the United States as represented by the Standard & Poor's 500 Composite Stock Index.

Note 4 - Plan termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Should the Plan terminate at some future time, the net assets of the Plan are to be allocated, first, to pay all necessary expenses of the Plan and, second, to the participants of the Plan. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 5 - Income tax status

The IRS has determined and informed the Company by a letter dated August 19, 2020, that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds and common collective trusts managed by T. Rowe, custodian of the Plan. These transactions qualify as exempt party-in-interest transactions.

T. Rowe provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MSA") between the Company and T. Rowe. T. Rowe receives revenue from mutual fund and collective trust fund service providers for services T. Rowe provides to the funds. This revenue is used to offset certain amounts owed to T. Rowe for its administrative services to the Plan.

If the revenue received by T. Rowe from such mutual fund or collective trust fund service providers exceeds the amount owed under the MSA, T. Rowe remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there was an excess amount of \$156,877, which was used to offset administrative expense and allocated to participant accounts.

Note 7 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
