**1. DESCRIPTION OF THE PLAN**

The following descriptive plan information for DLH Solutions, Inc. Health and Welfare Benefit Plan (the "Plan"), a defined benefit health and welfare benefit plan, set forth herein is provided for general information purposes only. The Plan provides self-insured medical and fully-insured dental, vision, life, and accidental death and dismemberment insurance benefits for eligible employees. DLH Solutions, Inc. is the Plan sponsor. Comerica Bank serves as trustee of the trust. Boon Administrative Services, Inc. serves as Third Party Administrator. Participants should refer to the Plan agreement for more complete information, copies of which may be obtained from the Plan sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

**General**

In April 2011, DLH Solutions, Inc. ("the Company") established a trust (the "VEBA Trust") for the purpose of funding certain health and welfare benefits for eligible participants and their dependents under three separate defined benefit health and welfare plans: Teamstaff Government Solutions GWL Benefit Plan, Teamstaff Government Solutions Dental Plan and Teamstaff Government Solutions Part Time Employee Health and Welfare Plan (collectively the "Former Plans"). The VEBA Trust was funded by irrevocable cash contributions paid by or at the direction of the Company or eligible participants to be held, invested, reinvested, managed, administered and distributed for the exclusive benefit of Plan participants. The VEBA Trust acts as the conduit for payment of claims, premiums and other Plan expenses.

**Eligibility**

Employees of the Company performing work on service contracts between the Company and the United States government ("SCA employees") are eligible to participate in the Plan. Leased, contract or temporary employees, employees covered under a collective bargaining agreement, self-employed individuals and certain others are not eligible to participate in the Plan. Dependents include legal spouse, children less than 26 years of age or a child older than 26 years of age that is permanently or totally disabled. Benefits take effect on the first day of the month after the eligible employee is in active service and the first employer contribution has been made.

**Contributions**

Employer contribution amounts are determined under The McNamara-O'Hara Service Contract Act ("SCA"). The Company provides service employees for contracts with the United States. The SCA requires contractors and subcontractors performing services on covered federal contracts to pay service employees in various classes no less than the monetary wage rates and to furnish fringe benefits found prevailing in the locality, or the rates contained in a predecessor contractors' collective bargaining agreement. The Company contributes the amounts calculated based upon hours worked multiplied by a stated rate to meet its obligations under the SCA as well as the benefits and expenses of the Plan.

The Company plans to make contributions which are sufficient to meet the current and future costs of the Plan, and has the ability to do so. The assets of the Plan are held in the VEBA Trust and are used to provide benefits to the participants and their dependents. The VEBA Trust fund is administered by Comerica Bank, an institutional trustee (the "Trustee"), under an agreement with the Company.

**Stop Loss Coverage**

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The Plan's stop loss policy has a \$175,000 deductible. For the year ended September 30, 2024 and 2023, the Plan had recoveries of \$111,313 and \$251,978, respectively, realized as a reduction of claims paid.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements have been prepared on a modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States. Employer contributions and interest income is recorded as received. Claims paid, insurance premiums and administrative expenses are recognized when paid rather than when obligations are incurred. Purchases and sales of securities are recognized on the settlement date rather than on the trade date. The financial statements are not intended to present the Plan's net assets available for benefits and the changes in its net assets available for benefits in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of the financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and the disclosure of contingencies, at the date of the financial statements and changes therein during the reporting period. Actual results could differ from those estimates.

**Recognition of Premiums and Claims Paid**

Premiums and claims paid are recognized when paid.

**Administrative Expenses**

The expenses incurred for the administration of the plan, including fees to manage the trust fund and administrative costs related to the processing of benefits are paid by the trust.

**Benefit Obligations - Self Insured Claims Liability**

The Plan makes payments related to the self-insured program as requested by the administrator of Plan benefits to fund benefit payments, which are reflected in the statements of changes in net assets available for benefits – modified cash basis when paid. The estimated liability for such amounts disbursed for self-insured benefits subsequent to the period end for “claims incurred but not reported” at September 30, 2024 and 2023 are approximately \$895,000 and \$1,374,000, respectively. For the year ended September 30, 2024, the Plan had claims reported and approved for payment totaling \$8,523,679 and \$9,002,679 of total payments were made for claims during the year. For the year ended September 30, 2023, the Plan had claims reported and approved for payment totaling \$8,409,833, and \$8,381,833 of total payments were made for claims during the year.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recognized as of the date of the trade, and any related receivables or payables pending settlement at year end are reflected on the statements of net assets available for benefits - modified cash basis.

**Payment of Benefits**

Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement.

**Cash**

Cash represents amounts held on deposit by the insurance provider to maintain minimum funding requirements. Due to timing and amount of claims, the Plan could experience temporary negative cash balance at a certain point.

**Stop Loss**

The premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits-modified cash basis.

**Subsequent Events**

The plan has evaluated events occurring after the statement of net assets available for benefits date through July 10, 2025, the date the financial statements were available to be released. Based upon this evaluation, the Plan has determined that no subsequent events have occurred, which require adjustment to or disclosure in the financial statements.

**3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

No auditing procedures were performed by the independent auditor as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA with respect to information certified as complete and accurate by the trustee, except for comparing such information with information reported in the financial statements. The following information included in the financial statements and supplemental schedules was obtained from data that has been prepared and certified as complete and accurate by Comerica Bank.

- Investments, as shown on the statements of net assets available for benefits – modified cash basis as of September 30, 2024 and 2023.
- Interest income, as shown on the statements of changes in net assets available for benefits – modified cash basis for the years ended September 30, 2024 and 2023.

**4. PARTY-IN-INTEREST TRANSACTIONS**

Administrative expenses include amounts paid to parties-in-interest for custodial fees, accounting fees and other administrative expenses. Personnel and facilities of the Plan sponsor have been used to perform administrative functions for the Plan at no charge to the Plan.

**5. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. For the years ended September 30, 2024 and 2023, there were no transfers in or out of Level 3.

The following is a description of the valuation methodologies and inputs used for assets measured at fair value. There have been no changes in methodologies used at September 30, 2024 and 2023.

*Money Market Mutual Fund* - The fair value of this investment is based upon the quoted price of \$1 per unit.

**6. TAX STATUS**

The Trust established under the Plan to hold the Plan's assets obtained its latest determination letter on December 2, 2011, in which the Internal Revenue Service stated that the trust as designed was in compliance with the applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has been amended since December 2, 2011, but the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan administrator has evaluated the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure of a liability in the financial statements. The Plan is subject to routine audits by taxing and regulatory jurisdictions; however, there are currently no audits for any tax periods in progress. In addition, there have been no tax related interest or penalties for periods presented in these financial statements.

**7. PRIORITIES UPON TERMINATION OF PLAN**

The Company anticipates and believes that the Plan will continue without interruption, but reserves the right to discontinue or amend the Plan and revise the amount of the Company contribution and participant eligibility requirements at any time and to terminate the Plan subject to the provisions set forth in ERISA. If terminated, the remaining assets of the Plan on the date of such termination shall be exhausted to pay benefits.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits – modified cash basis.
