NOTE 1 – DESCRIPTION OF PLAN

The following brief description of United Cerebral Palsy of Central California, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) profit sharing plan established October 1, 1991, which covers substantially all employees of United Cerebral Palsy of Central California, Inc. (the Organization). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustees. The Plan has been restated for final Cycle 3 regulations effective October 1, 2021. The Plan's purpose is to enable eligible employees to defer a portion of their salary to provide for their retirement.

Eligibility

An employee becomes eligible to participate in the Plan for salary deferrals and employer matching contributions after attaining age eighteen and completing three months of service. An employee becomes eligible to participate in the Plan's nonelective employer profit sharing contribution after attaining age eighteen and completing one year of service. A participant may not make withdrawals from their account prior to attaining normal retirement age except in the event of death, total or permanent disability, retirement, termination of employment, or proven hardship.

Participant contributions

An employee will be eligible to elect to make a pre-tax or Roth salary deferral on the first day of the month following completion of the age and service requirements. Plan participants may contribute a percentage or dollar amount of their annual compensation to the Plan up to the maximum determined annually by the Internal Revenue Service. If the participant is age 50 or older, the participant may elect to defer additional amounts as defined by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes a provision for eligible automatic contribution arrangements whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation.

Employer contributions

The Organization makes a matching contribution equal to 10% of the participant's salary deferrals, up to a maximum match of \$1,000. During the years ended September 30, 2024 and 2023, the Organization made a matching contribution of \$12,022 and \$12,541, respectively, to the Plan.

Each year the Organization may make a nonelective profit sharing contribution to the Plan. Contributions will be allocated to eligible participants in proportion to each participant's compensation for the plan year to total eligible compensation for all participants for that year. During the years ended September 30, 2024 and 2023, the Organization made a nonelective profit sharing contribution of \$15,000 and \$20,000, respectively, to the Plan.

Contributions are subject to certain IRS limitations.

NOTE 1 – DESCRIPTION OF PLAN (continued)

Participant accounts

Each participant's account is credited with the participant's contributions, the Organization's matching contribution, as well as allocations of the Organization's nonelective profit sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants may direct the investment of their contributions, and any employer contributions, into a variety of pooled separate accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants

Participants may borrow a minimum of \$1,000 and maximum of 50% of their vested account balance up to \$50,000. Only one loan may be outstanding at a time. The loans are to be repaid with interest at least quarterly and in a time period not to exceed five years, unless the loan is for the purchase of the participant's principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

Payment of benefits

Upon retirement, death or disability, distributions may be made in the form of a lump sum of the participant's vested account balance, or a series of substantially equal installments of the participant's vested account balance. Participants can request an in-service distribution at normal retirement age.

Vesting

Participant contributions, rollovers, employer matching contributions and actual earnings thereon are immediately 100% vested. Nonelective profit sharing contributions made by the Organization vest on a pro rata basis over five years. In the event of death, disability or retirement, a participant's interest in employer discretionary contributions become fully vested.

Forfeitures

Forfeitures are used to reduce future employer contributions. If a participant does not receive a distribution of their vested account balance, the nonvested portion is forfeited at the end of the plan year during which the participant incurs their fifth consecutive one-year break in service. At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$104 and \$5,694, respectively. During the year ended September 30, 2024, employer contributions were reduced by \$5,734 from forfeited nonvested accounts. During the year ended September 30, 2023, employer contributions were not reduced by forfeited nonvested accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive insurance contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from the financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Excess contributions payable

There were no amounts payable to participants for contributions in excess of amounts allowed by the IRS for the year ended September 30, 2024. Amounts payable to participants totaling \$2,146 for contributions in excess of amounts allowed by the IRS were recorded as a liability with a corresponding reduction to contributions for the year ending September 30, 2023. The Plan distributed the September 30, 2023 excess contributions and related earnings to the applicable participants within 4 months after the plan year end.

Delinquent participant contributions

A participant contribution is considered delinquent if the plan sponsor does not remit the participant's elective deferral withholdings and loan payments within a timely manner. Delinquent contributions must be reported for each subsequent year until after the year the violation has been fully corrected.

There were delinquent participant contributions of \$37,241 related to four payrolls during the plan year ended September 30, 2024. Lost earnings are to be calculated and remitted in the subsequent plan year.

There were delinquent participant contributions of \$7,912 related to three payrolls during the plan year ended September 30, 2023. Lost earnings were calculated and remitted during the plan year ended September 30, 2024.

Delinquent participant contributions (continued)

There were delinquent participant contributions of \$14,313 related to two payrolls during the plan year ended September 30, 2022. Lost earnings were calculated and remitted during the plan year ended September 30, 2023.

Subsequent event

Plan management has evaluated subsequent events through July 9, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 – FULLY BENEFIT RESPONSIVE INSURANCE CONTRACTS

The Plan holds an insurance contract that meets the fully benefit-responsive insurance contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive insurance contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value was \$276,215 and \$241,417 at September 30, 2024 and 2023, respectively.

The insurance contract held by the Plan is a guaranteed insurance contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is declared every month for financial activity in the coming month.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive insurance contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include termination of contracts, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and liberalization of plan withdrawal or transfer rules.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer nonelective profit sharing contributions.

NOTE 7 – ALLOCATION OF ASSETS

Net assets available in the amount of \$525,447 and \$397,747 as of September 30, 2024 and 2023, respectively, have been allocated to the accounts of employees who have separated service with the Organization. Non-vested amounts subject to forfeiture in future years total \$1,474 and \$555 of net assets available for benefits as of September 30, 2024 and 2023, respectively.

NOTE 8 – RELATED PARTY TRANSACTIONS

The plan assets were managed by The Standard. Plan management includes record keeping and investment services related to contributions received, plan earnings and distributions. The services to the Plan qualify as party-in-interest transactions. Investment management services and third party administrative services are paid for by the Plan. The Standard administration fees totaled \$26,677 and \$23,747 for the years ended September 30, 2024 and 2023, respectively. Investment advisory fees reported by The Standard related to the Plan totaled \$14,517 and \$12,926 for the years ended September 30, 2024 and 2023, respectively.

Administrative functions are jointly performed by employees of the Organization and The Standard. No employee receives compensation from the Plan. The independent auditor's fees are paid directly by the Organization.

NOTE 9 – TAX STATUS

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
