**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the JST Corporation 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all employees of JST Corporation (“the Company”) who have attained the age of 21 and completed three months of service, as defined, with the exception of employees who are members of a collective bargaining agreement or are employed by an affiliated company not located in the United States. Eligible employees enter the Plan on the first day of the month after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions: Each year, participants may contribute up to 100% of their annual compensation on a pretax basis to the Plan up to the maximum limit permitted by the Internal Revenue Service (“IRS”). The Plan also allows participants who have attained age 50 to make catch-up contributions in accordance with Code Section 414(v). Participants may also contribute amounts representing distributions from other qualified retirement plans. Effective January 1, 2017, the Plan was amended to provide a safe harbor matching contribution of 100% of salary deferrals up to the first 3% of Plan compensation, plus 50% of salary deferrals up to the next 2% of Plan compensation. The Company may also elect to contribute an additional discretionary matching contribution and/or an additional discretionary profit-sharing contribution to the Plan. There were no discretionary matching contributions or profit-sharing contributions made for 2024.

Investments: Participants direct the investment of their accounts into various investment options offered by the Plan. Participants are allowed to change the investment of their accounts on a daily basis.

Participant Accounts: Each participant’s account is credited with the participant’s own contribution and an allocation of the Company’s contributions and the Plan’s earnings. Allocations are based on participant earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant’s vested account.

Retirement: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their own contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in employer discretionary contributions plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service and vests at the rate of 20% per year beginning with the participant’s second year of credited service.

Forfeitures: Any forfeitures for a given period are segregated into a separate account and are made available to pay plan expenses and then to reduce employer contributions. At December 31, 2024 and 2023, \$6,546 and \$8,047, respectively, of forfeitures were available to pay plan expenses or reduce employer contributions.

Payment of Benefits: Participants are entitled to a distribution of all vested amounts upon termination of employment with the Company in the form of a lump-sum distribution. Participants who terminate service with a vested balance of less than or equal to \$5,000 will have their benefits paid as a lump-sum distribution. A participant may elect to receive in-service withdrawals from his or her vested account balance upon certain circumstances including certain cases of financial hardship and the participant’s attainment of age 59½.

**NOTE 1 - DESCRIPTION OF PLAN** (Continued)

Notes Receivable from Participants: Participants may borrow from their 401(k) accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their 401(k) vested account balance. Loan terms are five years except for loans made for the purchase of a primary residence, which may be repaid over a period up to 15 years. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1% as determined at the time the loan is requested. Principal and interest are repaid through payroll deductions.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Company.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks as well as the risks associated with global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

### **NOTE 3 - RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

### **NOTE 4 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) ("John Hancock").

### **NOTE 5 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Pooled Separate Accounts: All of the Plan's investments are units of pooled separate accounts. The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each of the pooled separate accounts held by the Plan is a passively managed fund that invests in a particular type of securities indicated by the pooled separate account's name. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain fees are paid by the Company for administration of the Plan. Participant loan maintenance fees are paid through the Plan by the individual participants. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan invests in shares of pooled separate accounts managed by John Hancock. John Hancock is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to John Hancock qualify as party-in-interest transactions.

**NOTE 7 - TAX STATUS**

The Plan was restated onto a prototype document sponsored by Retirement Plan Consultants, Inc., effective January 1, 2022; therefore, the Plan is not required to file for an individual determination letter from the IRS. The prototype document has received a favorable opinion letter from the IRS dated June 30, 2020. The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through July 11, 2025, which is the date the financial statements were available to be issued.

Effective March 1, 2025, the Plan was amended to change the Employer name to J.S.T. Corporation and the Plan name to J.S.T. Corporation 401(k) Plan.
