Independent Auditor's Report

To the Administrative Committee of the
Coreslab Structures, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Coreslab Structures, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion

DECEMBER 31, 2024 AND 2023

A. DESCRIPTION OF THE PLAN

The following description of the Coreslab Structures, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan Agreement and Summary Plan Description for a more complete description of the Plan’s provisions.

General

In January 1989, the Coreslab Structures, Inc. 401(k) Plan (the “Plan”) was established for the employees of Coreslab Structures (Ariz) Inc. and Coreslab Structures (Texas) Inc. In January 1994, the Plan was amended to include any employee who was a participant in a 401(k) plan maintained by a company acquired by Coreslab Holdings U.S. Inc. & Subsidiaries (the “Sponsor”). The companies eligible to participate in the Plan are:

The Plan is a defined contribution plan maintained under Section 401 of the Internal Revenue Code that covers substantially all employees of the above companies who meet specified age and service requirements, and which provides for pension and disability benefits. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”).

As of December 31, 2024 and 2023, the Plan’s record-keeper was Automatic Data Processing, Inc. (“ADP”). As of December 31, 2024 and 2023, the trustee was Reliance Trust Company.

Contributions

Contributions to the Plan are made as directed by the participants. Participants may generally contribute up to a maximum of 70% of their compensation on a pre-tax basis, within IRS limits (maximum of \$23,000 and \$22,500 for 2024 and 2023, respectively, with certain additional catch-up contributions of \$7,500 for both 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified pension plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Employer contributions may be made at the discretion of the Sponsor. No employer contributions were made for 2024.

A. DESCRIPTION OF THE PLAN - Continued

Participant Accounts

Each participant's account is credited with their individual contributions on a cash basis when received by the Plan's trustee. In addition, each participant's account is credited with an allocation of any Sponsor's contribution, plan earnings and forfeitures of nonvested accounts of terminated employees. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are also credited with rollovers from participants' other qualified plans when received by the Plan.

Vesting

Participants vest in their individual accounts based on years of continuous service. Participant contributions are 100% vested when contributed, and Sponsor contributions are 100% vested after three years of continuous service. The Plan sponsor may use forfeitures to pay plan expenses or to reduce amounts otherwise required to be contributed to the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loans are secured by the vested balance in the participant's account and bear interest at the prime rate (as published by the Wall Street Journal on the 14th day of each month) plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

If the value of a participant's vested benefit is less than \$1,000 upon termination of service, participants automatically receive a cash out election form 60 days from termination date. If the value of a participant's vested benefit exceeds \$1,000, participants may elect to receive either a lump sum payment amount equal to the value of his or her vested account, or to defer the distribution until retirement. On termination due to disability or death, a participant's vested account balance will be distributed to the participant (or participant's beneficiary) as soon as practicable. The distribution is made in the form of a single lump-sum payment.

Administrative Expenses and Investment Fees

The Sponsor pays certain administrative expenses of the Plan except for recordkeeping expenses, which are charged directly to the participant's account. Additionally, any mutual fund expenses or other transaction fees are charged directly to the participant's account.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value using primarily quoted market prices. See Note H. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the cash basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability and netted against participant contributions in the statement of changes in net assets available for benefits. The Plan distributes the excess contributions to the applicable participants within the timeframe established by the IRS.

Fair Value Measurements

Assets recorded at fair value in the statements of net assets available for benefits are categorized based on the level of judgment associated with the inputs used to measure their fair value. Level inputs are as follows:

Level 1 - Values are unadjusted quoted prices for identical assets in active markets accessible at the measurement date.

Level 2 - Inputs include quoted prices for similar assets in active markets, quoted prices from those willing to trade in markets that are not active, or other inputs that are observable or can be corroborated by market data for the term of the instrument. Such inputs include market interest rates and volatilities, spreads and yield curves.

Level 3 - Certain inputs are unobservable (supported by little or no market activity) and significant to the fair value measurement. Unobservable inputs reflect the best estimate of what hypothetical market participants would use to determine a transaction price for the asset or liability at the reporting date.

Risks and Uncertainties

The Plan provides for various investment fund options, which in turn invest in any combination of stocks, bonds and other investment securities exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Payments of Benefits

Benefit payments to participants are recorded when paid.

E INCOME TAX STATUS

The Plan obtained its latest determination letter dated March 25, 2005, in which the Internal Revenue Service stated that the Plan, as designed August 18, 2004, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Sponsor and administrator believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, the Plan Sponsor and the administrator believe that the Plan was qualified as of December 31, 2024 and 2023 and, accordingly, no provision for income taxes is included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
