INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants

Opinion on the Financial Statements

We have audited the financial statements of the Progressive AE Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Progressive AE Employee Stock Ownership Plan as of September 30, 2024 and 2023, and the changes in net assets available for benefits for the year ended September 30, 2024 in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Progressive AE Employee Stock Ownership Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. Responsibilities of Management for the Financial Statements

These amounts represent 63.15% and 62.24% of total investments held under the Plan as of September 30, 2024 and 2023, respectively.
