Note 1 – Description of the Plan

The following brief description of Visiting Nurse and Hospice Home Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan instrument for complete information.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Visiting Nurse and Hospice Home, Inc. d/b/a Stillwater Hospice (the Company). Eligible employees may participate in the Plan beginning the first payroll period after the date of hire by making salary reduction contributions. Eligible employees may also receive employer matching contributions and employer discretionary contributions after reaching age 21 and completing one year of service. A year of service constitutes a total of at least 1,000 hours of service over a period of twelve consecutive months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 100% of pretax annual compensation, as defined in the plan document, not to exceed limits imposed by law. During the year ended December 31, 2024, the Company matched up to 50% of participant deferrals, not to exceed 1.5% of the participant's compensation. Participants may also contribute amounts representing distributions from a previous employer's qualified plan, which are not subject to matching.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer matching contributions, employer discretionary contributions, and investment earnings thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portions of their accounts, plus actual earnings thereon, is based on years of continuous service. Each participant vests 20% per year and is 100% vested after five years of credited service, or upon attaining the age of 55.

Investment Options

Participants are able to direct the vested balance of their accounts to any of a number of investment options comprised of mutual funds, a corporate bond fund, and investment contracts with Lincoln Financial Group Trust Company, Inc. Participants may change their investment options at any time, subject to limitations.

Payment of Benefits

Benefits are payable upon retirement after attaining early retirement age of 55, or at any time on or after the date upon which a participant reaches the age of 59½. Benefits are paid to participants or designated beneficiaries either as a lump sum distribution, through installment payments, or through annuity payments, as selected by the participant.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The notes receivable are secured by the balances in the participants' accounts and bear interest at the prime rate at the time of the loan plus 1%, which is commensurate with the prevailing rate as determined by the plan custodian at the time of each loan. Principal and interest are paid ratably on a monthly repayment schedule.

Forfeited Accounts

Forfeited non-vested accounts are used to reduce employer matching contributions and/or discretionary contributions. Forfeited accounts totaled \$905 and \$-0- as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, employer contributions were reduced by \$2,629 by utilizing forfeited non-vested accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), which requires the plan administrator to make estimates and assumptions affecting certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for the investment contracts with insurance company, which are reported at contract value. Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable are reclassified as deemed distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Plan Administrative Expenses

Plan administrative expenses are comprised primarily of plan asset-based charges paid to the custodian and advisory fees paid to an outside advisor. Certain administrative expenses and fees, other than those previously noted, were paid by the Company, and are therefore not reflected in the Plan's financial statements.

Subsequent Events

The plan administrator evaluated subsequent events through June 18, 2025 the date these financial statements were available to be issued. Events occurring through that date have been evaluated to determine whether a change in the financial statements or related disclosures would be required.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy prioritizing the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices observable for the asset or liability;
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair measurement level within the fair value hierarchy is based on the lowest level of any input significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest bearing cash: Valued at the daily closing price as reported by the fund (Level 1 inputs).

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the SEC. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

Corporate bond fund: Valued using pricing models maximizing the use over observable inputs for similar securities. This includes basing the value on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, those corporate bonds are valued under a discounted cash flow approach which maximizes observable inputs, such as current yields or similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks (Level 2 inputs).

Note 4 – Investment Contracts With Insurance Company

The Plan has investment contracts with Lincoln Financial Group Trust Company, Inc. For each contract, Lincoln Financial Group Trust Company, Inc. maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The crediting interest rate is adjusted periodically, with minimum guaranteed rates for the Lincoln Stable Value Account and Lincoln Fixed Account of 1.0% and 3.0%, respectively. Interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents, including complete or partial plan termination or merger with another plan, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events, such as divestures or spin-offs of a subsidiary, (4) the failure of the trust to qualify for the exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of a material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

Note 5 – Tax Status

Since the Plan is maintained under Internal Revenue Code Section 403(b), rather than Section 401(a), there is no Internal Revenue Service program pursuant to which an individual determination letter may be obtained for the Plan. The plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position which more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by jurisdictions. There are currently no audits for any tax periods in progress.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 7 – Certified Information

At December 31, 2024 and 2023, the Plan's investments were maintained by Lincoln Financial Group Trust Company, Inc. The custodian supplied the plan administrator with a certification as to the completeness and accuracy of all information relating to investments as of December 31, 2024 and 2023, and income and expenses on such investments for the year ended December 31, 2024. The certified information includes total investments of \$6,439,387 and \$5,443,392 at December 31, 2024 and 2023, respectively, which diverges from the statements of net assets available for benefits by the values of the employer receivable. The certified information also includes the activity reported on the statement of changes in net assets available for benefits for the year ended December 31, 2024 except for the impact of the employer receivable on contribution income.

Note 8 – Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the plan, any party rendering service to the plan, the employer, and certain others. The Plan holds certain investment funds managed by the plan trustee. Such investments and the Plan's payment of fees qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some professional fees for the administration and audit of the Plan are paid directly by the Company.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to numerous risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
