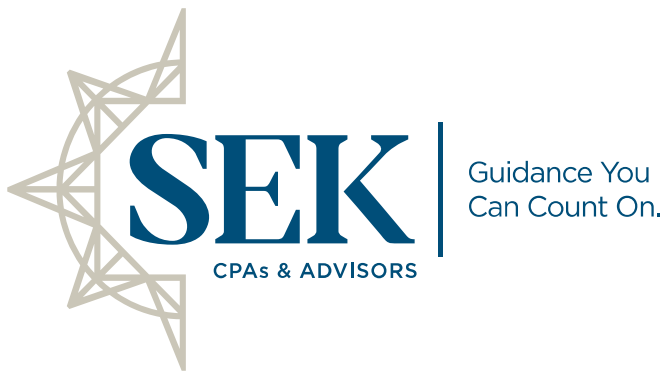

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Herbein + Company, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Herbein + Company, Inc. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Charles Schwab Trust Bank, a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

### NOTE 1 DESCRIPTION OF PLAN

---

The following description of the Herbein + Company, Inc. Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering employees of Herbein + Company, Inc. and its adopting employers (collectively the "Company" or "employer"). Adopting employers include Financial Outsourcing Solutions, LLC, Herbein HR Solutions, LLC, Herbein Talent Solutions, LLC (effective October 18, 2022), Herbein Financial Group, LLC (effective July 12, 2023), and Herbein Leadership Training, LLC (effective April 11, 2024). Employees of the Company who have one month of service and are age 21 or older are eligible to participate in the Plan. Employees classified as interns are excluded from the Plan. Also excluded from the Plan are any employees classified as part-time, temporary or seasonal whose original hire date was after October 1, 2016 and whose regularly scheduled service is less than 1,000 hours during an eligibility computation period. The Plan is subject to the provisions of ERISA. The Plan Trustees are responsible for oversight of the Plan. The Plan Trustees determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Company's Board of Directors.

Effective November 1, 2023 Herbein acquired Creese, Smith, Hune & Co, LLC, a Greater Pittsburgh certified public accounting firm. Employees who joined Herbein were credited with service earned with their previous Firm for eligibility and vesting purposes.

#### *Contributions*

Each year, participants may contribute a portion of their annual pretax and post tax (Roth) compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible pretax compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participant's deferral elections are increased each year by 1 percent beginning with the first payroll in July of each year until a participant reaches a withholding of 6 percent, unless the participant selects an alternative deferral election or elects not to defer into the Plan.

Company contributions consist of safe harbor non-elective and discretionary profit sharing contributions. For the year ended September 30, 2024, the Company made a safe harbor contribution in the amount of 3 percent of the participant's eligible compensation. The Company may make a profit sharing contribution to the Plan on an annual basis based upon the participant's eligible plan year compensation. Contributions are determined by the Plan sponsor. For the year ended September 30, 2024, the Company made a \$676,196 profit sharing contribution to the Plan. Contributions are subject to certain IRS limitations.

### NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and employer safe harbor contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are vested immediately in their contributions and employer safe harbor contributions, plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service, as follows:

#### *Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participant account balances of \$1,000 to \$5,000 (for distributions made after December 31, 2023 this limit increased to \$7,000, per plan amendment) that meet the provisions for a mandatory distribution will be directly rolled over into an individual retirement account with a qualified institution designated by the Plan in the participants name if the participant does not elect a distribution method. Participant account balances less than \$1,000 that meet the provisions for a mandatory distribution will automatically be paid to the participant in a cash distribution if the participant does not elect a distribution method. In addition, hardship and in-service distributions are permitted if certain criteria are met.

#### *Forfeited Accounts*

As of September 30, 2024 and 2023, forfeited nonvested accounts totaled \$0. These accounts are used to reduce future employer contributions or to defray administrative expenses of the Plan. In 2024, employer contributions were reduced by \$14,936 from forfeited nonvested accounts.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. The employer safe harbor and profit sharing contributions from the Company are recorded in the year in which participant compensation is earned.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to general recordkeeping are allocated to participant's accounts and the administration of benefit payments are charged directly to the participant's account, both are included in administrative expenses. Investment related expenses are included in investment income.

#### NOTE 3 FAIR VALUE MEASUREMENTS

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### ***Money Market Fund***

Valued at the carrying value, which equals fair value.

**NOTE 5 RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Direct fees paid by the Plan to Northeast Financial Group Inc., investment advisor, totaled \$85,615 for 2024. Direct fees paid by the Plan to Schwab Retirement Plan Services, third party administrator, totaled \$31,549 for 2024.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### NOTE 7 TAX STATUS

---

The Plan was amended and restated effective October 1, 2020 to adopt a defined contribution prototype non-standardized pre-approved profit sharing/money purchase/CODA Plan which received a favorable opinion letter from the Internal Revenue Service on September 21, 2020, stating that the Plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions, generally for a period of three years after the returns are filed; however, there are currently no audits for any tax periods in progress.

### NOTE 8 RISKS AND UNCERTAINTIES

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
