Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Spectrum Medical, Inc. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Significant Accounting Policies

Basis of accounting:

The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

Valuation of investments:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 7 below for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investment income:

Interest income is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Appreciation (depreciation) in the fair market value of investments includes currently realized gains and losses on the sale of assets as well as unrealized gains and losses resulting from yearly changes in market values of assets held in the portfolio.

Risks and uncertainties:

The Plan invests in registered investment companies and a common collective trust which invests in various securities including U.S. Government securities, corporate debt instruments, and corporate stocks, which in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with these securities, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect the amounts reported in the financial statements.

Note 1. Significant Accounting Policies (Continued)

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable, if any, from participants are recorded as distributions based upon the terms of the Plan agreement. No allowance for credit losses has been recorded as of September 30, 2024 and 2023.

Payment of benefits:

Benefit payments are recorded upon distribution.

Expenses:

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Date of Management's Review of Subsequent Events:

Subsequent events were evaluated through July 10, 2025, which is the date the financial statements were available to be issued.

Note 2. Plan Description

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan established in 1971 and was restated on October 16, 2017 and amended on December 18, 2017 to provide benefits to employees, as provided by the plan document. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan administration:

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Bank of America, N.A. serves as the trustee for the Plan (the "Trustee") and Merrill Lynch, Pierce, Fenner & Smith Incorporated provides administrative and recordkeeping services on behalf of the Plan. Investment fees, which may vary according to the individual investment funds selected, are paid out of the assets of the Plan and are included in net depreciation in fair value of investments. Participants should refer to the prospectus of the individual investment funds for further details on individual investment fees.

Note 2. Plan Description (Continued)

Contributions:

Each year, participants may contribute up to the maximum amount allowed by law of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Subject to the same limitations, participants may elect to defer all or a portion of any cash profit sharing to which they are entitled. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Company contributions are determined at the discretion of the Company's Board of Directors. Company discretionary contributions for the year ended September 30, 2024 were \$411,251.

The Company may make discretionary annual contributions as designated by the Company's Board of Directors. However, this amount cannot be greater than the amount allowable as a tax deduction under the IRC.

Investments held by the Plan on behalf of participants related to deferral, matching, and profit sharing contributions are nonparticipant-directed. In the nonparticipant-directed program, the Retirement Investment Committee, under the guidance of investment managers, directs the specific investments held by the Plan.

Participant accounts:

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company matching and profit sharing contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after 6 years of credited service.

Payment of benefits:

Distributions and withdrawals are payable upon retirement after attaining age 65, severance from employment, financial hardship, disability, or death. If a participant's account balance is equal to or less than \$1,000, the balance is distributed immediately in a lump-sum cash payment unless a direct rollover into an individual retirement account ("IRA") or other qualified benefit plan is requested. If the account balance is over \$1,000, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into an IRA or other qualified plan, or postpone payment to a later date and remain in the Plan as described in the Plan documents.

Note 2. Plan Description (Continued)

Forfeited Accounts:

At September 30, 2024, forfeited non-vested accounts totaled \$7,627. These accounts will be used to reduce future employer contributions.

Notes receivable from participants:

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 less their highest outstanding notes receivable balance under the Plan during the previous 12 months or 50% of their vested account balance. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate plus 1% which is commensurate with prevailing rates. Interest rates are updated on the day following the change in the published prime rate. Principal and interest are paid to the Plan ratably through payroll deductions. The notes receivable are to be repaid over a period not to exceed five years, unless the loan qualifies as a home loan, for which the term of repayment may not be greater than 15 years. A home loan is a loan used to acquire a dwelling unit which, within a reasonable time, the participant will use as a principal residence. Outstanding notes receivable at September 30, 2024 carried interest rates ranging from 5.00% - 9.50% and are currently expected to mature through 2029.

Note 3. Tax Status

The Plan adopted the trustee's volume submitter profit sharing plan document, which received a favorable opinion letter from the Internal Revenue Service, dated March 31, 2014, stating that it is qualified under the applicable requirements of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws.

Note 4. Funding Policy

Contributions are determined annually by the Company's Board of Directors.

The Employer may reimburse the Plan for any administrative expense incurred. Administrative expense reimbursements are not considered as Employer contributions.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements authoritative literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs, when applicable, were used only when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair values of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered actively traded. The Plan's interest in the common collective trust is valued based at the net asset value ("NAV"). The NAV is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Company believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.
