1. DESCRIPTION OF THE PLAN:

The following description of the Exco Technologies Limited U.S. Affiliates Deferred Profit-Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Exco, Inc. and Exco Extrusion Dies, Inc. (the Company and Plan Sponsor) who have six months of service and are age eighteen or older. Employees may enter the Plan after they have met all eligibility criteria. A participant, who is employed by the Company on the last day of the Plan year, is entitled to share in the allocation of Company contributions for a Plan year in which the participant is credited with at least 1,000 hours of service, except as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Profit-sharing contributions are entirely within the discretion of, and will be made only to the extent specifically authorized by the Plan Sponsor. The Plan Sponsor's contributions are allocated to eligible participants' accounts based on the participant's covered compensation (80%) and the participant's credited service (20%).

Each year, participants may contribute pre-tax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catchup contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds as options for participants, including equity funds, bond funds, retirement date funds and a money market fund. The Company contributes an amount equal to 8% of some participants' elective deferrals up to 6% of the participants' compensation. Matching amounts contributed by the employer are invested in the same portfolio investments. Contributions are subject to certain limitations. All contributions are subject to compliance with Internal Revenue Code regulations.

Effective January 1, 2024, the Plan was amended to allow Roth contributions.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions and related earnings thereon. Vesting in the Company's matching contributions, profit-sharing contributions and earnings thereon is based on years of continuous service. A participant is 100% vested in the Company's matching contributions after six years. A participant is 100% vested in the Company's profit-sharing contribution after 3 years.

Notes receivable from participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participants' accounts and bear interest between 4.25% and 9.50%. Principal and interest are paid ratably through weekly payroll deductions.

Payment of benefits

Upon termination of service due to death, disability, retirement or termination of employment where benefits are vested, the participant may elect to receive one of the standard forms of payment: a joint and survivor annuity, an annuity contract or a lump sum payment. Vested participants may make rollover contributions from their accounts.

Forfeitures

Forfeitures are used to reduce Employer contributions. At September 2024 and 2023, there were \$7,023 and \$7,876 of forfeitures of nonvested participant account balances, respectively, held in an account to be used in the future to offset contributions. Company contributions were reduced by \$5,270 and \$22,946 from forfeited nonvested accounts for the years ended September 30, 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' accounts become fully vested.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

The Plan has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the trustee, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of September 30, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of September 30, 2024 and the related investment activity and interest income on notes receivable from participants reflected in the statements of changes in net assets available for benefits for the years ended September 30, 2024 and 2023.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the organization has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets at fair value. There has been no change in the methodology used at September 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing prices as reported by the funds. The funds held by the Plan are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value and to transact that price. The funds held by the Plan are deemed to be actively traded.

5. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

Certain Plan investments are managed by Empower Trust Company, LLC, the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Professional fees for the administration and audit of the Plan were paid by the Company and are excluded from these financial statements. Investment fees paid by the Plan and participants to Empower Trust Company, LLC, totaled \$48,223 and \$51,016 for the years ended September 30, 2024 and 2023. These fees qualify as party in interest transactions.

6. INCOME TAX STATUS:

The Company adopted a pre-approved profit sharing plan which received a favorable opinion letter from the IRS dated November 14, 2022. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. DELINQUENT PARTICIPANT CONTRIBUTIONS:

For the year ended September 30, 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Delinquent Participant Contributions Disclosure under ERISA. Untimely remittances identified on the Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions, which totaled \$57,053, and lost earnings, which are required to compensate participants for the delay in these contributions, were identified and corrected by the Plan Sponsor during the current year.
