Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Children's Hope Alliance Tax-Deferred Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of September 30, 2024 and 2023 and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

- the information in the financial statements related to assets certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Children's Hope Alliance Tax-Deferred Annuity Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Children's Hope Alliance Tax-Deferred Annuity Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental Schedule H, Part IV, Line 4a – Schedule of Delinquent Participant Contributions and Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following description of the Children's Hope Alliance Tax-Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The original effective date of the Plan was October 1, 2014. The Plan is a 403(b) plan covering substantially all employees of Children's Hope Alliance, formerly known as Homes for Children (the "Organization" or "Employer"), except for employees who are eligible to participate in an eligible governmental plan under section 457(b) and non-resident aliens without U.S. source income. There is no age or service requirement for employee contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Additional special catch-up contributions may be made for participants with 15 years of service or more. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Organization contributes a safe harbor matching contribution equal to 100% of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation that a participant contributes to the Plan each pay period. Additionally, there is a discretionary contribution at year-end that is made to all employees who have 900 hours of service within the Plan year and are active at year end. The Organization made a 1% discretionary contribution for the year ended September 30, 2024. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Organization's contributions, if any, and plan earnings, and charged with administrative expenses in accordance with the service agreement. Allocations are based on participant deferrals, earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may direct the investment of their contributions into various investment options offered by the Plan. All contributions are invested with Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal Trust"). Participants may invest in an investment contract and mutual funds. Participants may also have balances with Mutual of America Life Insurance Company ("Mutual of America") and The Variable Annuity Life Insurance Company ("VALIC"), although no new contributions will be invested there. Through Mutual of America, participants may invest in an interest accumulation account and a pooled separate account. The interest accumulation account is a deposit administration contract. The pooled separate account contains several sub-accounts, which are registered separate accounts, corresponding to the name of its underlying fund, offering access to mutual funds, stocks, bonds, and money market instruments. Through VALIC, participants may be invested in investment contracts or registered separate accounts.

Vesting

Participants are immediately vested in their elective deferral and safe harbor matching contributions plus actual earnings thereon. Participants become vested in the organization's non-elective portion and the matching contributions made prior to October 1, 2018, based on years of continuous service. These contributions vest 25% after two years, 50% after 3 years and are 100% vested after 4 years of service.

Notes Receivable from Participants

Participants may borrow from their Principal Trust fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the rate of 4.25% to 9.5% during the 2024 plan year, which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest is paid ratably through bi-weekly payroll deductions.

Plan Loans

Participants who have accounts remaining at Mutual of America and VALIC may borrow directly from those entities. Adequate security is required, and a portion of the participant's account is reserved, or held in collateral, to cover 110% of the outstanding loan in case of default. The collateral is held in the respective investment contracts. The loan interest rate for these plan loans may be fixed or variable, and the initial rate is determined by the terms of the controlling contract as are the rate adjustment details and frequency. These plan loans are not considered assets of the Plan.

Payment of Benefits

Upon termination of service due to death, disability, retirement or separation from service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or other specified payment options as provided in the Plan. Participants who are age 59 ½ may elect to receive in-service withdrawals of their vested balances. All vested balances less than \$5,000 may be automatically distributed after termination of employment.

Forfeited Accounts

Forfeitures by non-vested participants may be used to reduce Employer contributions or Plan expenses. As of September 30, 2024 and 2023, the forfeiture balance was \$1,841 and \$1,595 respectively. Forfeitures amounting to \$1,273 and \$37 were used during the plan year ended September 30, 2024, to offset employer contributions and pay Plan expenses, respectively.

Administrative Expenses

Administrative expenses pertain to certain annual base recordkeeping and third party administration fees and participant requested services for distributions and loans. Additionally, there are investment fees which are netted against any investment income received from providers of the underlying investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for the fully benefit responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of the fair value measurements. See Note 6 for information on the investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of September 30, 2024. There were \$4,752 in loans that were deemed distributed during the plan year.

Payment of Benefits

Benefits are recorded when paid.

3. Unaudited Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America, Principal Trust, and VALIC have certified that the following data included in the accompanying financial statements are complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2- Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at September 30, 2024 and 2023.

Pooled Separate Account: The Mutual of America pooled separate account does not file as a direct filing entity, and therefore reports its underlying investments. The fair values of participation units held in the pooled separate account is based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each of the underlying separate accounts invests in a single, open-ended mutual fund which is generally identified in the name of the separate account. The investment strategies of these separate accounts are consistent with each of the mutual funds identified in the name of the fund. Each of the separate accounts provides for daily redemptions by the Plan with no advance requirements and has redemption prices that are determined by the fund's net asset value per unit.

Registered Investments: The plan holds mutual funds and registered separate accounts. Mutual funds are valued at their net asset value. The registered separate accounts are valued at their net asset value and adjusted for certain separate account charges.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Investment Contracts

The Plan holds fully benefit responsive investment contracts available through all of the contract holders associated with the Plan. Principal Trust has a fixed income guaranteed option, VALIC has deposit administration contracts, and Mutual of America has an interest accumulation account.

The contract holders related to the above contracts maintain the contributions in an unallocated fund, whose assets are invested with other assets in general accounts. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made under the Contract, plus earnings, less withdrawals and administrative expenses. There are no reserves against contract value for the credit risk of the Contract issuer or otherwise. The contract crediting rate is established on a quarterly basis and is based on a formula agreed upon with the issuer.

There are no events that limit the ability of the Plan to withdraw contract value or otherwise transact at contract value with the contract issuers. The contract holder or the Plan may terminate the contracts with 30 days’ advance written notice to either party. Upon such notice, the contract owner may choose immediate payment at contract value or purchase the paid-up annuity benefits within 30 days.

7. Parties-in-Interest and Related Party Transactions

Certain plan investments are investments managed by Mutual of America, Principal Trust, and VALIC. Maxus Plan Solutions, Inc. is the third party administrator. Plan transactions with these parties qualify as party-in-interest.

8. Non-Exempt Transactions

During the plan year ended September 30, 2024, employee withholdings amounting to \$1,378, were not remitted to the Plan within the appropriate time frame by the Company. This transaction constitutes prohibited transactions as defined by ERISA. The Company remitted these contributions to the Plan for the plan year and remitted the lost earnings in May 2025.

9. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

10. Tax Status

The Plan has received an opinion letter dated March 31, 2017, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator and the Plan’s management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

11. Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.


