Opinion

1. Description of Plan

The following description of the Blue Ridge Employees' Stock Ownership Plan (the "Plan"), provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

a. General

Blue Ridge Bancshares, Inc. (the "Company"), established the Plan effective as of January 1, 1994. The Plan operates as an employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations there under of the Internal Revenue Code of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by an Employee Benefits Administration Committee comprising of up to three persons appointed by the Company's Board of Directors.

All employees are eligible to participate in the ESOP after one year of service providing they worked at least 1,000 hours during such year. An employee is eligible to enter the Plan upon the first day of the plan year in which eligibility requirements are met.

b. Contributions

The Company may make an annual discretionary contribution to the Plan during the continuance of the Plan in an amount, if any, determined solely by the Company. Contribution allocations are based on a participant's eligible compensation, relative to total eligible compensation. Participants who are not employed on the last working day of a plan year are not eligible for an allocation of the Company's contributions for such year, except for participants terminated due to retirement, total and permanent disability, or death.

In addition, during 2024, the Company contributed 50 shares of common stock to the plan valued at the December 31, 2023 stock price for a total non-cash contribution of \$71,250. Cash contributions during the year ending December 31, 2024, were \$394,400.

c. Participant Accounts

Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock. Allocation of shares are based on a participant's other investment account, relative to the total other investment account at the year-end after all other allocations. Dividends and change in fair market value are allocated based upon the number of shares.

1. **Description of Plan (Continued)**

c. **Participant Accounts (Continued)**

Plan earnings on cash, interest, and fees are allocated to each participant's other investments account based on the ratio of the participant's adjusted beginning of the year other investments account balance to all participants' beginning of the year account balances. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

d. **Vesting**

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. A participant earns a year of service for vesting purposes if they have at least one hour of service during a plan year. A participant becomes 20% vested after two years of credited service and at the rate of 20% for each successive year of service thereafter. A participant is 100% vested after six years of credited service.

e. **Payment of Benefits**

No distributions from the Plan will be made until a participant retires, dies, or otherwise terminates employment with the Company except for diversification purposes as allowed by the Plan. Distributions are made in a lump-sum cash payment or, if a participant elects, in the form of Company common shares plus cash for any fractional share.

f. **Forfeitures**

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation for the Plan year. Forfeitures of terminated non-vested account balances allocated to remaining participants at December 31, 2024 and 2023, totaled \$5,404 and \$3,069, respectively.

g. **Voting Rights**

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is permitted to vote any allocated share for which instructions have not been given by a participant.

h. Put Options

If the employer stock that is held by the Plan and its participants is not readily tradable on an established market or is subject to trading limitations, it will have a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

i. Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period.

2. Summary of Significant Accounting Policies

The following are the significant policies followed by the Plan:

a. Basis of Accounting

The financial statements of the plan are prepared using the accrual method of accounting.

b. Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

The financial statements include Blue Ridge Bancshares, Inc. common stock totaling \$3,321,450, whose value has been estimated with the assistance of an independent valuation specialist in the absence of readily ascertainable market value. Because of the inherent subjectivity in any valuation, the estimated value may differ significantly from the value that would have been used had a ready market for the securities existed, and the difference could be material.

c. Investment Valuation and Income Recognition

Dividend income is accrued on the ex-dividend date.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method.

d. Income Taxes

The Plan's income tax filings are subject to examination by various taxing authorities. The Plan's open examination periods are 2021 and forward.

e. Subsequent Events

Subsequent events have been evaluated up to July 8, 2025, the date these financial statements were available to be issued.

4. Administration of Plan Assets

The Plan's assets, which consist principally of the Company common shares, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for certain fees are paid directly by the Company.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

5. **Fair Value Measurements (Continued)**

The fair value of Blue Ridge Bank's common stock held by the plan is valued at estimated fair value based upon an independent appraisal. This appraisal was based upon a combination of the asset and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, guideline public companies, and estimated fair value of company assets and liabilities.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. **Concentration of Investments**

Included in investments at December 31, 2024 and 2023, are shares of the sponsor's common stock amounting to \$3,321,450 and \$2,797,275, respectively. This investment represents 99.32% and 97.84% of total assets at December 31, 2024 and 2023, respectively. A significant decline in the market value of the sponsor's stock would significantly affect the net assets available for benefits.

7. **Tax Status**

The plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Company and the Plan administrator believe that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore believe that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. **Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Employee Benefits-Administration Committee shall direct the Trustee to pay all liabilities and expenses of the trust fund. In the event of Plan termination, participants will become 100% vested in their accounts.
