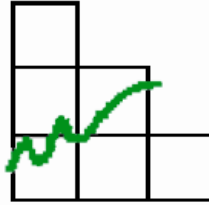

INDEPENDENT AUDITOR'S REPORT

To Board of Trustees of
the Community Resource Project, Inc. 403(b) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Community Resource Project, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Community Resource Project, Inc. 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Community Resource Project, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

- 1) *General:* The Plan is a defined contribution plan (403(b) plan) adopted January 1, 2009, covering all employees of Community Resources Project, Inc. (the Organization). Prior to January 1, 2009, there was no formal 403(b) plan in place. Employees made contributions to individual 403(b) plans. When the law changed as of December 31, 2008, the Organization adopted a formal 403(b) plan. Employees are eligible to participate in the Plan on hire date. As of September 30, 2022, the Plan was amended to provide that employees are eligible at one year of service and the age of 21 for nonelective employer contributions. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Board of Trustees oversees the governance of the Plan.
- 2) *Contributions:* Participants may contribute up to \$23,000 in 2024 (thereafter as adjusted by the Secretary of Treasury) as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, variable annuity funds and an insurance investment contract as investment options for participants. The Plan offers enrollment into Mainspring Managed services, which provides automatic 2% deferral increase on pre-tax contributions each year up to 10% and manages the participant's investment portfolio. The participant must enroll via the Standard website into Mainspring Managed. As of January 1, 2023, the Plan was amended to include an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 1% of eligible compensation. Contributions are automatically invested in a balanced fund until changed by the participant. As of September 30, 2022, the Plan was amended to provide that the Organization contributes, at its discretion, an amount equal to a percentage of base compensation.
- 3) *Participant Accounts:* Each participant's account is credited with the allocations of (a) the participant contributions and (b) the Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- 4) *Vesting:* Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

- 5) *Payment of Benefits:* On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
- 6) *Expenses:* Certain expenses of maintaining the Plan are paid by the Organization and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.
- 7) *Plan Termination:* Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, Participants would become 100% vested in their employer contributions.
- 8) *Note Receivable from Participants:* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 3% to 6%, which commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest is paid ratably through monthly payroll deductions.
- 9) *Forfeited Accounts:* As of September 30, 2024 and 2023, the forfeited nonvested accounts totaled \$-0-. In 2024, plan expenses were reduced by \$6,502 from forfeited nonvested accounts.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

- 1) *Basis of Accounting:* The financial statements of the Plan are prepared under the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.
- 2) *Investment Valuation and Income Recognition:* Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the

measurements date. See note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trades-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

- 3) *Use of Estimates*: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities. Actual results could differ from those estimates.
- 4) *Note Receivable from Participants*: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.
- 5) *Payment of Benefits*: Benefits are recorded when paid.
- 6) *Date of Management's Review*: Subsequent events were evaluated through June 27, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - RELATED PARTY TRANSACTIONS AND IDENTITY OF INTEREST TRANSACTIONS

Related Party: Management of the employer participates to the same extent as other employees.

Identity of Interest: Fees paid by the Plan for investment management service and recordkeeping were \$34,912 to Standard Retirement Services and \$160 to Empower Retirement, LLC for the year ended in September 30, 2024. The brokers of the Plan were paid \$19,472 for the year ended September 30, 2024. Fees due to the Plan at September 30, 2024 totaled \$5,412. The trustees of the Plan are Charles Schwab Trust Bank, Empower Annuity Insurance Company of America and Standard Life Insurance Company.

NOTE 6 - TAX STATUS

The Plan participates in a Volume Submitter Profit Sharing sponsored by Standard Retirement Services, Inc. This Plan was identified as acceptable by the IRS on March 31, 2014. Although the Plan has been amended since receiving the determination letter, the Plan administrator and plan's tax counsel believe the Plan is currently being designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7- CONCENTRATION OF CREDIT RISK ARISING FROM INVESTMENTS IN UNINSURED ACCOUNTS

The Plan's investments are currently all held with Charles Schwab Bank, Empower Annuity Insurance Company of America and Standard Life Insurance Company. These funds are uninsured and are not guaranteed. The value is based on current market value that varies daily. The availability of funds is based on the financial strength of the mutual funds and the insurance company. Uninsured balances total \$5,085,440 and \$3,876,541 at September 30, 2024 and 2023.

NOTE 8 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques

based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available, and Level 3 inputs were used when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented. And there were no changes in the methods used to measure fair value at September 30, 2024 and September 30, 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact that price. The mutual funds held by the Plan are considered to be actively traded.

Level 2 Fair Value Measurements

The fair value of variable annuities is based on observable inputs (assumptions obtained from independent services) for the asset or liability, either directly or indirectly.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or circumstances that caused the transfer. For the year ended September 30, 2024, there were no transfers of investments into or out of Level 3.

NOTE 9 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2009, the Plan entered into a benefit-responsive investment contract with Massachusetts Mutual Life Insurance Company which was acquired by Empower Annuity Insurance Company of America on February 18, 2022. In 2017, the Plan entered into a benefit-responsive investment contract with Standard Insurance Company. Standard Insurance Company and Empower Annuity Insurance Company of America maintain the contributions in a general account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Standard Insurance Company and Empower Annuity Insurance Company, represents contributions made under the contract, plus, earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at September 30, 2024 and 2023 was \$557,189 and \$433,453, respectively. The crediting interest rate is based on formula agreed upon with the issuer, but may not be less than 1% for Standard Insurance Company and 3% for Empower Annuity Insurance Company of America. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events might limit the Plan's ability to transact at contract value with Standard Insurance Company and Empower Annuity Insurance Company of America. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion or equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the

plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.


