

**SUMMARY ANNUAL REPORT FOR

This is a summary of the annual report Form 5500 Annual Return/Report of Small Employee Benefit Plan of Dickey & Campbell Law Firm P.L.C. Profit Sharing Plan and Employer Identification Number 68-0649557/Plan Number 001 for the plan year 01/01/2024 through 12/31/2024. The Form 5500-SF annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single employer, defined contribution plan with the following characteristics: employer contributions, profit sharing, code section 401(k) feature, ERISA section 404(c), total participant-directed account, pre-approved pension, covered by self-employed individuals, code section 401(m) arrangement, total or partial participant-directed account.

Basic Financial Statement

Plan expenses were \$10,579. These expenses included \$10,579 in administrative expenses and \$0 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 6 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$996,721 as of the end of the plan year, compared to \$806,728 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$189,993. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$200,572, including employer contributions of \$19,238, employee contributions of \$39,008, other contributions/other income of \$0 and earnings from investments of \$142,326.

Information Regarding Plan Assets

The U.S. Department of Labor's regulations require that an independent qualified public accountant audit the plan's financial statements unless certain conditions are met for the audit requirement to be waived. This plan met the audit waiver conditions for the plan year beginning 01/01/2024 and therefore has not had an audit performed.

The plan's assets were held in individual participant accounts with investments directed by participants and beneficiaries and with account statements from regulated financial institutions furnished to the participant or beneficiary at least annually and other qualifying assets.

- (2) Attach to this electronic filing, in addition to any other required schedules or attachments, a true and correct pdf copy of the first two pages of the completed Form 5500 or Form 5500-SF return/report bearing the manual signature of the plan administrator/employer under penalty of perjury;
- (3) Advise the plan administrator/employer that by selecting this electronic signature option the pdf image of that manual signature will be included with the rest of the return/report posted by the Department of Labor (DOL) on the Internet for public disclosure; and
- (4) Will communicate to the plan administrator/employer any inquiries and information that they receive from EFAST2, DOL, IRS or PBGC regarding this annual return/report.
