SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT

We have performed an audit of the financial statements of the Servpro Industries, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

OPINION

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Servpro Industries, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan. The Plan covers all eligible employees of Servpro Industries, LLC and all eligible employees of Restoration Risk Retention Group (collectively the “Employer”).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan Administrator is Servpro Industries, LLC and is responsible for oversight of the Plan.

Eligibility

Employees are eligible to participate in the Plan after completing three months of service. An employee may become a participant in the month coinciding with or following attainment of the eligibility requirements.

Contributions

Eligible employees may make pre-tax Elective Deferral Contributions and/or after-tax Roth Elective Deferral Contributions to the Plan through payroll deductions, not to exceed the contribution limits defined in the Internal Revenue Code. Pre-tax Elective Deferral Contributions are limited to 90% or less of participant’s compensation. The Plan provides for the Employer to make Discretionary Matching Contributions. For the year ended December 31, 2024, the Employer contributed an amount equal to 25% of participant’s Elective Deferral Contributions up to an elective deferral rate of 8% of any participant’s eligible wages. The Employer may also make Discretionary Profit-sharing Contributions to be allocated under a formula described in the Plan document. No Profit-sharing Contributions were made to the Plan in 2024. Employer Matching and Profit-sharing Contributions are allocated to the investment options as directed by the participants. Participants may also contribute Rollover Contributions, which represent distributions from other qualified defined benefit or defined contribution plans.

Participants’ Accounts

Each participant’s account is credited with the participant’s Elective Deferral and Rollover Contributions and allocations of the Employer’s Matching and Profit-sharing Contributions and Plan earnings. Participants’ accounts are reduced by any payments made from such accounts and the participant’s share of any Plan losses. Allocations are based on participant earnings or account balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Vesting and Forfeitures

Participants are immediately vested in their Elective Deferral Contributions and in the Employer's Matching and Profit-sharing Contributions plus actual earnings thereon. Accordingly, the Plan has no forfeited, nonvested balances.

Automatic Enrollment

The Plan includes automatic enrollment of eligible employees on the first entry date after the employee completes eligibility requirements. The Plan also includes an automatic deferral increase annually, unless the participant affirmatively elects otherwise, for all participants having automatic enrollment contributions withheld on their behalf.

Investment Options

Eligible participants may choose to invest all or a portion of their Elective Deferral, Discretionary Matching and Profit-sharing Contributions, Rollovers, and any earnings thereon into investments offered by Fidelity Management Trust Company.

Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts, a minimum of \$1,000, up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless used to purchase a primary residence, in which case the loan repayment period may not extend beyond 10 years from the date of the loan. Loans are secured by the balance in the participant's account and bear interest at a rate comparable to that charged by a commercial institution. Loan repayments are paid ratably through payroll deductions.

In-Service Withdrawals

In the event of financial hardship, participants may request a distribution from the Plan to the extent required to satisfy the immediate financial need of the participant. A description of the criteria to receive a hardship distribution is defined in the Plan's provisions. After age 59 1/2, a participant may withdraw all or any part of his or her vested account balance in accordance with the provisions of the Plan.

Payment of Benefits

On termination of service or upon death, disability, or retirement, a participant may receive a lump sum amount equal to the vested value of his or her account in accordance with the Plan's provisions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received upon sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments are recognized in the statement of changes in net assets available for benefits in the period paid. At December 31, 2024 and 2023, no amounts were payable to participants who had withdrawn from the Plan.

Administrative Expenses

Certain administrative expenses of the Plan are paid from Plan assets and allocated to participants. All other administrative expenses of the Plan are paid directly by Servpro Industries, LLC.

Events Occurring After Reporting Date

The Plan has evaluated events and transactions that occurred between December 31, 2024 and July 10, 2025, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market, but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investment in the collective trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

No changes in the methodologies used at December 31, 2024 and 2023, have occurred.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methods are appropriate and consistent with that of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The collective trust fund participates in a stable value fund that invests primarily in benefit-responsive investment contracts issued by insurance companies and other financial institutions (“Contracts”), fixed income securities, and money market funds. Under the terms of the Contracts, the assets of the fund are invested in fixed income securities (which may include, but are not limited to, U.S. Treasury and agency bonds, corporate bonds, mortgage-backed securities, commercial mortgage-backed securities, asset-backed securities, and collective investment vehicles and shares of investment companies that invest primarily in fixed income securities) and shares of money market funds. The fund may also invest in futures contracts, option contracts, and swap agreements.

Investments in this category may be redeemed on any business day, provided the exchange is not directed into a competing fund. Transferred amounts must be held in a noncompeting investment option for 90 days before transfers to a competing fund may occur. Withdrawals by the Employer are made one year after notification. The fair value of investments in this category has been estimated using the net asset value per share of the investments.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants are always 100% vested in their accounts.

NOTE 6 - TAX STATUS

The Plan has adopted a non-standardized pre-approved profit sharing plan (“Pre-Approved Plan”). The Pre-Approved Plan received its latest opinion letter on June 30, 2020, in which the IRS stated the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan has not applied for a separate determination letter.

NOTE 6 - TAX STATUS (CONTINUED)

The Plan Administrator and the Plan's tax counsel believe the Plan and Pre-Approved Plan are designed and have been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been provided in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

NOTE 7 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. The Plan's investments are held by Fidelity and qualify as party-in-interest transactions. The Plan also incurs expenses related to general administration and recordkeeping. These expenses and certain professional fees are paid by the Employer and the Plan. The Plan also allows for participant loans. All of these transactions are exempt from the prohibited transaction provisions of ERISA and the Internal Revenue Code.

NOTE 8 - CONCENTRATION OF CREDIT RISK

Fidelity Management Trust Company held 100% of the Plan's investments at December 31, 2024 and 2023. At December 31, 2024 and 2023, the Plan had a concentration in two funds, which represented approximately 24% and 22% of total investments, respectively.

The Plan utilizes various investment instruments as investment options. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, changes in the values of investment securities are reasonably possible in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.
