### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PAL Management, Inc. Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of PAL Management, Inc. Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **PAL Management, Inc. Employee Savings Plan Notes to Financial Statements**

### **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of PAL Management, Inc. Employee Savings Plan (the Plan) provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General and Eligibility**

The Plan is a defined contribution plan sponsored by PAL Management, Inc. (the Company). The Plan covers all employees working in covered employment, as defined in the Plan document, who have reached the age of 21, have completed one year (and 1,000 hours) of service, and are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established on December 9, 2010, and was most recently restated January 1, 2022.

#### **Contributions**

Participants may elect to defer and contribute a certain percentage of their compensation to the Plan in accordance with the provisions of section 401(k) of the Internal Revenue Code (the Code). The Plan has an automatic enrollment feature whereby employees will be automatically enrolled at 3% upon becoming eligible unless the employee makes a contrary election. This amount will increase effective on the first day of each Plan year by 1% until the amount withheld reaches 8% of the employee's compensation unless the employee elects to defer a different percentage. Participants may change the amount of their deferral effective on the first day of each Plan year quarter and may elect to cease making deferrals at any time.

The Company may also make elective discretionary contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company made elective discretionary contributions equal to 25% of the first 8% of eligible compensation that an eligible participant contributes to the Plan. No additional discretionary contributions were made for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's salary deferrals, the Company's contributions, if any, and Plan earnings or losses. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Investment Options**

The participant has the option of investing in a variety of investment choices, as more fully described in the Plan's literature. Each employee may make changes in the allocation of their individual account at any time during the year.

**NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)**

**Vesting**

Participants vest in Company contributions and earnings thereon at 20% after one year of service and at a rate of 20% per year thereafter until 100% vested after five years. Participants are always 100% vested in their deferral contributions and earnings thereon. Notwithstanding the foregoing, a participant is fully vested upon Plan termination, reaching normal retirement age, death or becoming permanently disabled while an employee.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000. The amount of the note cannot exceed 50% of their vested account balance. Note terms range from one to five years, or longer for the purchase of a primary residence. The notes are secured by the balance in the participant's account. Principal and interest are paid ratably through biweekly payroll deductions.

**Payment of Benefits**

An active participant may request withdrawal of benefits upon attaining the age of 59½. Hardship withdrawals are available if the participant has not reached age 59½ and are subject to restrictions. On termination of service, for whatever reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If an election for a rollover or a request for distribution is not received, and the account balance is less than \$5,000 but greater than \$1,000, the balance will automatically be rolled over to an individual retirement account (IRA). If the account balance is less than \$1,000, the balance will automatically be paid out in a single lump sum.

**Forfeited Accounts**

Forfeited nonvested accounts totaled approximately \$2,000 at December 31, 2024 and 2023. During 2024 and 2023, employer contributions were funded by approximately \$5,700 and \$3,200 respectively, from forfeited nonvested accounts.

**Subsequent Events**

The plan administrator has evaluated subsequent events through July 1, 2025, the date the financial statements were available to be issued.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors, custodians, and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Delinquent notes are treated as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplementary information, schedule of assets (held at end of year).

**Payment of Benefits**

Benefits are recorded when paid to participants.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included as an offset to net appreciation in fair value of investments.

**NOTE 3 - CERTIFICATIONS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the custodian and trustee of the Plan). Certain investments and related information for 2023 was also certified by Empower Annuity Insurance Company of America. Those assets were disposed of in 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. As of December 31, 2023, all investments held within the fair value hierarchy were mutual funds. As of December 31, 2024, the Plan held investments in mutual funds, as well as a common collective trust.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common collective trust:** Valued at the net asset value ("NAV") as a practical expedient to fair value based on the fair value of the underlying investments at year end.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS**

Certain Plan investments are shares of a group annuity contract managed by affiliates of Empower Annuity Insurance Company of America and Empower Trust Company, LLC the custodian and trustee of the Plan, as defined by the Plan. Therefore, these transactions and notes receivable from participants qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included as part of net appreciation (depreciation) in fair value of investments. Fees paid by the Plan for investment management services are included as a reduction of the return of each fund.

**NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has a traditional group annuity contract with Empower that invested contributions in the Key Guaranteed Portfolio Fund. During 2024, the Plan terminated their participation in this contract, and the related assets were liquidated and incurred no losses on redemption. The Key Guaranteed Portfolio Fund was a fixed annuity general account product and met the fully benefit-responsive investment contract criteria and, therefore, was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The group annuity contract held by the Plan was a guaranteed investment contract. The contract was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than 0%. The crediting rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Examples of such events included the following: (a) the Plan's failure to qualify under section 401(a) of the Code or the failure of the trust to be tax-exempt under section 501(a) of the Code, (b) premature termination of the contract, (c) Plan termination or merger, (d) change in the Plan's prohibition on competing investment options or (e) bankruptcy of the plan sponsor or other plan sponsor events that significantly affect the Plan's normal operations.

No events were probable of occurring that might have limited the ability of the Plan to transact at contract value with the contract issuers and that also would have limited the ability of the Plan to transact at contract value with the participants.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events included the following: (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misrepresentation or (d) a material amendment to the agreements without the consent of the issuer.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 9 - TAX STATUS**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more than likely would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
