### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of America II Corp. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors’ Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Notes to Financial Statements

December 31, 2024 and 2023

### (1) Description of the Plan

The following description of the America II Corp. Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions. The following employers: America II Electronics, LLC., America II Group, Inc. (Florida and Delaware), America II Belgium, Inc., Component Services & Logistics, Inc., 21st Century Electronics, LLC., and America II Japan, Inc. (collectively, the “Company”) sponsor the Plan. Effective January 1, 2023, the Company changed its name to America II Group LLC.

#### (a) General

The Plan is a defined contribution plan. The Plan covers all employees of the Company who have at least two months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Eligible employees are automatically enrolled in the Plan unless participation is declined. Effective January 1, 2023 the plan was amended for the default deferral rate to increase from 3% to 6% of eligible wages.

#### (b) Contributions

Each year a participant may contribute up to 100% of pre-tax annual compensation, as defined in the Plan subject to the limits set by the Internal Revenue Service (“IRS”). A participant may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In addition, participants who have attained the age of 50 years before the end of the plan year are eligible to make catch-up contributions. The Company’s contributions are discretionary at the option of the Company’s Board of Directors. For the year ended December 31, 2024, the Company contributed 50% of the first 6% of base compensation that a participant with one or more years of service contributed to the Plan. Additional amounts may be contributed at the option of the Company’s Board of Directors. For the year ended December 31, 2024, the Board of Directors elected not to make any additional contributions.

#### (c) Participant Accounts

Each participant’s account is credited with the participant’s contributions, allocations of the Company’s contributions and plan investment results, and is charged with an allocation of administrative expenses. Allocations are based on participant contributions, earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

#### (d) Forfeitures

Forfeited non-vested accounts are used to pay plan expenses or reduce future Company contributions. Total unallocated forfeitures, which may be used to pay plan expenses or reduce future Company contributions, were \$33,000 and \$10,000 at December 31, 2024 and 2023, respectively. No forfeitures were used to offset employer contributions during the year ended December 31, 2024.

#### (1) **Description of the Plan - Continued**

##### (e) **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Effective January 1, 2023, the plan was amended to change the vesting schedule from a 5 year grade to a 3 year cliff. A participant vests in Company contributions as follows:

Less than 1 Year	0%
1 Year	33%
2 Years	66%
3 Years or More	100%

##### (f) **Investment Options**

Upon enrollment in the Plan, a participant may direct employer and employee contributions in 5% increments in any of the investment options. A participant may change his or her investment options daily.

##### (g) **Notes Receivable from Participants**

A participant may borrow from his or her fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of his or her vested account balances. Loans bear interest at the prime rate plus 1%. The interest rates charged on participant loans ranged from 4.25% to 9.50% as of December 31, 2024. Loan terms range from one to five years or up to fifteen years for the purchase of a primary residence. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions, although prepayments are allowed in an amount equal to one or more of the next periodic payments or the current outstanding balance including accrued but unpaid interest.

##### (h) **Administrative Expenses**

All of the administrative expenses of the Plan may be paid by the Company or the Plan. During 2024, the Plan paid substantially all of the administrative expenses of the Plan.

##### (i) **Distribution of Benefits**

Distribution of a participant's account in an amount equal to the participant's vested interest in his or her own account may be made in a lump-sum distribution or annuity payments upon termination of service, death, disability, or retirement. Certain in-service withdrawals are allowed by the Plan, in accordance with the IRS limitations, for participants meeting minimum age requirements. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. If the vested account balance does not exceed \$5,000, the Plan will distribute that portion to the participant as soon as administratively feasible after termination of employment with the Company.

#### (1) Description of the Plan - Continued

##### (j) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

#### (2) Summary of Accounting Policies

##### (a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“US GAAP”).

##### (b) Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

##### (c) Payments of Benefits

Benefits are recognized when paid.

##### (d) Investment Valuation and Income Recognition

Investments in mutual funds are stated at fair value as determined by quoted market prices, which represents the net asset value (“NAV”) of shares held by the Plan at year end.

The Principal Stable Value Fund (the “Fund”) is a common/collective trust fund. The Fund invests principally in investment contracts, including traditional Guaranteed Investment Contracts (“GICs”) and security-based contracts issued by insurance companies and other financial institutions. The Fund is valued by Principal based on the unit value of the funds. This common/collective trust has underlying investments in investment contracts which are valued at estimated fair value of the underlying investments and then adjusted to contract value.

The Principal BlackRock S&P MidCap Index CIT, Principal BlackRock Russell 2000 Index CIT, Principal BlackRock S&P 500 Index CIT, and Principal BlackRock Large Cap Growth Index CIT (collectively, the “CIT Funds”) are common/collective trust funds. The CIT Funds invest principally in the equity securities of companies that compose the applicable index. The CIT Funds are valued by Principal based on the unit value of the funds.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The net appreciation in fair value of investments includes both realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of the year.

#### (2) Summary of Accounting Policies - Continued

##### (e) Unit Values

Individual participant accounts for the pooled separate account are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but do have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

##### (f) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

##### (g) Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### (h) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

#### (3) Trustee Certifications of Plan Investments

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.1.3-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, the trustee of the Plan, has certified that the following data included in the financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments, at fair value
- Guaranteed interest account, at contract value
- Notes receivable from participants
- Interest and dividend income
- Interest income from notes receivable from participants
- Net appreciation in fair value of investments
- Schedule of Assets (Held at End of Year)

#### (3) Trustee Certifications of Plan Investments - Continued

The Plan's independent auditors' did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### (4) Fair Value Measurements

Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, issued by the Financial Accounting Standards Board ("FASB"), provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this guidance are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If an asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds* are valued at NAV of shares held by the Plan at year end.

*Pooled Separate Account* is a public investment vehicle valued using the Net Asset Value ("NAV") provided by Principal. The NAV is based on the value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The NAV is classified within Level 2 of the valuation hierarchy because the NAV's unit price is quoted on a private market that is not active, however, the unit price is based on the valuation of the underlying investments which are traded on an active market.

**(4) Fair Value Measurements - Continued**

*Common Collective Trusts* are valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. The collective trust funds do not have a finite life, unfunded commitments relating to these types of investments, or significant restrictions on redemptions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (5) **Guaranteed Interest Account**

Effective February 20, 2024, the Plan provided the Principal Fixed Income Guaranteed Option (“GIA”), a guaranteed general account backed group annuity contract that has been issued by Principal Life Insurance Company (Principal Life) to Principal Trust Company as custodian, as an investment option to participants of the Plan. The GIA is intended to provide a stable crediting rate consistent with preservation of principal. Interest is accrued daily and credited monthly to the GIA and reflects the crediting rate declared in advance and guaranteed by Principal Life. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this guaranteed investment contract.

The key factors that impact the crediting rate under the group annuity contract are the timing and magnitude of the cash flows in and out of the general account as well as prevailing market rates on fixed income assets available for investment by the general account. The interest crediting rate may not be reset more frequently than semi-annually after the first contract year. The crediting rate is subject to a minimum rate provision as provided in the group annuity contract, but may never fall below 1% after deduction for any expenses. Participant-initiated transactions are permitted on a daily basis.

The group annuity contract provides that, subject to certain limitations, withdrawals for benefit payments at death, retirement, disability, termination of employment, and for loans, hardship withdrawals or in-service withdrawals as permitted by the Plan are completed at contract value and without any surrender charge. Certain distributions, including but not limited to distributions resulting from employer-initiated events such as plan termination, merger, spin-off, and early retirement incentives may be completed subject to a market value adjustment, however, the plan administrator deems these employer-initiated events are not probable to occur.

The group annuity contract may be terminated by the contract holder at any time, provided written notice of terminations is received by Principal at least 30 days in advance, and will be subject to a surrender charge.

#### (6) **Income Tax Status**

The Plan has adopted a pre-approved plan under Principal Life Insurance Company. The pre-approved plan obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The pre-approved plan has been amended since receiving the opinion letter. However, the plan administrator believes that the pre-approved plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) **Party-in-Interest**

Certain plan investments were managed by Principal Trust Company. Principal Trust Company is the Trustee as defined by the Plan, and therefore, transactions between the Plan and Principal qualify as party-in-interest transactions. The Plan had approximately \$63,000 in expenses paid to Principal during 2024.

Participant loans are considered party-in-interest transactions, as defined in Section 3(14) of ERISA, because they are transacted with plan participants. These transactions qualify as party-in-interest transactions, as defined in Section 3(14) of ERISA; they are, however, expressly exempted from the prohibited transaction rules.

(8) **Subsequent Events**

In accordance with ASC Topic 855, *Subsequent Events*, plan management has evaluated events occurring through July 8, 2025, the date financial statements were available to be issued, to determine if these events were significant to the financial statements.
