### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of PathStone Corporation Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 30, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

### **Basis for Opinion on the 2024 Financial Statements**

### **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about PathStone Corporation Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1. Description of the Plan**

The following description of the PathStone Corporation Retirement Plan ("the Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of PathStone Corporation and Affiliates (the "Company"), except those residing in the Commonwealth of Puerto Rico. An employee is eligible for company contributions at the date of hire with no age or service requirements. Effective September 1, 2022, the Plan initiated automatic enrollment for eligible participants equal to 3% of employee's compensation and will increase by 1% of compensation up to a maximum of 6% of compensation. Participants who are eligible to make salary deferrals to the Plan are eligible for safe harbor contributions. Safe harbor contributions equal to 100% of salary deferrals that do not exceed 3% of compensation. An employee is eligible for company contributions on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions**

Participants may make pre-tax or post-tax contributions from their annual compensation, up to amounts permissible under ERISA and the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Eligible participants may defer up to 100% of their annual compensation, as defined in the Plan, as a qualified contribution subject to maximum annual dollar contribution restrictions of ERISA and the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings (losses) and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined, and forfeitures of terminated participant's nonvested accounts. The benefit to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

For employee contributions, the Plan provides participants with a number of investment options. All funds are managed by the administrator, ADP, Inc. ("ADP"). Each participant elects which funds his or her interest in the Plan will be invested. If no election is made, funds are invested in money market accounts.

**Vesting**

A participant is 100% vested in Company contributions upon completion of three years of credited service, at the age of 62, or in the event of total and permanent disability or death. Service is calculated using all years of service except years prior to age 18. Employees are vested immediately in their contributions plus actual earnings thereon. Participants are immediately vested in their contributions, plus actual earnings thereon, and all safe harbor contributions.

**Note 1. Description of the Plan (Continued)**

**Payment of Benefits**

Benefits are payable as soon as practical after the participant separates from service. On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum amount, as a qualified joint or survivor annuity, or in substantially equal installments over their assumed life expectancy. Partial withdrawals or installments are only permitted for required minimum distributions.

**Forfeitures**

Unvested amounts that have been forfeited are added to, or reduce the Company's discretionary contribution and are allocated to other eligible participants in the same manner as employer contributions. At September 30, 2024 and 2023, forfeited non-vested accounts totaled \$1,944 and \$8,667, respectively. In 2024, employer contributions were reduced by \$1,259 from forfeited nonvested accounts.

**Administration**

The Plan is administered by the Company. For the 401(k), record-keeping is maintained by ADP. The plan administrator makes its employees aware that they are eligible to participate in the Plan and distributes materials, the Summary Plan Description and enrollment packet. ADP assists employees with investment selection and distributions. Reliance Trust Company is the custodian of the funds.

**Note 2. Summary of Significant Accounting Policies**

**Method of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting.

**Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investments Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes Plan gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

Management has evaluated subsequent events through July 11, 2025, which is the date the financial statements were available to be issued.

**Note 3. Information Prepared and Certified by Trustee (Unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at September 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

**Note 4. Fair Value Measurements**

ASC 820-10 establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

**Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

**Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

**Level 3:** Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

**Note 4. Fair Value Measurements (Continued)**

The following is a description of the valuation methodologies used for assets measured at fair value:

**Registered Investment Companies** - Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

**Common Collective Trust** - Valued at the net asset value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. All investments are valued as level 1.

**Note 5. Net Asset Value (NAV) Per Share (Continued)**

(b) Strategies seek to invest in a variety of investment contracts offered by major insurance companies and other approved financial institutions and in certain types of fixed income securities.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

**Note 7. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8. Tax Status**

The Plan adopted a standardized form of a volume submitter plan sponsored by Automatic Data Processing (ADP). The prototype plan has received an opinion letter, dated October 6, 2020, from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions and the Department of Labor; however, there are currently no audits for any tax periods in progress.

**Note 9. Party-In-Interest Transactions**

Certain employees of the Company provide administrative services to the Plan, and are not reimbursed for their services from the Plan. Certain plan investments are managed by Reliance Trust Company, and therefore these transactions qualify as party-in-interest transactions.
