NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Taylor Metalworks, Inc. Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Plan sponsor, Taylor Metalworks, Inc., who have completed six months of service and are age 18 or older. At December 31, 2024 and 2023, the net assets of the Plan are maintained in investment funds held by Voya Retirement Insurance and Annuity Company (Voya). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is designed to conform to the provisions of Internal Revenue Code Section 401(k).

Contributions

Participants may elect to contribute up to 100% of their annual compensation, subject to certain limitations under Section 401(k) and 415 of the Internal Revenue Code (\$23,000 in 2024 and \$22,500 in 2023). Participants who have attained age 50 before the end of the plan year are eligible to make additional catch-up contributions (\$7,500 in 2024 and 2023). Each plan year, the employer will have the opportunity to make a discretionary matching contribution, which is allocated based on a percentage of each participant’s elective deferrals for that plan year, as defined. Discretionary contributions of \$130,000 and \$155,000 were made for the years ending December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant’s account is credited with the participant’s contribution; Taylor Metalworks, Inc.’s matching contribution; an allocation of Plan earnings/(losses), based on the participants chosen investment allocation; administrative expenses; and forfeitures of terminated participants’ non-vested accounts. Allocations are based on participant account balances or compensation, as defined by the Plan agreement.

Plan Administration

The Plan is administered by Taylor Metalworks, Inc. Participant account records are maintained by the Plan’s third-party administrator, Rimkus Marciano & Associates, Inc. (“RMA”). All Plan non-investment administrative expenses are being absorbed by the sponsor, Taylor Metalworks, Inc.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings/(losses) thereon. Vesting in the remainder of their account is based on years of continuous service. The Plan provides that after two years of credited service, the participant is 20% vested. Thereafter, an additional 20% is vested in each of the next four years so that a participant is 100% vested after six years of credited service.

Payment of Benefits

A participant will be eligible for payment of benefits upon attaining normal retirement age (65) or death, prior to termination or severance date. On termination of service, a participant will receive a lump sum amount equal to the vested value of his or her account.

1. DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Under the Plan, participants may borrow from their accounts up to 50% of the participant's vested account balance and not greater than \$50,000. Terms of the loans generally call for principal and interest payments over a term of no more than 60 months. The loans are collateralized by the balance in the participant's account and bear interest at a rate as determined by the plan administrator. The repayment of the loan is handled through payroll deductions.

Forfeitures

Forfeitures of terminated participants' non-vested accounts may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. In some cases, however, forfeitures will be reallocated to participants as though they are additional employer contributions. Unallocated forfeitures were \$5,093 and \$5,005 for the years ended December 31, 2024 and 2023, respectively.

Hardship Withdrawals

The plan does not allow participants to withdraw any part of his or her vested account as a hardship withdrawal.

Plan Termination

Although it has not expressed any intent to do so, Taylor Metalworks, Inc. has the right, under the Plan, to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants will become 100% vested in their accounts, and participant account balances will be paid out in a single lump sum.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's policy is to prepare its financial statements in accordance with the accrual basis of accounting in conformity with accounting principals generally accepted in the United States of America.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under terms of the Plan. The Plan invests in an investment contract measured at contract value through a stability of principal fund.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investments

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between knowledgeable unrelated parties at the measurement date. See Note 3 for discussion of fair value measurements.

2. SIGNIFICANT ACCOUNTING POLICIES (Continued)

Security Transactions and Investment Income

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments includes realized gains and losses and unrealized gains and losses attributable to the investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all Participants in the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan agreement. No delinquent notes receivable have been recorded as of December 31, 2024 and 2023.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Income Taxes

The Internal Revenue Service has determined and informed the Plan by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving its most recent determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

3. FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establishes a fair value hierarchy that prioritizes the valuation assumptions used to measure fair value. This hierarchy consists of three broad levels: **Level 1** - assumptions rely on unadjusted quoted prices in active markets for identical assets and must be used when available, **Level 2** - assumptions rely on quoted prices for similar, but not identical, assets, and **Level 3** - assumptions generally are developed by the reporting entity, and may only be utilized when Level 1 and Level 2 information is not available. The Plan uses appropriate valuation techniques on the available information to measure the fair value of its investment assets.

3. FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodology used for assets measured at fair value:

Level 2 - Fair Value Measurements – The pooled separate accounts invest mainly in mutual funds. The fair value of the pooled separate accounts is based on quoted market prices for the underlying assets owned by the pooled separate accounts. The pooled separate accounts invest in a variety of designated mutual funds. The investment objective of these funds is aligned with the underlying investment of the fund. There are no unfunded commitments or withdrawal restrictions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. STABILITY OF PRINCIPAL FUND

The Plan allows participants to direct their contributions into an investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the fully benefit-responsive investment contract.

4. STABILITY OF PRINCIPAL FUND (Continued)

Certain events limit the Plan's ability to transact at contract value with Voya. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of Taylor Metalworks, Inc. or other Taylor Metalworks, Inc. events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

5. FINANCIAL CERTIFICATION

The following information relating to the Plan's assets at December 31, 2024 and 2023, as well as investment income (loss) and investment transactions for the years then ended, has been derived from information provided by Voya Retirement Insurance and Annuity Company, the custodian of the Plan, and that has been certified as complete and accurate:
