Basis for Opinion

1. DESCRIPTION OF PLAN

The following description of the Folk Oil Company, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a multi-employer, defined contribution plan covering employees of Folk Oil Company, Inc., Convenience King Group, Inc., Toledo 76, Inc., and 115 Truck Stop, Inc. (collectively, the "Company"). The Plan covers employees who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Trustees are responsible for the oversight of the Plan, determine the appropriateness of the Plan's investments, and monitor investment performance.

Contributions

Each year, participants may contribute to the Plan at their discretion up to 100% of their annual pre-tax wages not to exceed \$23,000 and \$22,500 for the years ending September 30, 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified plans and certain IRA'S (rollover contributions). Participants may elect to direct the investment of their contributions into various investment options offered by the Plan. Additional matching contributions may be declared at the option of the Company. For the Plan years ended September 30, 2024 and 2023, a match was declared at 50% of the first 6% of base compensation that a participant contributes to the Plan. Profit sharing contributions may also be made at the option of the Company. For the Plan years ended September 30, 2023 and 2022, the Company did not elect to make a profit sharing contribution to the Plan. Contributions are subject to certain statutory limitations.

Catch-Up Contributions

A participant age 50 or older may elect to defer additional amounts (called "catch-up contributions") to the plan. The additional amounts may be deferred regardless of any other limitations on the amount that a participant may defer to the plan. The maximum "catch-up contribution" that a participant can make is subject to Internal Revenue Service limitations, which was \$7,500 September 30, 2024 and 2023, respectively. Any "catch-up contributions" that a participant makes will not be taken into account in determining any Employer matching contribution made to the Plan.

Vesting

Participants are immediately vested in their voluntary contributions, including rollover contributions, plus actual earnings on the contributions. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Participant Accounts

Each participant's account is credited with the participant's contribution, including any rollover contribution, and an allocation of (a) the Company's contribution, (b) Plan earnings (losses), and (c) forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to disability, retirement, or any other reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In the event of death, a participant may elect to be paid out no later than five years following the date of death. Withdrawals from participant's salary deferral and vested employer contribution accounts may also be made in the event of financial hardship, in accordance with provisions specified in the Plan. Prior to termination of employment, participants who have attained the age of 59-1/2 are eligible to make in-service withdrawals, in accordance with provisions of the Plan.

Forfeited Accounts

At September 30, 2024 and 2023 forfeited nonvested accounts totaled \$17 and \$6,174, respectively. These accounts have been used to reduce future company contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

The Plan has evaluated subsequent events through June 25, 2025, the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses incurred in connection with investment advice, trust fees, and general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses.

3. INVESTMENT INFORMATION CERTIFIED BY PLAN TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at September 30, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and dividends for the year then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Capital Bank and Trust Company, the trustee of the Plan.

4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The following table sets forth, by level within the fair value hierarchy, the Plan's investments at fair value as of September 30, 2024 and 2023.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended September 30, 2024 and 2023, there were no significant transfers between Level 1 and 2 and no transfers into or out of Level 3.

5. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated November 27, 2001, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Uncertain Tax Positions

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

7. PARTICIPANT-DIRECTED INVESTMENTS

The investments in all participant accounts are self-directed by the participants.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
