NOTE A - GENERAL DESCRIPTION OF THE PLAN

Plan Summary

The following brief description of the CP&Y, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for complete information.

CP&Y, Inc. (“the Company”) established the CP&Y, Inc., Employee Stock Ownership Plan (Plan) effective October 1, 2001. As of September 30, 2024 the Plan operates as a non-leveraged employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by employees appointed by the Company. Three senior members of the Board of Directors served as the Plan’s Trustees until August 2021 and currently Christopher Robinson, a third-party independent trustee is serving as the Plan’s Trustee.

The financial statements of the Plan as of September 30, 2024 and 2023 and for the year ended September 30, 2024 present separately the assets and liabilities and changes therein.

On September 30, 2021, the Company was acquired by STV, Incorporated. Effective September 30, 2021 the Company adopted a Plan Termination Amendment to provide termination of the Plan and will be considered a frozen plan. The ESOP will remain in existence until all amounts are released and been paid to the participants and the Plan will no longer invest in qualifying employer securities. In accordance with the Plan document all participants shall be 100% vested as of the termination date. The Plan will make a partial distribution to each participant in the amount of 75% of the balance as of the Termination Date and will pay the final distribution to each participant after receipt of the favorable determination letter from the Internal Revenue Service.

Participant Accounts

The Plan is a discretionary contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited with an allocation of shares of the Company’s common stock released by the Trustee and forfeitures of terminated participants’ non vested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year receive an allocation. Allocations are based on a participant’s eligible compensation, relative to total eligible compensation.

Eligibility

Employees of the Company are eligible to participate in the Plan after completing 90 days of employment. As of the termination date the Plan became frozen and no new employees were eligible.

Vesting

The Plan uses the elapsed time method for vesting purposes. Based on their employment date, participants become 25% vested after two years of service, 50% vested after three years of service, 75% vested after four years of service and 100% vested after five years of service. In accordance with the Plan Termination Agreement all participants become 100% vested as of the termination date.

Distributions

On retirement or other termination of service, a participant receives a distribution in the amount of the participant's vested account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account.

Risks and uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of any forfeited shares of terminated participant's nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total compensation.

Participant Accounts and Forfeitures

Employer contributions and plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the plan year. Forfeitures of terminated nonvested cash account balances allocated to remaining participants at September 30, 2024 and 2023 totaled \$-0- and \$-0-, respectively. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participant's beginning of the year account balances.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICES

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis of accounting.

Cash and cash equivalents

The cash and cash equivalents are stated at fair market value.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reported period. Actual results could differ from these estimates.

Plan Termination

The Board of Directors of CP&Y, Inc. the Plan's Sponsor, voted on September 24, 2021 to terminate the plan effective September 30, 2021. The Plan assets will be paid to the Plan participants. In accordance with generally accepted accounting principles, the Plan changed its basis of accounting used to value plan assets from the going concern basis to the liquidation basis for periods after September 30, 2020.

Investment Valuation and Income Recognition

Investments of mutual funds and equities are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

Operating Expenses

All expenses of maintaining the Plan are paid by the Company, unless paid by the Trust.

Benefit Payments

Benefit are recorded when paid.

NOTE C – PAYMENT OF BENEFITS

No distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. In accordance with the Termination Agreement and Plan Amendment the Trustee shall distribute to the participants 75% of the value of their account balance in a single lump sum. This amount was paid out during the year ended September 30, 2022. The remaining payment of benefits was paid to each participant upon the Plan receiving a favorable determination letter which was received during 2023 and was paid during the year ended September 30, 2024.

NOTE D - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated January 18, 2023, that the Plan is qualified, and the trust established under the Plan is tax-exempt, under the appropriate sections of the IRC. The Plan is being terminated as of September 30, 2021 and the termination of the plan doesn't affect its qualifications per the letter.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

NOTE E- FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods use to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in different fair value at the reporting date.

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair values. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements), Level 2 inputs consist of observable inputs other than quotes prices for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3 measurements). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of the investments. When available, the plan measures fair value using the Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no Level 3 assets held.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: The fair values of mutual funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE F - SEPARATED PARTICIPANTS

At September 30, 2024, approximately \$-0- of plan assets were allocated to the accounts of persons no longer employed by the Company but have deferred vested benefits remaining in the Plan.

NOTE G – ADMINISTRATION OF PLAN ASSETS

Company contributions are held and managed by the Trustee, which invests cash received, interest and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee’s fees are paid directly by the Company, unless paid by the Trust.

NOTE H – OTHER INCOME

In accordance with the Stock Purchase Agreement dated September 30, 2021 STV, Incorporated was to release funds held in an escrow account. As a result of this \$138,389 was paid to the Plan. In addition, the Plan received \$938,493 of Shareholder Representative Funds. These amount are recorded as other income in the accompanying statement of changes of net assets available for benefits for the year ended September 30, 2024.

NOTE I – SUBSEQUENT EVENTS

The plan has evaluated subsequent events through June 20, 2025, the date the financial statements were available to be issued.
