## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
LeMans Corporation 401(k) Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of LeMans Corporation 401(k) Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits do not affect management's responsibility for the financial statements.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

### **ERISA-Required Supplementary Information**

The schedule of assets (held at end of year) as of September 30, 2024 and schedule of delinquent participant contributions for the year ended September 30, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of accounting** - The LeMans Corporation 401(k) Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to September 30, 2024 through June 18, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Key parties of the plan** - LeMans Corporation is the plan sponsor, employer and the plan administrator. Empower Trust Company, LLC is the trustee that holds custody of the plan's mutual funds. Empower Annuity Insurance Company of America held custody of the plan's guaranteed investment contract. Empower Retirement, LLC is the third party administrator which maintains investment and participant records, performs various compliance tests as tax counsel and is the brand name which refers to the products and services provided by both Empower entities discussed above, collectively referred to as "Empower". Robert W. Baird & Co. Incorporated is the plan's investment advisor.

**Investments** - The plan administrator determines the investments available to plan participants. The participants allocate the contributions and transfer existing balances among the available investment options. Participants should refer to the prospectuses and annual reports of the investments for more information. Earnings, including the net appreciation (depreciation) of investments bought, sold and held during the years, are reflected in the accompanying statements of changes in net assets available for benefits.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

**Mutual funds** - Valued at the daily quoted market prices as reported by the fund. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

**Investment at contract value** - The plan invested in the Key Guaranteed Portfolio Fund, a general account product of Empower. The investment was a fully benefit-responsive guaranteed portfolio investment through a group fixed annuity contract issued by Empower. As a general account product, participants' principal and interest amounts were fully guaranteed by the general assets of Empower. The methodology for calculating the interest crediting rate was based on the prevailing market conditions and earnings of medium-long term investments compared to a minimum interest crediting rate, as stated in the plan's contract with Empower. The interest crediting rate was reset quarterly.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because that was the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal of all or a portion of the investment at contract value.

## 2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

**General** - The plan was established on October 1, 1988, as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - Employees are eligible once they have completed one year of service (defined as 1,000 hours of service in the eligibility contribution period) and have reached age twenty-one. An employee can enter the plan on October 1 or April 1 after meeting the eligibility requirements. Effective July 1, 2024, the service requirement was eliminated and the entry date was changed to immediately upon meeting the eligibility requirements. At that time, employees are also eligible to receive employer matching contributions as long as they are employed on the last day of the year in which the contribution relates. For purposes of profit sharing contributions, an employee must have completed 1,000 hours of service in that plan year and must be employed on the last day of the year in which the contribution relates.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. New participants are automatically enrolled in the plan and have 2% of compensation withheld as deferral contributions. Participant deferral percentages automatically increase by 1% each year thereafter until they reach a maximum of 5%. Such participants have the option to increase, decrease, or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer matching contributions may be made at the employer's discretion. For the years ended September 30, 2024 and 2023, the employer contributed 60% of the first \$1,000 that a participant contributed to the plan plus 25% of participant contributions in excess of \$1,000 up to 5% of the participant's plan compensation. Total employer matching contributions, funded annually subsequent to year-end, were \$791,000 and \$715,000 in 2024 and 2023.
- d. Employer profit sharing contributions may be made at the employer's discretion. Such contributions are allocated to participants in the ratio that each participant's compensation bears to the compensation of all eligible participants. Total profit sharing contributions, funded annually subsequent to year-end, were \$1,800,000 in 2024 and 2023.

**Participant accounts** - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions and rollover contributions and an allocation of employer contributions. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

**Vesting** - Participants are always 100% vested in their elective deferral contributions, rollover contributions and related earnings. Participants begin vesting in employer contributions and related earnings upon two full years of service, at which time they are 20% vested. The participant then vests at a rate of 20% for each year thereafter. Upon death, disability or attainment of normal retirement age while employed, participants become 100% vested.

**Payment of benefits** - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Participants may elect their distribution to be in the form of a single lump sum or installment payments. In-service withdrawals can commence upon attaining the age of 59½. In addition, hardship withdrawals are also permitted under certain circumstances.

**Administrative expenses** - Certain administrative expenses of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and are recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distributions and non-participant directed fees for advisory, service and administrative services. Non-participant directed fees are allocated to participants on an account value basis.

**Forfeitures** - Forfeitures of nonvested account balances are reallocated as nonelective contributions on an annual basis to participants eligible to receive employer contributions. Such reallocations are allocated to participants in the ratio that each participant's compensation bears to the compensation of all eligible participants. Forfeited non-vested accounts reallocated to participant accounts were \$58,000 and \$83,000 in 2024 and 2023. Unapplied forfeitures were \$109,000 and \$58,000 as of September 30, 2024 and 2023.

**Notes receivable from participants** - Loans to participants are not permitted under the plan.

### 3. PARTY-IN-INTEREST TRANSACTIONS

The plan's investments are managed by Empower. Empower is the investment agent as defined by the plan, and therefore, these transactions qualify as party-in-interest transactions. In addition, Empower receives indirect compensation from the plan's mutual fund investment providers for services Empower provides to the funds. Certain revenues received by Empower from such service providers are remitted to the plan in the form of service credits (as part of an administrative services agreement between the plan sponsor and Empower). Such service credits received by the plan are used by the plan to pay advisory services and other plan fees. If the revenue received from Empower exceeds the amount owed under the services agreement, Empower remits the excess to the plan. The excess revenue received by the plan is recorded as other income in the accompanying statements of changes in net assets available for benefits. There are also certain other plan expenses that Empower charges that are paid directly. Direct fees paid by the plan to Empower, recorded as a component of administrative expenses in the accompanying financial statements, were \$88,000 and \$68,000 in 2024 and 2023.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

### 5. INCOME TAX STATUS

The plan adopted a Great-West Trust Company, LLC pre-approved profit sharing plan. The pre-approved profit sharing plan received its most recent favorable opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. As a result, the plan administrator has not obtained a separate Internal Revenue Service opinion letter for the plan. The plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of September 30, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

### 6. INFORMATION CERTIFIED BY EMPOWER

Management has obtained certifications from Empower, qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values and contract values of such as of September 30, 2024 and 2023;
- b. Dividends from investments and the net appreciation (depreciation) of investments during 2024 and 2023;
- c. Contributions to and withdrawals from accounts, and purchases, sales and inter-fund transfers of investments during 2024 and 2023; and
- d. The report of individual participant accounts as of and for the years ended September 30, 2024 and 2023.

### **7. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS**

During 2024, the plan sponsor remitted certain employee elective deferral contributions later than required by Department of Labor Regulation 2510.3-102. The plan sponsor will calculate and remit lost earnings related to the late contributions in 2025 to account for the investment income that would have been earned had the contributions been remitted on a timely basis. In addition, the plan sponsor will file the Internal Revenue Service Form 5330 and pay the associated excise tax.
