### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Quarles & Brady LLP Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of September 30, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

## 1. Description of Plan

The following description of the Quarles & Brady LLP Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established by Quarles & Brady LLP (the Firm) effective October 1, 1983, as restated October 1, 2017. Individuals may make salary deferral contributions to the Plan upon employment with the Firm and are referred to as "early participants." Individuals who are classified as seasonal or limited term employees do not participate in the Plan until they have completed 1,000 hours of service in a year. Employees may become participants in the Plan, and may be eligible to receive firm contributions, upon the first October 1 in which the participant has completed 20 weeks of service and is at least age 20 1/2. A participant must be employed on the last work day of the plan year to be eligible for firm contributions, unless the participant ceases to be employed by the Firm during the plan year because of death, retirement at or after age 65, or determined by the Firm to be disabled, then the participant will be eligible to share in the firm contributions regardless of employment status on the last day of the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan management is responsible for oversight of the Plan. The Retirement Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

During 2023, the Firm acquired two law firms. Each firm was acquired through a separate business combination on January 1, 2023 and March 1, 2023, respectively. The plan document was amended effective September 28, 2023 to recognize the service credits of the acquired employees and partners as of the respective acquisition date for vesting purposes under the Plan.

### Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Prior to September 1, 2024, automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. Effective September 1, 2024, the Plan was amended to increase the initial deferral rate for automatically enrolled participants hired or rehired on or after September 1, 2024 to 6% of eligible compensation. Prior to September 1, 2024, automatically enrolled participants had their deferral rate increase by one percentage point each October until their deferral rate reaches 8%. Effective September 1, 2024, the Plan was amended to increase the maximum deferral rate to 10% for participants hired or rehired on or after September 1, 2024. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan provides for a matching contribution for eligible participants. For the year ended September 30, 2024, the Firm matched 25% of the first 8% of eligible compensation that a participant contributed to the Plan, which totaled \$1,368,863.

The Plan provides for a profit-sharing contribution that includes discretionary and nondiscretionary components. The discretionary component for the year ended September 30, 2024 was equal to 9.5% of compensation for participants who are equity partners age 43 and over, 5.5% of compensation for those younger than age 43, and 2% of compensation for all non-lawyer participants. The Firm made a discretionary profit sharing contribution of \$5,300,153 for the year ended September 30, 2024. The nondiscretionary component was equal to 3% of compensation for all eligible participants for the year ended September 30, 2024. The Firm made a nondiscretionary profit-sharing contribution of \$2,838,317 for the year ended September 30, 2024.

## Participant Accounts

Each participant's account is credited with the participant's contributions, the Firm's matching contributions, allocations of the Firm's discretionary and nondiscretionary profit-sharing contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting

Participants are vested immediately in their contributions and the Firm's matching contributions plus actual earnings thereon. Vesting in the Firm's profit-sharing contributions and actual earnings thereon is based on years of credited service. A participant is 20% vested after one year of credited service and continues to vest in increments of 20% until the participant is 100% vested after five years of credited service.

## Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50% at September 30, 2024, which are commensurate with the prime rate of interest plus 1% at inception of the loan as determined monthly by the plan administrator. Principal and interest are paid ratably through semi-monthly payroll deductions. Terms range from one to five years. Participants may only have one loan outstanding at a time.

## Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum distribution or installment payment distributions equal to the value of the participant's vested interest in their account. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of a single sum cash distribution or a rollover IRA. In addition, the Plan allows for hardship distributions if certain criteria are met.

## Forfeited Accounts

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$94,447 and \$82,040, respectively. These accounts will be used to reduce future firm contributions. During the year ended September 30, 2024, \$80,250 was applied from forfeited nonvested accounts to reduce the firm's contributions, in accordance with plan provisions. Subsequent to year end, forfeitures were used to reduce the September 30, 2024 firm contribution receivable by \$96,098.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023.

### Payment of Benefits

Benefits are recorded when paid. Amounts allocated to withdrawing participants and approved for payment prior to year-end, but not yet paid as of that date, totaled \$409,151 as of September 30, 2024. There were no such payments outstanding as of September 30, 2023.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Firm. Expenses that are paid by the Firm are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### Recent Regulatory Update

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended September 30, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of the SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

The money market fund is valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and are to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The common collective trust funds are valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 4. Concentrations

As of September 30, 2024 and 2023, the Plan had investments of \$160,925,510 and \$127,829,367, respectively, that were concentrated in two funds.

#### 5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Vanguard Fiduciary Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of September 30, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of September 30, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended September 30, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

#### 6. Related-Party and Party in Interest Transactions

Certain of the Plan's investments are managed by Vanguard Fiduciary Trust Company, the trustee, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the services provided by the trustee are included in administrative expenses. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Firm. No such officer or employee receives compensation from the Plan.

## 7. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Firm contributions.

## 8. Tax Status

The IRS has determined and informed the Firm by a letter dated September 29, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
