Opinion

We have audited the accompanying financial statements of the Group Insurance Plan for the PHPA/ECHL Health and Welfare Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the Statements of Benefit Obligations and Net Assets Available for Benefits as of September 30, 2024 and 2023, and the related Statements of Changes in Benefit Obligations and Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.


