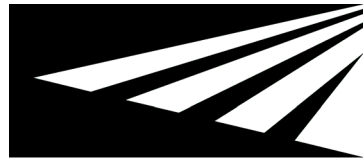

(1) Plan Description:

The following description of the Donnelly Mechanical Corp. Profit Sharing Plan for Union Employees (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Background -

Donnelly Mechanical Corp. (the "Sponsor") established the Plan on January 1, 2000. The Plan is a defined contribution plan covering all employees included in a Collective Bargaining Unit represented by Local Union 638-B who have attained the age of 21 and completed thirty days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Contributions -

The Sponsor may contribute a discretionary contribution on behalf of all participants who are active employees on the last day of the Plan year. For the year ended December 31, 2024, the Sponsor elected to make a contribution in the amount of 2% of each eligible participant's compensation, as defined in the Plan document. Contributions are subject to certain limitations.

Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of the contributions into various investment options offered by the Plan.

Vesting -

Rollover contributions are always 100% vested. Vesting in the Sponsor's contributions, and related earnings, is based on vested levels over five years of continuous service.

Participant Accounts -

Each participant's account is credited with the Sponsor's contributions, Plan gains or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants -

Each participant can borrow up to 50% of their vested account balance, subject to a maximum of \$50,000 and a minimum of \$1,000. Each loan is for a five-year period, unless it is for the purchase of a principal residence, in which case the loan may be for a reasonable period in excess of five years. The effective interest rate assumed is the prime rate (7.75% to 8.50% for the year ended December 31, 2024). Loan repayments are deposited back into the participant's account through payroll deductions. Loans are secured by the participant's account.

Payment of Benefits -

If a participant terminates employment with the Sponsor for any reason other than death, the participant can elect to leave the vested account balance in the Plan until the normal retirement date, if the account balance is greater than \$5,000. If the account balance is less than \$1,000, the participant will receive an involuntary cash-out payment in the form of a lump sum distribution. The involuntary cash-out payment will be rolled over to an individual retirement account established for the participant if the account balance is greater than \$1,000, but less than \$5,000.

Upon retirement, the total value of a participant's account can be distributed in the form of a lump-sum payment. Participants are required to begin distributions when the age of 72 is attained. In the case of death of a participant, the beneficiary designated by the participant shall be paid the deceased employee's vested account balance immediately, or in payments for up to five years from the anniversary of the date of death. If the beneficiary is the participant's spouse, payment of benefits may be deferred until they reach the age of 72. Participants who reach the age of 73 during the year ended December 31, 2023 are required to begin distributions during 2024 in accordance with the SECURE 2.0 Act.

Forfeitures -

Participants who separate or withdraw from the Plan will forfeit any amounts not vested with respect to the Sponsor's contributions. Forfeitures are transferred to a separate account and may be used to reduce future Sponsor contributions or pay plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$22,207 and \$26,703, respectively. Forfeitures used to reduce the Sponsor's contribution or pay plan expenses for the years ended December 31, 2024 and 2023, were \$30,046 and \$11,671, respectively.

(2) Summary Of Significant Accounting Policies:

Basis of Presentation -

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

Use of Accounting Estimates -

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates.

Investment Valuation and Income Recognition -

Investments are reported at fair value. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Net appreciation in fair value of investments includes realized and unrealized gains and losses on the fair value of investments held by the Plan. Purchases and sales of investments are recorded on a trade date basis. Dividends are recorded at the ex-dividend date.

Notes Receivable from Participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payments of Benefits -

Benefits are recorded when paid.

Expenses -

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

(3) Fair Value Measurement and Investments

U.S generally accepted accounting principles establish a fair value hierarchy, which require an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the reported entity has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs to the valuation are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (“SEC”). These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market mutual fund: Valued at the daily closing price as reported by the fund from an actively traded exchange. The NAV is calculated on a daily basis using the amortized cost of the underlying investments. The underlying investments consist of cash and government securities.

Collective trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available For Benefits.

(5) Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right. Accordingly, in the event of Plan termination, participants would become 100% vested in their total account balances.

(6) Information Prepared And Certified By Trustee

(7) Income Tax Status

The Plan has not obtained a determination letter from the IRS stating that the Plan is in compliance with the applicable requirements of the Internal Revenue Code (the "IRC"). The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has determined and informed the Trustee by a letter dated June 30, 2020, that the prototype plan document was designed in accordance with the applicable standards of the IRC. The Plan Administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. generally accepted accounting principles require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator believes there are no such positions, and therefore, no provision for income tax has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(8) Transactions With Parties-In-Interest

Certain Plan investments are shares of funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$11,167 for the year ended December 31, 2024.

The Plan also utilizes the services of a consultant, United Benefit Pensions, Inc., to calculate the employer contribution, perform non-discrimination testing, and prepare the Form 5500. Fees paid by the Plan to the consultant amounted to \$7,978 for the year ended December 31, 2024.
