## Independent Auditors' Report

To the Plan Administrator of  
Nassau Candy Pension Plan

### ***Opinion***

We have audited the accompanying financial statements of Nassau Candy Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of accumulated plan benefits and net assets available for benefits (in liquidation) as of September 30, 2024 and 2023, and the related statements of changes in accumulated plan benefits and net assets available for benefits (in liquidation) for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to in the first paragraph present fairly, in all material respects, the accumulated plan benefits and net assets available for benefits of Nassau Candy Pension Plan (in liquidation) as of September 30, 2024 and 2023, and the changes in its accumulated plan benefits and its net assets available for benefits (in liquidation) for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Nassau Candy Pension Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Emphasis of Matter-Plan Termination***

As discussed in Note 4 to the financial statements, the board of directors approved a resolution to terminate the Plan effective August 1, 2023. As a result, the financial statements are prepared on the liquidation basis of accounting. Our opinion is not modified with respect to that matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair

presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Nassau Candy Pension Plan (the "Plan"), is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

- A. General – The Plan is a defined benefit pension plan covering the employees of Nassau Candy Distributors, Inc., the Plan sponsor, not excluded by class. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Board of Directors approved a resolution to terminate the Plan, see note 4.

- B. Pension Benefits – To participate in the Plan, an employee must have one or more years of service, and not be excluded. Employees other than those identified in the Plan document are not eligible to participate in the Plan. Provided a participant has met the Plan's vesting requirements, the participant's annual pension benefit beginning at normal retirement age of 62 is equal to the participants accrued benefit as of September 30, 2017 plus five tenths percent (.5%) of compensation multiplied by the participants years of service as a participant up to a maximum of thirty-five. Notwithstanding, certain participants identified in the Plan document shall receive the participants accrued benefit as of September 30, 2017 plus 1.75% of compensation times credited years of service, 2% of compensation times credited years of service, 2.5% of compensation times credited years of service, 3.1% of compensation times credited years of service, 3.6% of compensation times credited years of service, 5.5% of compensation times credited years of service, 8% of compensation times credited years of service, or 11% of compensation times credited years of service. Credited years are Plan years commencing October 1, 2017 and ending with the retirement year excluding years with less than 500 hours, with a maximum of 35 years. The benefit as determined shall be offset by an actuarially equivalent benefit consisting of the participants vested account balance that is derived from employer contributions, other than salary reduction and matching contributions, if applicable, under the Nassau Candy Profit Sharing Plan I. For purposes of determining a participants accrued benefit, the offset shall be applied after determining the accrued benefit without regard to the offset. The accrued benefit shall be subject to a participants vested interest under each plan. The benefit is based on average salary during the highest five consecutive years of employment excluding years prior to the year of entry. If any participant shall terminate employment for any cause except death, disability, retirement on the normal retirement date, or deferred retirement, his or her participation in the plan shall terminate. The nonforfeitable percentage of a participants accrued benefit shall be as follows: 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, 100% after six years of service. The value of a participants accumulated plan benefits is payable for the life of the participant. Employees may elect to receive their pension benefits in the form of a joint and survivor annuity.
- C. Distribution of Vested Accrued Benefits – In the event of a mandatory distribution greater than \$1,000 that is made in accordance with provisions of the Plan providing for an automatic distribution to a participant without the participants consent, if the participant does not elect to

have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly in an immediate single sum payment, the plan administrator will pay the distribution in a direct rollover to an individual retirement plan designated by the plan administrator.

- D. Late Retirement Benefit – If such a participant elects to defer commencement of his normal retirement benefit beyond the participants' normal retirement date, the late retirement benefit shall be payable on his actual retirement date.
- E. Death and Disability Benefits – If an active participant dies, a death benefit equal to the value of the proceeds of any insurance policies on the life of the participant plus the actuarial equivalent of the accrued benefit earned to date of death less the cash value of such policies is paid to the participants beneficiaries. Active participants who become totally disabled receive annual disability benefits that are equal to the normal retirement benefits they have accumulated as of the time they become disabled.
- F. Forfeitures – On termination of service, the unvested portion of a participant's company contribution account is forfeited. All forfeitures arising for any reason shall be used to reduce the employer's contribution to the Plan. If a benefit is forfeited because the beneficiary cannot be found, such benefit will be reinstated if a claim is made by the participant or beneficiary. At September 30, 2024 and 2023 there were no forfeited non-vested accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- A. Basis of Accounting – For the September 30, 2024 and 2023 fiscal year, the financial statements of the Plan are prepared on the liquidation basis of accounting in accordance with U.S. GAAP.
- B. Use of Estimates – The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- C. Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- D. Actuarial Present Value of Accumulated Plan Benefits - Accumulated plan benefits are those future periodic payments, including lump sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries.

Benefits under the plan are accumulated based on employees' compensation during each year of credited service. The accumulated plan benefits for active employees is based on average salary during the highest five consecutive years of employment excluding years prior to the year of entry on the date as of which the benefit information is presented (the valuation date). Benefits payable under all circumstances—retirement, death, disability, and termination of employment—are included, to the extent they are deemed attributable to employee service rendered to the valuation date. The actuarial present value of accumulated plan benefits is determined by an independent actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuations as of September 30, 2024 and 2023 were (a) life expectancy of participants (2024 417(e) Mortality Table and PRI – 2012 with Projection Scale MP 2021 were used), (b) retirement age assumptions (the assumed average retirement age was 67), and (c) investment return. The 2024 and 2023 valuations each assumed an average rate of return of 6.5%.

The Plan performed its valuations as of the beginning of year. Had the valuations been performed as of December 31, there would be no material differences.

- E. Payment of Benefits – Benefit payments to participants are recorded upon distribution.
- F. Administrative Expenses – The Plan's administrative expenses are paid by either the Plan or the Plan's sponsor, as provided by the Plan document.
- G. Subsequent Events - The Plan's management evaluated subsequent events through July 11, 2025 the date these financial statements were available to be issued and determined there were no subsequent events requiring disclosure.

NOTE 3 – FUNDING POLICY

The contributions of the Plan sponsor are designed to fund the Plan's current service costs on a current basis. The amounts contributed to the Plan are determined on a basis of: (a) annual actuarial valuations of the Plan by an independent consulting actuary; (b) the maximum amount permitted by law or regulation as a federal income tax deduction; (c) the minimum amount certified by the actuary as necessary during any plan year to avoid an accumulated funding deficiency as defined by ERISA. The minimum required contribution for the Plan year ended September 30, 2024 and 2023 was \$0 and \$324,452, respectively. The minimum required contribution is a term defined in the law. It does not represent the minimum contribution required to satisfy the funding requirement. Rather, it may be satisfied through any combination of Company contributions, or use of advanced contributions in either the funding standard carryover balance or prefunding balance. The Plan sponsor contributed \$0 and \$0 to the Plan for the Plan years ended September 30, 2024 and 2023, respectively.

NOTE 4 – PLAN TERMINATION

The Board of Directors has approved a resolution to terminate the Plan effective August 1, 2023. Effective with the Plan's termination, all participants are considered to be fully vested. Participants account balances were distributed in the form of a lump sum payment from the Plan, and such participants could elect to have their lump sum payment rolled over into an IRA or other qualified retirement plan. After all distributions were made to participants, subsequent to year end the remaining assets were rolled into a qualified replacement plan.

Upon Plan termination, the net assets of the Plan were allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- A. Benefits attributable to employee contributions, taking into account those paid out before termination.
- B. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
- C. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.
- D. All other vested benefits (that is, vested benefits not insured by the PBGC).
- E. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC when the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. Whether all participants receive their benefits upon Plan termination at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.

NOTE 5 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2*

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Money market funds:* Valued at the net asset value of shares held by the Plan at year end.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held

by the Plan are deemed to be actively traded.

*Exchange Traded Funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Equities:* Valued at the closing price reported on the active market on which the individual securities are traded. If not traded on active market, valued by third-party pricing sources or appraisers.

*Corporate bonds:* Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

*Life insurance contracts:* Valued using the cash surrender value provided by the insurance companies. The cash surrender values do not represent a quoted price in an active market; therefore, those inputs are unobservable and are categorized as level 3.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Changes in fair value levels:* The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

The Plan has certain investments managed by Charles Schwab, the custodian, therefore these transactions qualify as party-in-interest transactions. Pathstone Family Office, LLC (formerly known as Veritable, LP) provides investment advisory services to the plan which qualify as party-in-interest transactions. Fees paid by the Plan to Pathstone Family Office, LLC for investment advisory services for the years ended September 30, 2024 and 2023 amounted to \$39,128 and \$50,474, respectively. NFP provides actuarial services, as defined by the Plan, which also qualify as party-in-interest transactions. Actuary service fees are paid by the Plan sponsor.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change.

Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

NOTE 8 – COMMITMENTS

On March 7, 2023 the Plan subscribed to a \$1,000,000 capital commitment to invest in Star Mountain Strategic Credit Income Fund IV (“SMSCIF”). The Plan was committed to making capital contributions, in cash, in installments as called from time to time by the fund, for up to an amount constituting the Plan’s commitment amount. As of September 30, 2024, the Plan has fulfilled its commitment.

On June 24, 2022 the Plan subscribed to a \$700,000 capital commitment to invest in F3 Investments V Rated Feeder, LLC (“the fund”). The Plan was committed to making capital contributions, in cash, in installments as called from time to time by the fund, for up to an amount constituting the Plan’s commitment amount. As of September 30, 2024, the Plan has fulfilled its commitment.

On January 30, 2021, the Plan subscribed to a \$1 million capital commitment to invest in Star Mountain Lower Middle-Market Capital Corp (“Star Mountain”). The Plan was committed to making capital contributions, in cash, in installments as called from time to time by Star Mountain, for up to an amount constituting the Plan’s “Unfunded Capital Commitment”. As of September 30, 2023, the Plan had fulfilled its commitment.

NOTE 9 – TAX STATUS

The Internal Revenue Service has determined and informed the company by letter dated February 11, 2016, that the Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter. However, the Plan administrator and Plan’s actuary believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded

that as of September 30, 2024, the Plan has maintained its tax-exempt status and there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
