INDEPENDENT AUDITORS' REPORT

To the Board of Trustees
Local 802 Musicians Health Fund

Opinion

We have audited the financial statements of the Local 802 Musicians Health Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in benefit obligations and in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS SEPTEMBER 30, 2024 AND 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Local 802 Musicians Health Fund (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan was established for the purpose of providing benefits to eligible employees covered by collective bargaining agreements between the League of New York Theatres, Inc., and other employers (together the “Employers”) and the Associated Musicians of Greater New York, Local 802, A.F. of M. (the “Union”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Administration: The administration of the Plan is the responsibility of a Board of Trustees comprised of Union and Employer Trustees. The Union Trustees and Employer Trustees have equal voting rights. The investments of the Plan are managed by an investment adviser and maintained by an investment custodian.

Benefits: The Plan provides benefits as enumerated in Note 7 to active participants of the Plan and to their beneficiaries and covered dependents.

During the year, the following insured benefits were in effect:

Contributions: Contributions under the various collective bargaining agreements are made by the employers for covered participants based on hours and/or days worked. The contribution rates are determined by the collective bargaining agreements in effect at the time. Participants are required to contribute quarterly for family coverage, and monthly for individuals at rates determined by the Plan.

Procedure on Termination: In the event of termination of the Plan, the Trust Agreement requires that the Trustees pay all obligations of the Plan and distribute any remaining surplus to the participants and/or their dependents or beneficiaries in the form of benefits. In no circumstance may any funds revert to the Employers or to the Union.

Other: The Plan’s Board of Trustees, as Sponsor, has the right under the Plan to modify benefits provided to participants and to terminate the Plan. The Plan may be terminated at (1) any time by a vote of the Board of Trustees or (2) automatically, in the event that the obligation of all Employers to make contributions to the Plan terminates or no assets remain in the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 12 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year. Unrealized gains or losses are the differences between the fair value of the investments held at year-end and those held at the beginning of the year. Realized gains or losses on the sale of investments are based on the historical costs of the individual investments sold for financial reporting purposes, whereas the revalued cost (fair value at the beginning of the year) is used for determining the realized gain or loss for Form 5500 purposes.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Plan Benefits: Plan obligations at September 30 for health claims incurred but not reported at that date and for accumulated eligibility of participants at year end were estimated by the Plan's actuary in accordance with accepted actuarial principles. These estimated amounts are reported in the accompanying statement of the Plan's benefit obligations at present value. Additionally, the Plan provides for the payment of sick pay benefits subsequent to the financial statement date for those participants who have accumulated a sufficient number of unused sick days. Such accumulated eligibility credits represent a liability of the Plan. The liability is determined by the Plan Administrator by applying the amount of unused sick days to the regular daily wage.

Fixed Assets and Depreciation: Fixed assets are stated at cost less depreciation accumulated since acquisition and do not purport to represent replacement or realizable value. All assets are depreciated over estimated useful lives using the straight-line method. Expenditures for normal repairs of equipment are charged to current operations. All other expenditures for fixed assets are capitalized.

Current Expected Credit Losses: The Plan has adopted Accounting Standards Update (ASU) No. 2016-13, Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments. The core principles of ASU 2016-13 (the "ASU") significantly change the way organizations recognize credit losses by replacing the incurred loss model with an expected loss model. The financials assets held by the Plan that are subject to the ASU are accounts receivables.

The Plan assesses credit losses on accounts receivable on a regular basis to determine the allowance for doubtful accounts. Given the nature of the Plan's financial assets and historical loss experience, the adoption of the ASU did not have a significant impact on the financial statements.

NOTE 3 – CONCENTRATION OF CREDIT RISK

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of cash held by financial institutions, which from time to time may exceed the Federal Depository Insurance Corporation coverage limit. The Plan has not experienced any losses in such accounts.

NOTE 4 – TRANSACTIONS WITH PARTY-IN-INTEREST

For administrative purposes, the Plan's employees are included in the Union's payroll. The Plan reimburses the Union for 100% of the Plan's payroll costs, rent as per the lease agreement (see Note 12), computer, overhead, and other administrative expenses paid on its behalf as described in the allocation agreement between the Plan and the Union. Reimbursements to the Union for the years ended September 30, 2024 and 2023 were \$842,010 and \$748,945 respectively.

NOTE 10 – TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c) (9) of the Internal Revenue Code and, accordingly, the trust's net income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service, and the Plan sponsor believes that the Plan, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

NOTE 12 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Interest bearing cash: Interest bearing cash is carried at cost, which approximates fair value.

NOTE 12 – FAIR VALUE MEASUREMENTS (continued)

Registered investment companies: Certain registered investment companies are valued at the closing price reported in the active market on which they are traded. Others are valued at estimated fair value as determined by the investment manager based on the market value and estimated fair value of the underlying investments in the portfolio. In establishing the fair value of these investments, the investment manager takes into consideration information about the net asset value of shares held by the Plan at year end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.


