Opinion

Notes to Financial Statements

1. Plan Description

The following brief description of Nassau Candy Profit Sharing Plan I (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a profit-sharing plan sponsored by Nassau Candy Distributors, Inc. (the "Company"). All, non-leased employees not covered by a collective bargaining agreement, who have attained the age of twenty-one and have performed one year of service, and are participating in the Nassau Candy Pension Plan are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Board of Directors approved a resolution to terminate the plan, see note 5.

Contributions

Nonelective contributions: Participants are eligible to receive a discretionary nonelective employer contribution if they are employed on the last day of the plan year and have completed 500 hours of service during the Plan year.

Top-heavy contribution: The Company shall contribute to the Plan the amount necessary to provide the top-heavy minimum contribution, even if it exceeds the amount that would be deductible under Code Section 404.

Participants may also transfer funds from another qualified plan, subject to certain requirements.

The Company made a discretionary nonelective employer contribution of \$0 and \$61,048 for the years ended September 30, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on each participant's account balance within each fund.

Vesting

Effective with the Plan's termination, all participants are considered to be fully vested in the company's contributions and earnings.

Distribution of Benefits

The benefit to which a participant is entitled is equal to the value of the participant's vested interest in their account. Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Participants may elect to

take a distribution in the form of a lump sum distribution, partial distribution, or installment payments. A participant may also request a withdrawal upon attainment of age 62.

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture, as defined by the Plan. Forfeited balances may be used to reinstate previously forfeited account balances of participants, if any; to satisfy any contribution that may be required to resolve an erroneous omission of an eligible employee or circumstances relating to the unknown location of a participant or an unknown beneficiary as described in the Plan document, if any; or be used to pay any administrative expenses of the Plan. The remaining forfeitures, if any may be used to reduce employer contributions. Forfeitures attributable to nonelective contributions shall be used to reduce the employer's contribution for the Plan year. In the event forfeitures are used to reduce an employer discretionary contribution and the forfeitures to be allocated exceed such discretionary contribution (such as when no discretionary contribution is made), then the remaining forfeitures will constitute an additional discretionary contribution. During the year ended September 30, 2024 there were no forfeitures. There also were no unallocated forfeitures at September 30, 2024 and 2023.

2. Summary of Significant Accounting Policies

Basis of Presentation

For the September 30, 2024 and 2023 fiscal years, the financial statements of the Plan are prepared on the liquidation basis of accounting in accordance with U.S. GAAP.

Use of Estimates

The preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's states its investments at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion on fair value measurements.

2. Summary of Significant Accounting Policies *(Continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's realized and unrealized gains (losses) on investments bought, sold, and held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Plan's sponsor, as provided by the Plan document.

Subsequent Events

The Plan's management evaluated subsequent events through June 23, 2025, the date these financial statements were available to be issued and determined there were no subsequent events requiring disclosure.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and reflect management's best estimate of what market participants would use as fair value.

3. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Funds: Valued at the net asset value of shares held by the Plan at year end.

4. Parties-in-Interest

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, the management of investments held by the custodian as well as the audit services provided by the Plan's independent auditor are considered party-in-interest transactions. Fees paid by the Plan for investment management services and administrative fees for the year ended September 30, 2024 amounted to \$1,021. Fees paid by the Plan sponsor to the Plan's independent auditor were \$9,000.

5. Plan Termination

The Board of Directors has approved a resolution to terminate the Plan effective August 1, 2023. Effective with the Plan's termination, all participants will be considered to be fully vested. Participants account balances were distributed in the form of a lump sum payment from the Plan, and such participants could elect to have their lump sum payment rolled over into an IRA or other qualified retirement plan. After all distributions were made to participants, subsequent to year end the remaining assets of \$6,801 were rolled into a qualified replacement plan.

6. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the sponsor by a letter dated July 25, 2019 that the plan document adopted by the plan sponsor and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
