The financial statements comprise the statement of net assets available for benefits as of September 30, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. Description of Plan

The following description of Springfield 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan provisions for more information.

General

The Plan is a tax-exempt, defined contribution retirement plan covering substantially all employees of North Star Health and Springfield Hospital Corporation (collectively, the Organizations). Employees are eligible to make salary deferrals to the Plan as of their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Variable Annuity Life Insurance Company (VALIC) is the recordkeeper and the custodian of the Plan.

Contributions

Participants can elect to contribute up to 100% of their compensation on a pre-tax basis during each Plan year, up to a maximum allowable amount, as determined by the Internal Revenue Code (Code).

The Plan allows for employer matching and discretionary contributions. Participants are eligible to receive employer contributions after 90 days of employment. The Plan made matching contributions of 50% of participant contributions up to a maximum of 2% of eligible, fiscal year compensation. There was no discretionary contribution made in 2024.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's and Organizations' contributions and an allocation of investment income, and charged with an allocation of the investment losses and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct their accounts among various investment options. The Plan currently offers several mutual funds as well as a group fixed unallocated annuity contract. A participant's account shall be reduced by any distributions.

Vesting

Participants are immediately vested in their contributions and all related earnings. Vesting in the Organizations' contributions and all related earnings is based upon years of continuous service. A participant is 100% vested if they are working for the Organizations and reach normal or early retirement age, become totally disabled, or die. Before that time, participants vest on a five-year vesting schedule.

Forfeiture Accounts

Forfeiture balances of terminated participants' nonvested accounts shall be used to reduce employer contributions or pay plan expenses. There is no balance in the forfeiture account as of September 30, 2024 and 2023.

Payment of Benefits

On termination of service due to any reason including death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period of the participant's assumed life expectancy. In addition, participants may withdraw their pre-tax contributions upon demonstration to the plan administrator that they are suffering a hardship, as defined in Section 401(k) of the Code.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to the lesser of 50% of their vested account balance or \$50,000. The notes receivable are secured by the balance in the participant's account and bear interest at a rate of 1% above the Prime interest rate, which is subject to change on a quarterly basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Plan Termination

Although it has not expressed any intent to do so, the Organizations have the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual method of accounting.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment Valuation and Income Recognition

Investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The group fixed unallocated annuity contract is reported at contract value, which is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract (Note 3). See Note 8 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

Expenses

Substantially all administrative expenses are paid by the Plan.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Subsequent events are events or transactions that occur after the balance sheet date, but before the financial statements are issued. Management has considered transactions or events occurring through July 7, 2025, the date the financial statements were available to be issued, and no events occurred requiring recognition or disclosure.

3. Investment Contract with Insurance Company

The group fixed unallocated annuity contract is a fully benefit-responsive investment contract with VALIC. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, as reported to the Plan by VALIC. Fair value is the amount which is payable on demand on the reporting date. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract may be surrendered at any time for the accumulated value of net purchase payments received by VALIC, plus any interest credited, less any amounts deducted for benefits, withdrawals, transfers and annuity purchases. Participant withdrawals are also subject to the limit of the accumulated value.

4. Income Tax Status

The Plan is a prototype plan sponsored by VALIC Retirement Services Company (VALIC RSC), an affiliated company to the Plan's recordkeeper. VALIC RSC obtained an opinion letter on the Plan dated June 30, 2020, stating that the form of the Plan is acceptable under Section 401 of the Code. Generally, the plan administrator and the Plan may rely on the opinion letter received by VALIC RSC as to the form of the Plan qualifying under the Code (except as otherwise noted in the opinion letter). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

5. Information Prepared and Certified by the Custodian

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants, notes receivable from participants income, and interest and dividends were obtained by management and agreed to or derived from the information certified by VALIC, the custodian, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits;
- Note 3 in the Notes to Financial Statements; and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

6. Party-in-Interest Transactions

Certain plan investments are shares of a group fixed unallocated annuity contract managed by VALIC, the recordkeeper. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amount to \$59,011 for the year ended September 30, 2024.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued using market quotations.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.
