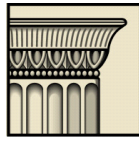

## Independent Auditor's Report

The Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SWVA, Inc. Collective Bargaining Unit Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in *Note 4* to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

## Notes to Financial Statements

September 30, 2024

### **1. Description of the Plan**

The following description of the SWVA, Inc. Collective Bargaining Unit Retirement Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all collective bargaining employees of SWVA, Inc. (Company) who have completed a probationary period of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Participants may make voluntary before-tax contributions to the Plan up to 75 percent of eligible annual compensation, as defined by the Plan, up to a maximum that is set by law. Participants age 50 or older may elect to contribute additional amounts to the Plan up to a maximum that is set by law. With approval by the plan administrator, participants may also make rollover contributions of amounts representing distributions from other qualified retirement plans. Additionally, the Plan allows participants to change their contribution rate with regard to future compensation on a quarterly basis with proper notice to the Company.

Effective June 27, 2022, pursuant to the amended and restated plan, the Company makes contributions in accordance with the terms of the Plan. Monthly contributions are made to a participant's accounts in an amount equal to one dollar and fifty cents (\$1.50) multiplied by such participant's hours of service for the month. Prior to June 27, 2022, monthly contributions were made to a participant's accounts in an amount equal to one dollar and twenty-five cents (\$1.25) multiplied by such participant's hours of service for the month. An additional contribution to the Plan may be made at the sole discretion of the Company.

Participants are immediately and fully vested in their voluntary contributions and Company contributions, plus actual investment gains or losses thereon.

#### **Investment Options**

The Plan allows participants to change their investment elections, with respect to the portion of their account subject to their investment direction, at any time. Currently, a participant may select from numerous diversified mutual funds and a common collective trust fund.

## Notes to Financial Statements (continued)

### **1. Description of the Plan (continued)**

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contributions, (b) Plan earnings or losses, and (c) administrative expenses. Allocations are based on participant earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### **Notes Receivable from Participants**

Effective October 14, 2022, the Plan was amended to permit participants to borrow from their account. Participants may borrow against the value of their vested account balance with a minimum of \$1,000 and up to a maximum equal to the lesser of (a) \$50,000 reduced by the excess, if any, of the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan over the current outstanding balance of loans as of the date of the new loan or (b) 50 percent of their vested interest in the Plan. The maximum number of loans available to any participant is two and the term of the loan is up to five years. However, if the loan is for the purchase of a principal residence, the plan administrator may permit a longer repayment term (generally ten years). The loans are secured by the balance in the participant's vested account and bear interest at a reasonable rate of interest as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions. Should the participant terminate as an employee of the Company, the balance of the outstanding loan (including any accrued interest) becomes due and the participant's vested account may be used to pay the balance of the outstanding loans.

#### **Benefit Payments**

Upon termination of service, including disability, retirement, resignation, or dismissal, a participant may elect to receive a distribution equal to the value of his or her account. Payment of benefits to eligible participants may be delayed in accordance with the Plan. Participants who have attained age 59½ are permitted to make one in-service withdrawal during a rolling 12 month period of all or a portion of the available funds in their account for the Plan offered to employees and as referenced in the Collective Bargaining Agreement. Benefit payments may be in the form of a lump-sum payment in cash; monthly, quarterly, semi-annual, or annual cash installment over a period of not more than the participant's assumed life expectancy (or the participant's and the participant's beneficiary's assumed life expectancies) at the time of distribution; or an annuity from an insurance company providing payments over the participant's lifetime with or without payments over the spouse's lifetime after the participant's death.

## Notes to Financial Statements (continued)

### 1. Description of the Plan (continued)

#### Benefit Payments (continued)

A beneficiary or beneficiaries may request a distribution of a participant's account balance in the event of a participant's death. Participants that are entitled to a distribution with account balances of \$1,000 or less will receive a lump-sum distribution. The Plan also allows participants to have any portion of an eligible distribution paid directly to any eligible retirement plan specified by the distributee in a direct rollover. Terminated participants with account balances over \$1,000 may delay timing of the distribution, subject to minimum distribution rules required by law.

Subject to certain requirements and limitations, the Plan also provides for hardship withdrawals. Distributions of benefits are recorded as withdrawals from the Plan and reduction of assets available for plan benefits in the period paid to the participant.

#### Plan Termination

Although the Company has not expressed any intent to do so, the Company and the United Steelworkers Association may, by agreement between them, amend or terminate the Plan and may agree that the Company may discontinue, suspend, or change the rate and amount of its contributions at any time. If the Plan is terminated, partially terminated, or contributions are discontinued, the Plan assets shall continue to be held for distribution to participants as provided by the Plan or may be immediately distributed to the participants.

### 2. Significant Accounting Policies

#### Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

#### Investments

Investments are reported at fair value, including the Plan's investment in a common collective trust fund that is reported at fair value using net asset value as a practical expedient. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See *Note 5* for discussion of fair value measurements.

### **2. Significant Accounting Policies**

#### **Investments (continued)**

Purchases and sales of securities are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains distributions are included in dividend income.

The Plan presents in the statements of changes in assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments. Unrealized appreciation or depreciation in the aggregate fair value of investments represents the change in the difference between aggregate fair value and the cost of investments, including reinvestment of earnings. The realized gain or loss on sale of investments is the difference between the proceeds received and the average cost of investments sold.

The underlying investments of the mutual funds and a common collective trust fund consist of diverse portfolios with no significant concentration of risk by issuer, industry, or geographic location.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

#### **Use of Estimates**

Preparation of the Plan's financial statements requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

## Notes to Financial Statements (continued)

### **3. Income Tax Status**

The Plan has received a determination letter from the Internal Revenue Service stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (Code) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the favorable determination letter, the plan administrator believes the Plan, as amended, is being operated in compliance with the applicable requirements of the Code, and, therefore, believes that the Plan is qualified and the related trust is tax exempt and the Plan has no income subject to unrelated business income. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to take that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to September 30, 2021.

### **4. Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule including investments held at September 30, 2024 and 2023 and net appreciation (depreciation) in fair value of investments and interest and dividend income for the years then ended, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, Newport Trust Company, and PNC Bank, N.A., the trustees of the Plan. Interest and dividend income was \$1,359,353 and \$922,597 for the years ended September 30, 2024 and 2023, respectively.

#### 5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 (ASC 820), *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 5. Fair Value Measurements (continued)

*Common collective trust fund:* The collective investment fund is a public investment vehicle, valued using the NAV provided by the administrator of the trust that focuses on stability of principal and current income. There are currently no redemption restrictions on the common collective trust fund. The NAV is based on the value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of shares outstanding. The NAV is quoted on a private market that is not active; however, the unit price of the underlying investments is traded on an active market. The common collective trust fund has no unfunded commitments as of September 30, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
