The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1 - Description of Plan

The following description of the York Graphic Services Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a defined contribution plan covering all employees of York Graphic Services Company (the Company) who have completed one month of service. The Plan does not have an age requirement. During the year ended December 31, 2024, Gavin Communications, Inc. became a newly participating employer in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 100% of their compensation, not to exceed the annual maximum deferral amount as defined by law. Participants may contribute pre-tax and after-tax amounts. Catch-up contributions are permitted for eligible participants age 50 or older by the end of a calendar year. The Plan has automatic enrollment at a 4% deferral rate for all eligible employees into a qualified default investment fund. The participant may modify enrollment to waive participation or to change this automatic deferral percentage or fund. The Plan also has an auto-escalation provision whereby deferral rates will increase 1% each year, up to a maximum of 10%, unless the participants elect otherwise. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company may make discretionary matching contributions to be determined each year. For the years ended December 31, 2024 and 2023, the matching contribution is 25% of the participant's salary deferral, including catch-up contributions, to a maximum of 4% of the participant's eligible compensation.

The Company may make discretionary profit-sharing contributions. A participant must complete one year of service to be eligible for the discretionary profit-sharing contribution, with the exception of death, permanent disability, and retirement. There were no profit-sharing contributions for 2024 and 2023.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of Plan (continued)

Vesting

Participants are immediately vested in the participant's salary deferral amounts, rollover contributions, employer's matching contributions, and any earnings thereon, regardless of the number of years of service. If a participant ceases participation, except by retirement, death or permanent disability, the vested interest in employer's discretionary profit-sharing contributions and earnings thereon is dependent upon the years of credited service.

Each participant is vested in the employer's discretionary profit-sharing contributions according to the following schedule based upon the years of service:

2 years	40.0%

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence, in which case the loan may be for up to 15 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%, set the first day of each month. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment, if a participant's vested interest in their account exceeds \$5,000, no distribution shall be made to the participant before they reach the age of normal retirement or receipt of consent to pay out by the participant and their spouse, if applicable.

If the participant's account is less than \$5,000, the vested account balance is paid out in the form of a lump sum distribution. In the event of a mandatory distribution greater than \$1,000, the Plan Administrator will pay the distribution in a direct rollover to an individual retirement arrangement designated by the Plan Administrator if the participant does not elect a direct rollover or lump sum distribution.

Forfeited Accounts

Forfeited non-vested accounts, if any, shall be applied to pay administrative expenses or reduce employer contributions no later than the following plan year. Forfeited non-vested accounts at December 31, 2024 and 2023 were immaterial.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants and beneficiaries are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to the required deadline in the subsequent year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain recordkeeping and other administrative expenses are paid by the Plan. Investment-related expenses are included in net appreciation in fair value of the investments.

Note 3 - Information Certified and Provided by Voya Retirement Insurance and Annuity Company

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

Note 4 - Fair Value Measurements

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts are primarily valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments held by the fund.

The Plan's interest in the collective trust fund is valued at NAV of units held.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Plan Tax Status

The Company adopted a prototype non-standardized profit-sharing plan sponsored by CCH Incorporated. The prototype non-standardized profit-sharing plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the prototype non-standardized profit-sharing plan is qualified under the appropriate section of the Internal Revenue Code (IRC). The prototype non-standardized profit-sharing plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. Federal, state, or local tax authorities for years before 2021.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company contribution portion of their account.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Related Party Transaction and Party-In-Interest Transactions

The Plan invests in various pooled separate accounts and units of a collective trust fund managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the custodian as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management and custody services are immaterial.

Note 9 – Prohibited Transactions

During 2024, the plan sponsor inadvertently failed to deposit \$5,600 of participant deferrals within the required time frame as stated by the United States Department of Labor regulations. The plan sponsor intends to make the corrective deposit in 2025 to reimburse the Plan for lost interest. The plan sponsor intends to file Form 5330 and pay the applicable excise tax in 2025. The excise tax payments will be made from the plan sponsor's assets and not from assets of the Plan.

Note 10 - Reconciliation of Financial Statement to the Form 5500
