The following description of the St. Joseph's Rehabilitation Center, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of St. Joseph's Rehabilitation Center, Inc. (the Center) who complete one year of service, as defined, and are age 20½ or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Center is the sponsor of the Plan.

#### **Contributions**

Participants may make voluntary contributions subject to certain limitations under the terms of the Plan and the Internal Revenue Code (the Code). The Center can make supplemental contributions at the discretion of the Board of Directors and contributed \$59,928 and \$74,885 for the years ended September 30, 2024 and 2023, respectively.

#### **Rollover Contributions**

The Plan will accept direct rollover contributions from a qualified plan, as defined by the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Center's contributions, account earnings or losses, and certain administrative expenses. Participants direct the investment of the contributions into various options offered by the Plan.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus earnings/losses thereon. Vesting in the Center's supplemental discretionary contributions plus earnings thereon is based on a vesting table and are 100% vested after completing five years of credited service.

#### **Payment of Benefits**

On termination of service due to death, retirement or other reasons, a participant or beneficiary receives an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount.

#### **Hardship Withdrawals**

Participants may receive distributions up to 100% of their elective deferrals in the form of a hardship withdrawal upon meeting financial hardship requirements outlined in the Plan document.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Plan participants may borrow up to the lesser of \$50,000 or 50% of the participant's vested interest in the Plan. The minimum loan amount is \$1,000. Participant loans are secured by their account balances and bear interest at rates ranging from 5.00% to 10.50%.

## 1. DESCRIPTION OF PLAN (Continued)

### **Forfeitures**

Forfeitures of supplemental discretionary contribution accounts can be used for several purposes, including adding to supplemental employer discretionary contributions and payment of Plan expenses. During the years ended September 30, 2024 and 2023, \$5,120 and \$4,203, respectively, were forfeited, and the amount available for future use at September 30, 2024 and 2023, was \$21,999 and \$16,125, respectively.

### **Plan Administration Costs**

The Center pays certain administrative costs of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments held by a defined contribution plan are to be reported at fair value, except for fully-benefit responsive investment contracts, which are required to be reported at contract value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

### **Fair Value Measurements**

Accounting Standards Codification 820 (ASC 820) established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lower priority to unobservable inputs (Level 3 measurements). Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly, or indirectly, are considered level 2 measurements.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value Measurements (Continued)

The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology during the years ended September 30, 2024 or 2023.

*Pooled separate accounts:* Valued at the quoted net asset value of each fund, which is based on the value of the underlying portfolio investments at the valuation date.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at reporting date.

### Guaranteed Insurance Contract

*Guaranteed Insurance Contract:* Valued at contract value, which approximates fair value, as reported to the Plan by Ameritas Life Insurance Company ("Ameritas"). Contract value represents contributions made under the contracts, plus earnings and reduced for withdrawals and administrative expenses and an estimate of the surrender charges if the Plan were terminated.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Guaranteed Insurance Contract (Continued)**

*The Guaranteed Investment Account* invests in a conservative mix of corporate bonds, mortgage-backed and asset-backed securities, government securities, commercial mortgage loans, and short-term equivalents. These investments in this diversified portfolio, purchased each quarter, will determine the renewal rates in subsequent years. The fund is designed to provide safety of principal, liquidity, and a competitive rate of return by offering stability of crediting rate, guaranteed protection of principal and accumulated interest from market volatility, and intermediate-term fixed income returns.

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Ameritas totaling \$540,453 and \$560,373 as of September 30, 2024 and 2023, respectively. Ameritas maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3.0 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Ameritas, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

### **Payment of Benefits**

Benefits are recorded when paid.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances the amounts reported in the financial statements.

The Plan's investments in pooled separate accounts are stated at fair value based on quoted prices of securities with similar characteristics. Pooled separate accounts do not have quoted market prices available and were therefore valued using level 2 inputs, using pricing models that vary by asset class and incorporate available trade, bid and other market information of the underlying investments. Pooled separate accounts are made up of a wide variety of underlying investments such as equity funds, balanced funds, money market funds, bond funds and international funds and allocation of those investments vary with the specific investment strategies of the individual accounts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes to the valuation techniques during 2024 and 2023.

#### 5. PLAN TERMINATION

While the Center has not expressed any intent to discontinue the Plan, it has the right to do so at any time, subject to the provisions of ERISA. In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants would become fully vested and nonforfeitable. Assets would be distributed to participants as directed by the plan administrator in the form of a lump sum. All distributions would be made in accordance with any applicable requirements of ERISA and the Code.

#### 6. TAX STATUS

The Internal Revenue Service has determined and informed the Center by letter dated August 30, 2001, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

#### 7. PARTY-IN-INTEREST TRANSACTIONS

Ameritas is the custodian of the Plan and the Center is the Plan Sponsor. As such, transactions between Ameritas, the Center, and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.
