## Independent Auditor's Report

To the Board of Trustees of  
403(b) Thrift Plan for Employees of Asociacion Puertorriquenos En Marcha, Inc.:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan for Employees of Asociacion Puertorriquenos En Marcha, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan for Employees of Asociacion Puertorriquenos En Marcha, Inc. and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

### **June 30, 2024 and 2023**

#### **1. Description of Plan**

The following description of the 403(b) Thrift Plan for Employees of Asociacion Puertorriquenos En Marcha, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan qualifying under Section 403(b) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established on July 1, 2006 for the purpose of providing eligible employees of Asociacion Puertorriquenos En Marcha, Inc. ("APM" or the "Employer") and their beneficiaries funds for retirement. The Board of Trustees is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### **Eligibility**

All employees, except for non-resident aliens and employees who normally work less than 20 hours per week, are eligible to participate in the Plan. Eligible employees can make elective deferrals to the Plan beginning on the first day of the month following their date of hire. Employees are eligible to participate in Employer matching and base contributions once they have reached age 18 and completed three months of service, as defined by the Plan document. The entry date for employer contributions is defined as the first day of the month following the date the employee satisfies the Plan's eligibility requirements. Employees who are covered by a collective bargaining agreement are not eligible for Employer contributions.

##### **Employee Contributions**

A participant of the Plan may make before-tax or after-tax (Roth) contributions to the Plan through payroll deductions of any whole percentage up to 100% of eligible compensation, as defined, up to the limit prescribed by the IRC . Any participant, age 50 or over, may make an additional "catch up" contribution as determined by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. A participant may suspend contributions at any time, or may increase or decrease their level of participation at any time during the Plan year.

Participants who do not opt-out of automatic enrollment are automatically enrolled to make before-tax 401(k) contributions equal to 1% of eligible compensation. Automatic escalation provisions apply to participants enrolled via automatic enrollment at a rate of 1% at the beginning of each Plan year to a 3% maximum contribution.

##### **Employer Contributions**

The Plan allows the Employer to make matching and base contributions to eligible employees, as defined by the Plan Document. The Employer matching contribution is equal to 100% of the employee's deferral up to 3% of eligible compensation. The Employer base contribution is a percentage of employee's eligible compensation determined by the Employer each Plan year. For the Plan year ended June 30, 2024, the Employer determined the employer base contribution is equal to 4% of employees' eligible compensation.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Employer contributions and an allocation of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant is 25% percent vested after one years of credited service and continues to vest in increments of 25% percent until 100 percent vested after four years of credited service.

#### **Payment of Benefits**

During employment, a participant may make withdrawals of vested amounts upon retirement, death, disability, separation from service, attainment of age 59½, or hardship. Prior to age 59½, hardship withdrawals may be requested for immediate and heavy financial need, including costs associated with medical expenses, purchase of a principal residence (excluding mortgage payments), post-secondary education, payments to prevent eviction or foreclosure from a principal residence, burial or funeral expenses, payments for repairs of damage to a principal residence or payments of federal, state, or local income taxes, and penalties reasonably anticipated to result from a hardship distribution. Upon termination of employment, and upon request, a participant's vested interest in his or her account can be distributed in the form of (i) a lump-sum payment, (ii) annuity contracts, or (iii) installment payments. A lump-sum payment is distributed if the vested interest is \$5,000 or less. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of a lump sum cash payment. In addition, the Plan allows for age 59 1/2 and hardship distributions if certain criteria are met.

#### **Forfeited Accounts**

Forfeitures of nonvested Employer contributions are allocated to the forfeiture subaccount to offset Plan fees and future Employer contributions. As of June 30, 2024 and 2023, \$13,249 and \$4,662, respectively, was available from the forfeiture account. For the year ended June 30, 2024, Employer contributions and/or qualified Plan expenses were reduced by \$143,154 from forfeited nonvested accounts.

#### **Notes Receivable from Participants**

The Plan allows for loans to be extended to participants for financial hardships or financial needs. All loans are considered a direct investment of the participant, and payments of principal and interest are credited to the participant's account. Participants may borrow 50% of their vested account balance not to exceed \$50,000 with a minimum borrowing of \$1,000. Interest is charged at current rates as determined on the date the loan is issued (as defined in the Plan agreement). Such interest rates ranged from 2.80% to 4.20% for loans outstanding as of June 30, 2023 and matured and or were distributed during 2024. Restrictions and repayment terms are described in the Plan document but not to exceed 5 years, generally. Principal and interest are paid by the participant through payroll withholdings and based on an amortization schedule, term of the loan and the applicable interest rate of the loan. There were no outstanding loans at June 30, 2024.

#### **Plan Loans**

Participants may borrow directly from the custodian, subject to certain limitations, by using a portion of their Plan account as security for the Plan loan. These loans do not occur directly within a participant's account but rather through a designated custodian account. Outstanding loan balances were \$150,403 and \$108,287 at June 30, 2024 and 2023, respectively, and are not reported within the accompanying financial statements of the Plan but serve as collateral against the outstanding plan loan balances. Interest on these loans is paid directly to the custodian.

## **2. Summary of Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments, except for fully benefit-responsive investment contracts, are reported at fair value or net asset value ("NAV"), which approximates fair value. Fully benefit-responsive investment contracts are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Cash Equivalent in General Account**

The Plan has a cash equivalent which is an investment in the Mutual of America General Account. The General Account is comparable to a cash equivalent for the following reasons:

- There are no front or back-end charges, completely liquid.
- The interest rate credited to investments in the General Account is a current rate and is not dependent upon the length of time the assets are invested with the custodian.
- Requests for withdrawal can be made at any time and are processed on the day that they are received; they are not dependent on the organization having to liquidate securities in order to generate payment.
- The value shown on the pension fund report is the redeemable value of the fund; there are no deferred sale charges, load assessments, or interest rate adjustments that would affect the value as a result of a withdrawal request.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments and are not readily determinable.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

The Plan's management evaluated events that occurred after June 30, 2024 through June 16, 2025, the date when the financial statements were available to be issued.

**3. Information Certified by Trustees**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Voya Retirement Insurance & Annuity Co. and Mutual of America Life Insurance Company, the Trustees of the Plan, have certified the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of June 30, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended June 30, 2024.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of June 30, 2024 and 2023.

*Registered Investment Companies:* Valued based on the quoted market prices that are available on an active market. The registered investment companies are priced daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date.

There were no transfers between asset levels during the reporting periods presented.

**5. Fully Benefit-Responsive Investment Contracts**

The Plan held a fully benefit-responsive investment contract with Voya. The insurance company maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the statement of changes in net assets available for benefits at contract value as reported to the Plan by the insurance company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Certain events limit the Plan's ability to transact at contract value with Voya. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan; or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The fully benefit-responsive investment contracts were liquidated during the plan year ended June 30, 2024.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**7. Tax Status**

Currently, 403(b) plans are not required to submit plans to the IRS for determination. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and ERISA.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. In addition, there have been no tax related interest or penalties for the periods presented in these financial statements.

**8. Related-Party and Party-in-Interest Transactions**

The group fixed annuity contract and certain registered investment companies are managed by Voya or Mutual of America, the Trustees. These transactions qualify as party-in-interest transactions. In addition, certain fees charged directly or indirectly by this party-in-interest have been netted with appreciation of such investments.

**9. Delayed Deposits of Participant Contributions**

U.S. Department of Labor regulations require that employee contributions to a retirement plan that are withheld from employees' paychecks must be deposited into the Plan as soon as they can be reasonably segregated from the employer's general assets.

For the year ended June 30, 2024, the Employer delayed making certain deposits of employee withholdings as soon as they could be reasonably segregated. Such delayed deposits totaled approximately \$33,900. Management will take corrective action relating to the delayed deposits which consists of calculating and restoring lost earnings to affected participants' accounts. Such lost earnings relating to these delayed deposits, are immaterial to the financial statements as a whole.
