**Note 1. Plan Description**

The following description of The Engineered Precision Casting Company Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information. The Plan was established on December 15, 1964. The Plan is a noncontributory defined benefit plan covering substantially all employees of The Engineered Precision Casting Company (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

***Eligibility***

All full-time employees of the Company are eligible to enter the Plan after completing one year of service, as defined.

***Pension Benefits***

Employees with five or more years of service are entitled to annual pension benefits beginning at normal retirement age (65). For participants who retired prior to January 1, 2018, the annual retirement benefit is equal to the larger of \$180 or 37% of Average Final Compensation (as defined), multiplied by the ratio of service (with a maximum of 25 years). For participants who retire after January 1, 2018, the annual retirement benefit is equal to the larger of \$180 or 38% of Average Final Compensation (as defined), multiplied by the ratio of service (with a maximum of 25 years). Effective January 1, 2018, each member whose retirement income commenced on or before January 1, 2018 had a 2.7027% increase in their retirement income. The Plan permits early retirement at ages 55 to 64 with five or more years of service, at a reduced benefit amount determined by the Plan document. The benefits for any member who terminates shall never be less than the actuarial equivalent of his or her allocated credit.

Benefits can be paid as a lump sum payment or in various forms of annuity payments.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts of assets, liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated Plan benefits at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Plan investments are reflected in the accompanying statements of net assets available for benefits at fair value as determined by management. The sales and purchases of investment securities, and gains and losses on the sale of investments, are recognized at the trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

The Plan records benefits when paid.

**Administrative Expenses**

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Fair Value Measurements**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

Money market funds: Valued at cost plus accrued interest which approximates fair value.

Exchange traded funds: Stated at fair value based on quoted prices in an active market for each share held by the fund.

Mutual funds: Valued based on the quoted prices in an active market for each share held by the funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Actuarial Present Value of Accumulated Plan Benefits**

Accumulated Plan benefits are those future periodic payments that are attributable under the Plan's provisions to the service employees have rendered. Accumulated Plan benefits include benefits expected to be paid to: (a) retired employees or their beneficiaries; (b) present employees or their beneficiaries; and (c) terminated vested Plan members.

The actuarial present value of accumulated plan benefits is determined by an actuary from CSB Associates and it is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as for death, disability, or retirement) between the valuation date and the expected date of payment. The Plan uses an end-of-year valuation date.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits. The computations of the actuarial present value of accumulated Plan benefits were made as of December 1, 2024 and 2023. Had the valuations been performed as of November 30, there would be no material differences.

**Note 5. Funding Policy**

The Company's funding policy is to make annual contributions to the Plan based upon normal cost and the unfunded actuarial accrued liability such that all employees' benefits will be fully provided for by the time they retire. No contribution was required to be made for the years ended November 30, 2024 and 2023 because the full funding limitation under ERISA had been met. Any amounts contributed to the Plan in excess of ERISA minimum funding requirements are reflected as Plan contributions in the year paid.

**Note 6. Related-Party Transactions**

Custodian and professional fees are paid by the Company, but in the event that the Company does not pay such expenses, they shall be paid by the Plan in accordance with the Plan's provisions. Custodian fees paid by the Plan to Bank of America, N.A. are considered party-in-interest transactions. Custodian fees paid by the Plan to Bank of America, N.A. amounted to \$63,773 for the year ended November 30, 2024. Professional fees paid by the Plan to Forvis Mazars, LLP, CSB Associates, and Pension Benefit Guaranty Corporation (PBGC) are considered party-in-interest transactions and amounted to \$31,200, \$22,500, and \$13,272, respectively, for the year ended November 30, 2024.

The Company provides certain administrative services at no cost to the Plan.

**Note 7. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

In the event the Plan terminates, the net assets of the Plan will be distributed to the employees based on priorities established in the Plan and by ERISA. Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. In addition, there is a statutory ceiling on the amount of an individual's monthly benefit that the PBGC guarantees, which is adjusted periodically. Vested benefits under the Plan are guaranteed at the PBGC level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits and may also depend on the level of benefits guaranteed by the PBGC.

**Note 8. Investment Information Certified by the Plan's Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Bank of America, N.A., a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA required supplemental schedules is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of November 30, 2024 and 2023
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended November 30, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of November 30, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

**Note 9. Concentrations**

At November 30, 2024 and 2023, three mutual fund investments accounted for approximately 35% of total investments.

**Note 10. Tax Status**

The Plan obtained its latest determination letter on March 25, 2011, in which the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 11. Risks and Uncertainties**

The Plan invests in various funds that invest in marketable equity securities. The investments are exposed to various risks, such as market risks. Due to the level of risk associated with certain equity securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions, in the near term, could materially affect participants' account balances and the value of investments reported in the financial statements.

Plan contributions are made and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**Note 12. Subsequent Events**

The Company has evaluated subsequent events for the Plan through July 14, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

**Schedule SB Part V Summary of Plan Provisions as of December 1, 2023**

- A. **EFFECTIVE DATE** - December 15, 1964. The Plan was restated on December 15, 1974 and was last amended effective January 1, 2018.
- B. **ELIGIBILITY** - One year of service. Prior Plan members were automatically eligible as of the effective date.
- C. **NORMAL RETIREMENT** - Age 65. Annual pension is the larger of \$180 or 38% of AFC multiplied by the ratio of service (with a maximum of 25 years) to 25. AFC is the average annual basic compensation during the 60 consecutive months within the last 120 months of service which produces the highest average. Members who postpone retirement beyond age 65 will receive an annual pension, as described above, based on AFC and service at their actual retirement date.
- D. **EARLY RETIREMENT** - Age 55 with 10 years service. The benefit is the accrued benefit deferred to age 65 or reduced 5/9% for each of the first 60 months and 5/18% for each additional month by which the starting date precedes age 65.
- E. **DISABILITY** - Anytime, provided receiving Social Security disability benefits. Member continues to accrue benefits until age 65 based on the annual rate of compensation received at the time of disablement.
- F. **TERMINATION** - 100% vested right after 5 years of service with accrued benefit deferred to age 65 or reduced (as described in D above) if payments begin after age 55 but before age 65. The benefits for any member who terminates shall never be less than the actuarial equivalent of his allocated credit.

**G. DEATH BENEFITS -**

- (i) *Before Retirement* - If the participant has a vested right but has not attained age 55, the spouse receives pension for life commencing at the employee's 55th birthday equal to one-half the amount the participant would have received if he terminated on his date of death, survived until age 55, retired at age 55 with the joint and 50% survivor option in effect. If the participant has attained age 55, the spouse receives a pension for life equal to one-half the amount the participant would have received if he retired early on his date of death and elected a joint and 50% survivor option.
- (ii) *After Retirement* - Normal form is 10 years certain, but if the employee has a spouse, this standard benefit is automatically converted to a reduced joint and 50% survivor option unless the employee elects not to have such conversion take place.
