INDEPENDENT AUDITORS' REPORT

To the Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of F.B. Purnell Sausage Co., Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Note 1 – Description of Plan

The following description of the F.B. Purnell Sausage Co., Inc (Company) 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan provisions.

General

The Plan is a defined contribution plan, established July 1, 1979, covering all employees of F. B. Purnell Sausage Co., Inc. (the "Company") who are age twenty-one or older and have completed one year of service in which the employee worked 1,000 hours or more. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the named sponsor and administrator of the Plan as defined by ERISA, and Reliance Trust Company is the Plan's trustee and holds all of the assets of the Plan.

Contributions

Employees who are eligible to participate may elect to contribute up to 75% of their compensation to the Plan, subject to Internal Revenue Code annual limitations. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company can match participants' contributions as a percentage of their elective deferrals and can make additional contributions based on their compensation. For the fiscal year ended September 30, 2024, the Company made quarterly matching contributions of 50% of participants' elective deferrals or portions thereof that did not exceed 3% of compensation. The Company made no other contributions in the fiscal year.

Participant Accounts

In addition to the participant's own pre-tax contributions, each participant's account is credited with an allocation of (a) the Company's contribution, and (b) Plan earnings (losses). Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the participant's vested account balance.

Vesting

Participants are immediately fully vested in their contributions plus actual earnings thereon. For contributions made by the Company, the Plan uses a six-year graded vesting schedule in which participants become 20% vested with their second plan year of service, as defined, and receive an additional 20% of vesting for each credited plan year thereafter until 100% vested with the sixth year.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The maximum loan term is five years unless the loan is used to purchase a participant's principal residence. The loans are secured by the balance in the participant's account and bear interest at the applicable rate as of the note origination date. The interest rates range from 4.25% to 9.50%. Loan rates are equal to the prime rate as published in the Wall Street Journal, plus one percent, at the loan origination date. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service, a participant is eligible to receive a lump-sum amount equal to the vested value of his or her account. Certain in-service withdrawals, including hardship withdrawals, are permissible subject to Plan provisions.

Forfeited Accounts

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$10 for each year. During 2024, forfeitures of \$1,327 were used to reduce employer contributions.

Note 2 – Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. The net appreciation in the fair value of investments includes realized and unrealized gains and losses on the fair value of investments held by the Plan. Purchases and sales of investments are recorded on a settlement date basis. Interest income is accrued as it is earned, and dividends are recorded as of the ex-dividend date. The Plan's interest in the collective trust is valued based on the fair value of the collective trust's underlying investments.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded as earned. No allowance for credit losses was recorded at September 30, 2024 and 2023, as repayments of principal and interest are received through payroll reductions, and the notes are secured by the participants' account balances.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Fees related to participant withdrawals/distributions and loans are charged directly to participants' accounts and are included in administrative expenses.

Payment of Benefits

Benefits are recorded when paid.

Note 3 – Related-Party Transactions and Party In Interest Transactions

Administrative fees related to the Trustee's administration of the Plan are paid by the Plan. Other administrative fees are paid by the Plan sponsor on behalf of the Plan. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 4 – Plan Termination

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note 5 – Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Note 5 – Fair Value Measurements (Continued)

The three levels of the fair value hierarchy under relevant accounting standards are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- i. Quoted prices for similar assets or liabilities in active markets;
- ii. Quoted prices for identical or similar assets or liabilities in inactive markets;
- iii. Inputs other than quoted prices that are observable for the asset or liability;
- iv. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust: Consists of the Invesco Stable Asset Fund ("Fund"), which is considered a stable value fund with underlying investments in insurance contracts. The Fund is valued using NAV based on the fair value of the underlying investments. The beneficial interest of each investor is represented in units. Units are issued and redeemed daily at the Fund's closing NAV. The primary investment objective of the Fund is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity.

It was determined that as a practical expedient, NAV per share is permitted by ASC 820 to estimate the fair value of an investment as long as the investment does not already have a readily determinable fair value (i.e. it's available on a domestic stock exchange or is a mutual fund with a published price), it's calculated in a manner consistent with the measurement principles of investment company reporting as of the reporting entity's measurement date and there are no plans to redeem the investments at amounts different from NAV.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Tax Status

The Internal Revenue Service issued an opinion letter, dated October 6, 2020, for the prototype plan stating that the form of the prototype plan is acceptable under Section 401 of the Internal Revenue Service Code (the "Code") for use by employers for the benefit of their employees. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code, and therefore believes that the Plan is qualified and the related trust is tax exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan provides for various investment options in any combination of registered investment companies and a collective trust fund. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Note 8 – Custodial Certification
