### **Note 1. Description of Plan**

The Ashley Industrial Molding Inc. 401(k) Plan (the "Plan") is a defined contribution plan, which covers substantially all employees, excluding leased employees, of Ashley Industrial Molding Inc. (the "Company"), who have completed 90 days of service as defined by the Plan and have attained age 18. The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information.

#### Participant Contributions:

Participants may make pre-tax contributions to their individual accounts each Plan year up to 100% of their compensation not to exceed the maximum permitted under the Internal Revenue Code. The Plan also allows catch-up elective deferral contributions for those participants who have attained age 50 by the close of the Plan year. Participants may enter the Plan immediately after obtaining the eligibility requirements, and may change the amount of their contribution each pay period.

#### Automatic Enrollment:

Once eligibility requirements are met, employees are automatically enrolled in the Plan at a contribution rate of 3%. An employee can elect not to participate in the Plan or select his or her own contribution percentage.

#### Company Contributions:

The Plan provides for a safe harbor Company match which requires the Company to make matching contributions in an amount equal to the sum of 100% of each participant's elective deferrals that do not exceed 3% of each participant's compensation, plus 50% of each participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 6% of the participant's compensation. In addition, the Company may, at its discretion, make other matching and profit sharing contributions to the Plan in an amount determined by the Company's management. No discretionary matching or profit sharing contributions were made for the year ended December 31, 2024.

#### Participants' Accounts:

Each participant's account is credited with participant contributions, Company contributions, and Plan earnings, and charged with administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment Options:

Participants have the option of investing in a variety of investment options offered through John Hancock Life Insurance Company, the recordkeeper of the Plan. All amounts in participant accounts are participant-directed.

### **Note 1. Description of Plan (Continued)**

#### Vesting:

Participants are immediately vested in their contributions and safe harbor Company match plus actual earnings thereon. Participants begin vesting in any Company discretionary matching and profit sharing contributions plus earnings thereon based on years of continuous service. Participants are 25% vested after one year of service, increasing 25% each year until fully vested in all Company discretionary matching and profit sharing contributions.

#### Forfeitures:

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their Company discretionary profit sharing contributions. These forfeitures are used to reduce future Company contributions. For the year ended December 31, 2024, there were no forfeitures used to reduce Company contributions. The amount of forfeitures held at December 31, 2024 and 2023, was \$5,579 and \$0, respectively.

#### Notes Receivable from Participants:

The Plan allows participants to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable are to be repaid in five years or less unless the note is for the purchase of a principal residence, in which case the term may be longer. The loans are secured by the balance in the participant's account and bear interest at a fixed rate equal to the prime rate plus 3% at the time of origination. The loan plus interest must be repaid to the participant's account based upon terms of the loan agreement. Principal and interest is paid ratably through regular payroll deductions. The balance of the loan becomes due upon termination of employment of the participant. Loans outstanding at December 31, 2024, mature through June 2046, and bear interest at rates ranging from 6.25% to 11.50%.

#### Payment of Benefits:

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount, rollover into another qualified plan or remain in the Plan as an inactive participant. If the balance in the participant's account is under \$5,000, the balance will automatically be distributed.

Hardship withdrawals are also allowed from the pre-tax elective deferrals of a participant's account with certain restrictions, as outlined in the Plan document.

#### Termination:

Although the Company has not expressed any intent to terminate the Plan, it has the right to do so at any time, subject to the provision set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

### **Note 2. Significant Accounting Policies**

#### Basis of Financial Statements:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Collective investment trusts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive stable value funds because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. However, these funds qualify for measuring fair value using the net asset value ("NAV") practical expedient. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund.

#### Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Gains and losses realized upon the sale of a security are calculated by using the average-cost method. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants:

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the loan will be deemed distributed and the loan balance will become taxable to the participant.

#### Payment of Benefits:

Benefit payments to participants are recorded when paid.

#### Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events:

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through June 24, 2025, the date the financial statements were available to be issued.

### **Note 3. Information Certified by the Plan's Recordkeeper**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the recordkeeper, John Hancock Life Insurance Company, and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Total investments as shown in the accompanying statements of net assets available for benefits.
- b. Net realized and unrealized appreciation in fair value of investments, as shown in the accompanying statement of changes in net assets available for benefits.
- c. Schedule of assets (held at end of year).

### **Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Collective investment trusts:* Composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities' liquidations will be carried out in an orderly business manner.

*Pooled separate accounts ("PSA"):* Valued at NAV at the end of the Plan year. PSA's are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate and mutual funds. The NAV is based on the value of the underlying assets owned by the PSA, minus any liabilities, and then divided by the number of shares outstanding. The NAV of a PSA is not a publicly quoted price in an active market, therefore, the NAV is used as a practical expedient to estimate fair value. The Plan's PSA investments have a daily redemption frequency, do not require a redemption notice period, and have no unfunded commitments as of December 31, 2024 and 2023, respectively.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5. Transactions With Parties-in-Interest

The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation. Administrative expenses for legal, accounting, and other services are rendered by parties-in-interest and are paid by the Company.

### Note 6. Income Tax Status

The Plan, which is a prototype plan, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan as then designed, was in compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code (IRC) and therefore, not subject to tax. The Plan has been amended since this date; however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRC. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### Note 7. Risks and Uncertainties

The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.
