Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mengel, Metzger, Barr & Co. LLP Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

1. Description of Plan:

The following description of Mengel, Metzger, Barr & Co. LLP Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering essentially all employees of Mengel, Metzger, Barr & Co. LLP (the Partnership) who have attained the age of 21 years and been employed by the Partnership for more than 3 months. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each year, participants may contribute a percentage of either pre-tax or post-tax annual compensation, as defined in the Plan. Additionally, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Partnership makes a 3% safe-harbor contribution and an annual discretionary profit-sharing contribution of a percentage (depending on participant group, as defined in the Plan) of all qualifying employees' compensation to the Plan, regardless of the employee's contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Partnership's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions and safe-harbor contributions, plus actual earnings thereon. Vesting in the Partnership's profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. The Partnership's profit-sharing contributions vest over a six-year period.

Investment Options:

A participant may direct contributions into a variety of investments offered by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (Empower), some of which are proprietary in nature.

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from 1 year to 5 years. Loans for purposes of purchasing a primary residence may be repaid over 30 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the local bank prime rate. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum distribution, annual installments, or annuity options equal to the value of the participant's vested interest in his or her account. The Plan allows for in-service withdrawals for active employees that have reached normal retirement age, as defined by the Plan. Additionally, hardship distributions are permitted if certain criteria are met.

Forfeitures:

At September 30, 2024 and 2023, forfeited non-vested accounts totaled \$22,366 and \$18,157. These amounts are used to reduce future employer contributions. The Plan used \$15,127 of forfeitures during 2024 to reduce employer contributions.

2. Summary of Significant Accounting Policies:

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value (except for the guaranteed investment annuity contract, which is reported at contract value). Inputs to the valuation methodology for mutual funds and the money market fund are unadjusted quoted prices for identical assets in active markets. The common collective trust is valued based on the net asset value per share without further adjustment, as a practical expedient to determine fair value. Net asset value is based on the aggregate fair values of the underlying investments. Participants may redeem shares at net asset value daily, without restriction.

The Plan maintains a fully benefit responsive guaranteed investment annuity, which is stated at contract value. Contract value, as reported to the Plan by MassMutual without further adjustment, represents contributions made, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The insurance company may not terminate the contract at any amount less than contract value and is contractually obligated to pay the principal and specified guaranteed interest rate. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code, (2) complete or partial termination of the Plan, (3) any change in law, regulation, or administrative ruling applicable to the Plan that could have a material adverse effect on a portfolio's cash flow, (4) any communication given to participants not to invest in a portfolio or to transfer assets out of a portfolio, or (5) premature termination of the contract. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation on investments is charged or credited to the net assets of the Plan.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits:

Benefits are recorded when paid.

Tax Status:

The IRS has issued a favorable opinion letter on the tax-exempt status of the Plan. Accordingly, no provision has been made for income taxes.

Subsequent Events:

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through July 11, 2025 (the date the financial statements were available to be issued).

Administrative Expenses:

Certain administrative expenses of the Plan are borne by the Partnership.

3. Financial Information Certified by the Trustees (Unaudited):

In accordance with Department of Labor Regulation 2520.103-8, the plan administrator has obtained certified "Statements of Account" from Empower as of September 30, 2024 and 2023, and for the year ended September 30, 2024, that the information below is complete and accurate:

- Statements of Net Assets Available for Benefits – investments and notes receivable from participants.
- Statement of Changes in Net Assets Available for Benefits – investment income.
- Schedule of Assets (Held at End of Year) – all items and amounts.

4. Plan Termination:

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

5. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
