Opinion

We have audited the financial statements of ACRT Services, Inc. Employee Stock Ownership Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

ACRT Services, Inc. Employee Stock Ownership Plan

1 Description of Plan

The following description of ACRT Services, Inc. Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan operates, in relevant part, as an employee stock ownership plan (“ESOP”) and is designed to comply with Section 4975 E(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (“IRC”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is administered by a Retirement Plan Committee (the “Administrative Committee”) comprised of five or more individuals appointed by the ACRT Services, Inc. and Subsidiaries Board of Directors. The Plan is a noncontributory defined contribution plan, the assets of which are primarily invested in common stock of ACRT Services, Inc. and Subsidiaries (the “Company”). The Plan’s Trustee is GreatBanc. The Plan was restated on January 1, 2019 to reflect all prior amendments.

During plan year ended September 30, 2003, the trust received financing through ACRT, Inc. and Subsidiary in the form of two notes payable in order to purchase the remaining 43,499 of the 64,767 total shares of ACRT, Inc. and Subsidiary stock, and therefore, the trust owns 100% of ACRT, Inc. and Subsidiary stock. The loans were repaid in full during year ended September 30, 2018 and all shares were allocated during the year ended September 30, 2018.

Effective October 1, 2021, the Plan was amended to change to the compensation limit for eligible employees. Effective December 21, 2021, EnviroScience, Inc. became a participating affiliated company in the Plan.

Eligibility:

All employees of the Company, except for union and leased employees, age twenty-one and older and who have completed 1,000 hours of service are eligible to participate in the Plan.

Contributions:

The Plan is funded solely by the Company’s contribution to the Plan as determined by the Company’s Board of Directors. A participant will share in Company contributions if they are employed in the plan on the last day of the Plan year and have 1,000 hours of service during the Plan year. A participant need not be employed on the last day of the Plan year to share in the Company contribution if certain qualifications are met.

The Company’s contributions, if any, may be made in cash or common stock of the Company, or both. The Company did not record a stock or cash contribution for Plan year ending September 30, 2024. The Company recorded a stock (3,096.0000 shares) and cash contribution for Plan year ending September 30, 2023. The contribution was allocated based on the ratio of the employee’s compensation during the contribution period to the total compensation of all eligible employees during that period.

NOTES TO FINANCIAL STATEMENTS

ACRT Services, Inc. Employee Stock Ownership Plan

1 Description of Plan, Continued

Participants' Account:

Each participant's account is credited with the participant's allocation of (a) the Company's contributions, (b) the Plan's earnings and losses, (c) forfeitures and (d) S Corporation distributions. Allocations of these items are based on a specified allocation schedule defined in the Plan document.

Vesting:

Vesting in the participant's account balance is based on years of service. A participant is vested as follows:

Years of Service	Vested %
Less than 2	0%
2	40%
3	60%
4	80%
5 or more	100%

Participants who reach normal retirement age (65), regardless of service, become disabled or die while employed, become 100% vested in their account balance.

Forfeitures:

Forfeitures due to termination from the Plan before a participant is 100% vested shall be allocated to remaining participants in the same manner as the employer's contribution after a five-year break in service period. Effective January 1, 2020, non-vested portions of participants' accounts will be forfeited upon distribution or a five-year break in service. Forfeitures for the years ended September 30, 2024 and 2023 allocated to eligible participants were 403 shares and 463 shares, respectively.

Payment of Benefits:

Upon termination of service by reason of retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account. The amount to be distributed is based upon the immediately preceding valuation date. Prior to September 30, 2023, participants with a vested balance have the option to be paid in cash or rollover the balance to another qualified plan. Effective September 30, 2023, all distributions arising from a Participant's termination of employment for any reason other than death or disability shall be distributed in substantially equal payments over a five-year period. Prior to September 30, 2023, if the participant's account balance is less than \$5,000, the Plan may make an automatic lump-sum distribution to the participant equal to the participant's vested interest in his or her account. Effective September 30, 2023, if the participant's account balance is less than \$7,000, the Plan may make an automatic lump-sum distribution to the participant equal to the participant's vested interest in his or her account. If the participant's vested account balance exceeds \$1,000 and the participant has not elected to roll over the distribution to another retirement plan or receive the distribution directly, the distribution will be made as a rollover to an individual retirement plan designated by the Company.

1 Description of Plan, Continued

Payment of Benefits, Continued:

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations. For the years ended September 30, 2024 and 2023, the Plan distributed 5,281 and 4,293 shares, respectively. For the years ended September 30, 2024 and 2023, the Company repurchased 0 and 4,293 shares from participants at the greater of the current appraised value or the floor price, respectively.

Benefits are recorded when paid.

Diversification:

Participants who are at least 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify can receive a cash distribution or roll over amounts into alternative investments under the Plan or in another qualified plan sponsored by the Company.

Put Option:

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Company common stock is valued by an independent third-party appraiser.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

2 Summary of Significant Accounting Policies, Continued

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees:

Substantially all administrative fees are paid by the Company.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Risks and Uncertainties:

The Plan's investments include mutual funds and Company stock. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through July 11, 2025, which is the date the financial statements were available to be issued.

3 Tax Status

On September 25, 2013 the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

3 Tax Status, Continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of September 30, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

4 Investment in Company Stock

Plan investments are carried at fair market value and consist of voting common stock. The fair market value per share of ACRT's Services stock, as determined by an independent appraiser, was \$933.85 and \$966.90 at September 30, 2024 and 2023, respectively.

5 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

5 Fair Value Measurements, Continued

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual Funds:

The fair value of the mutual funds are based on quoted market prices. The investment is classified as a Level 1 investment.

Common Stock:

The fair value of the employer's common stock is based on a valuation determined by an independent appraiser. These instruments are classified within Level 3 of the valuation hierarchy.

The fair value of the Sponsor Company common stock held by the plan is valued at fair value based upon an independent appraisal. This appraisal was based upon a discounted cash flow method consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparable, and fair value of Company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability. The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which Plan management, along with the ESOP Trustee, reviews in detail, discusses and approves. The results of this process are documented in minutes of the Plan fiduciary.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of September 30, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Transfers Between Levels:

For the years ended September 30, 2024 and 2023, there were no transfers in or out of Level 3.

For the year ended September 30, 2024, the Plan had purchases and sales of assets using significant unobservable inputs (level 3) of \$0 and \$5,106,593 respectively.

For the year ended September 30, 2023, the Plan had purchases and sales of assets using significant unobservable inputs (level 3) of \$3,755,912 and \$5,207,761 respectively.

6 Party-in-Interest Transactions

ACRT Services, Inc. stock is held by the ESOP and is a party-in-interest to the Plan. In addition, the Plan has arrangements with various service providers and these arrangements qualify as party-in-interest transactions.

7 Administration of Plan Assets

The Plan's assets consist of Company common shares and a mutual fund, which are held by the Trustee of the Plan.

The contributions are held and managed by the Trustee, which invests cash or stock received, interest, and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loan, which is reimbursed to the Trustee through contributions as determined by the Company.

Certain administrative functions are performed by officers of employees of the Company who make up the Administrative Committee. No such officer or employee received compensation from the Plan or Trust.

8 Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified the Trustee prior to the time that such rights are to be exercised.
