Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about PORT Health Services 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about PORT Health Services 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter- Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1, the Company entered into a combination agreement with another entity resulting in a decision to terminate the Plan effective June 30, 2024. Accordingly, the Plan is reported on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

1. Description of Plan

The following description of the PORT Health Services 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established September 1, 2004, and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covered all employees of PORT Health Services, (the "Company") who were age 21, except for leased employees, as defined by the plan.

On January 1, 2023, PORT Health Services and Easterseals UCP North Carolina & Virginia ("Easterseals") entered into a combination agreement to expand their continuum of services. This combination provides a broad and comprehensive range of Developmental Disabilities, Mental Health and Substance Use services. As part of the integration of PORT Health Services and Easterseals, the Company made the decision to terminate the Plan effective June 30, 2024. On July 1, 2024, employees became eligible for the Easterseals plan and could decide whether they would transfer their plan assets to that Plan. All plan assets were fully distributed by September 30, 2024.

Contributions

Prior to July 1, 2024, participants could contribute up to 90% of their annual compensation annually, as defined by the Plan, subject to the restrictions of the Internal Revenue Code. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company provided a safe-harbor matching contribution of 100% of participant's elective deferrals up to 3% and then 50% of participant's elective deferrals of the next 2% each payroll period. The Company could also make a discretionary non-elective contribution each year. To be eligible for the discretionary non-elective contributions, a participant must have been credited with 500 hours of service during the plan year if not employed on the last day of the plan year. No service requirement if a participant was employed on the last day of the plan year.

Participant Accounts

Each participant's account was credited with the participant's contributions, as well as allocations of plan earnings. Allocations were based upon participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered a collective investment trust fund and various registered investment funds as investment options.

Vesting

Participants were vested immediately in their elective deferral, rollover contributions, and employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's non-elective contribution portions of their accounts was based on years of continuous service. A participant vested 20% each year after two years of service and was 100% vested after six years of credited service for any discretionary nonelective contributions. All participants became 100% vested in their accounts as of June 30, 2024 as a result of the Plan termination.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants could have one outstanding loan, which was secured by the balance in the participant's account and bore interest at the prime rate plus 1%. Principal and interest was paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant could elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum, installment, or partial withdrawal. The Plan allowed for in-service distributions for participants who had reached age 59 ½. In addition, participants could request a hardship distribution if they experienced an immediate financial need, as defined by the Plan.

Forfeited Accounts

Forfeited accounts were used to reduce future administrative expenses or employer contributions. The Plan had no forfeited non-vested account balances at September 30, 2024 and June 30, 2024. No forfeitures were utilized during the Plan period.

2. Summary of Accounting Policies

Basis of Accounting

As the Plan has been terminated, these financial statements are prepared on the liquidation basis of accounting as of September 30, 2024 and June 30, 2024 and for the period from July 1, 2024 through September 30, 2024, due to the imminence of the termination. The change from accrual basis to liquidation basis did not have an impact to the financial statements.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed as they were incurred. No allowance for credit losses has been recorded as of September 30, 2024. If a participant ceased to make loan repayment and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded. During the plan year there were no new defaulted loans.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

The Plan's expenses were paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments.

3. Unaudited Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company ("Reliance") has certified that the following data included in the accompanying financial statements is complete and accurate.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at September 30, 2024 and June 30, 2024.

Registered Investment Funds: Valued at the daily closing price as reported by the fund. Registered investment funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment funds held by the Plan are deemed to be actively traded.

Collective Investment Trust Fund: The Morley Stable Value Fund is an investment fund offered by the Principal Global Investors Trust Company. The objective of the Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive payments. The Fund seeks to achieve this objective by investing primarily in a variety of high quality stable value investment contracts as well as cash and cash equivalents. Investments in contracts are presented at contract value, which represents invested principal plus accrued interest thereon and approximates fair value. The contracts are nontransferable but provide for benefit-responsive withdrawals and participant transfers to noncompeting options by plan participants at contract value. The fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Plan Termination

The Company's board resolved to terminate the Plan effective June 30, 2024. At that time, all participants became fully vested in any unvested accounts. The Plan is subject to the provisions of ERISA. All participant accounts were properly distributed to participants or rolled over by participant election to the Easterseals plan by September 30, 2024.

7. Tax Status

The Plan received an opinion letter dated October 6, 2020, that the Plan document was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan was periodically amended; however, the Plan Administrator and the Plan's management believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and therefore believed the Plan was qualified and the related trust was tax-exempt.

8. Risks and Uncertainties

The Plan invested in various investments. Investments were exposed to various risks such as interest rate, market, and credit volatility. Market risks included U.S. and global events that could impact the value of Plan investments. Such events could include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions.

9. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments were shares of registered investments and a collective investment trust fund managed by Reliance. Reliance was the trustee as defined by the Plan. ADP, Inc. ("ADP") served as the record keeper. The plan paid approximately \$20,897 in fees to these parties. These transactions qualify as exempt party-in-interest transactions.
