## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("U.S. GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedules, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended September 30, 2024, and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of September 30, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedules that is agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS

#### ( 1 ) Description of plan

The following description of Play & Learn Centers 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** - The Plan is a defined contribution plan sponsored by Learn & Play, Inc. d/b/a Play & Learn (the "Organization" or "plan sponsor") for the benefit of its employees. Effective January 1, 2024, the Plan was amended to allow all employees of the Organization, except nonresident aliens, to enroll on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - Participants may contribute a percentage of pre-tax or after-tax annual compensation, as defined in the Plan, up to the maximum amount permitted by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, participants aged 50 or older who are making contributions to the Plan are allowed to make catch-up contributions as defined in the Plan.

Prior to January 1, 2024, a participant who was at least twenty-one years of age and had completed three months of service was eligible for discretionary employer contributions. Effective January 1, 2024, the age requirement was removed. The Organization elected to contribute 50% of the first 6% of the compensation that a participant contributed to the Plan during the year ended September 30, 2024. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Participant investment account options** - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and a stable value fund as investment options for participants.

**Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of: (a) the Organization's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution, portion of their accounts is based on years of service, as defined. A participant becomes 100% cliff vested after three years of service or upon instances of death or disability.

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The notes receivable from participants are secured by the balance in the participants' accounts and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. As of September 30, 2024, the interest rates on outstanding loans ranged from 5.00% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### ( 1 ) Description of plan (continued)

**Payment of benefits** - Upon reaching retirement age, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his/her account or annual installments not to exceed the life expectancy of the participant or his/her beneficiary(ies). Upon termination of service, a participant or his/her beneficiary(ies) will receive a lump sum payment. Participants may also elect to receive a lump sum amount for qualifying hardship distributions. Participant balances under \$7,000 can be distributed without participant approval by the plan management. Effective January 1, 2024, in-service distributions are permitted for participants who have reached the age of 59 ½. Additionally, both hardship and in-service distributions from Roth elective deferrals are now allowed.

**Forfeited accounts** - These accounts can be used to pay Plan expenses and reduce future employer contributions. There were no forfeited nonvested accounts as of September 30, 2024 and 2023. During the year ended September 30, 2024, \$3,676 of forfeitures were used to reduce employer contributions.

#### ( 2 ) Summary of significant accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Organization are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** - Notes receivable from participants is measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expenses when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

**Excess contributions refundable** - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions as of September 30, 2024, in December 2024.

#### ( 2 ) Summary of significant accounting policies (continued)

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Organization and are not included in the statement of changes in net assets available for benefits. Administrative expenses include recordkeeping and investment management services. Investment-related expenses are included in net appreciation in fair value of investments.

#### ( 3 ) Information prepared and certified by the custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and notes receivable from participants on September 30, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income on notes receivable from participants for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company ("AUL"), the custodian of the Plan.

#### ( 4 ) Fair value measurements

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, "*Fair Value Measurements and Disclosures*," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**( 4 ) Fair value measurements (continued)**

As of September 30, 2024, and 2023, the Plan held no investments that were required to be classified by level within the fair value hierarchy. As of September 30, 2024, and 2023, the Plan's total investment in the pooled separate accounts valued at the NAV practical expedient was \$7,251,714 and \$5,710,007, respectively. As of September 30, 2024, and 2023, the Plan's total investment in the stable value fund valued at the NAV practical expedient was \$92,350 and \$95,260, respectively.

**( 5 ) Administrative expenses and party-in-interest transactions**

Expenses are paid by the Plan to AUL for investment management and recordkeeping services. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for recordkeeping services were \$492 for the year ended September 30, 2024. Fees paid by the Plan for investment purchases/sales transactions are included in net appreciation in fair value of investments.

**( 6 ) Plan termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Organization's contributions.

**( 8 ) Tax status**

The IRS has determined that the 403(b) Volume Submitter Plan, adopted by the Plan, is designed in accordance with applicable sections of the IRC and informed the custodian of such in a letter dated November 22, 2017. The plan administrator believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that "more likely than not" would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**( 9 ) Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**( 10 ) Subsequent events**

The Plan has evaluated subsequent events through July 14, 2025, which is the date the financial statements were available to be issued.

The investment options of the Plan include various portfolios within an AUL separate account. The separate account in turn invests in investment portfolios of certain open-end management investment companies. AUL receives indirect compensation from these investment companies for the services provided by AUL.

The compensation received by AUL is computed by each investment company by multiplying the daily account balance of the AUL separate account's interest in a particular portfolio by a predetermined percentage rate negotiated with the investment company. This indirect compensation is not charged to the plan or participants accounts but is paid directly by the investment company.
