## Independent Auditor's Report

**NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

1. Basis of Presentation

The accompanying financial statements of Engage Technologies Corporation 401(k) Savings Plan (the Plan) have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

2. Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date.

Purchases and sales of investments are reflected as of the trade date. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net change in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

3. Participant Direction of Investments

Subject to the provisions of the Plan, a participant has the right to direct the investments of the balance in their accounts in the specific investment funds made available by the Plan administrator. At September 30, 2024 and 2023 all investments are participant directed.

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. As of September 30, 2024 and 2023, no allowance for credit losses has been recorded.

5. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are reported as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contribution to the applicable participants on January 21st, 2025.

6. Payment of Benefits

Benefits are recorded when paid.

7. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE B - DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering substantially all employees of Engage Technologies Corporation (the Employer). Employees are eligible for participation on the first day of the month following attaining 21 years of age and completion of two months of service. An eligible employee may become a participant on the next entrance date, which is the first day of the month following the date the eligibility requirements are satisfied.

The Employer is responsible for appointing an administrator and trustee for the Plan. The trustee has discretionary powers in executing investment transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is responsible for investment management fees and costs of the Plan administration to the extent not paid by the Employer.

2. Contributions

The Plan allows participants to contribute up to 90% of annual eligible compensation, as defined by the Plan, subject to limits imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the IRC. Participants may also make rollover contributions from other qualified sources

All Employer contributions are determined at the discretion of the Employer. The Employer may make matching contributions, Employer discretionary profit sharing contributions, or qualified non-elective contributions to the Plan. Employer matching contributions, when made, will be made to all participants regardless of service and are based on a discretionary percentage of participant salary deferrals. For the year ended September 30, 2024, the Employer matched 25% of the employee deferral for the year, excluding catch-up contributions, with no maximum. The Employer made discretionary matching contributions totaling \$333,793 during the year ended September 30, 2024.

Employer discretionary profit sharing contributions are allocated to all participants based on the participant's compensation as compared to the total compensation of all participants. Qualified non-elective contributions may be allocated to all non-highly compensated employees in an amount to be determined by the Employer. To share in Employer discretionary profit sharing contributions and qualified non-elective contributions, the employee is required to be actively employed on the last day of the Plan year. In the year of death, disability or retirement, the employee will share in the Employer discretionary profit sharing contributions and qualified non-elective contributions for the year regardless of service. There were no Employer discretionary profit sharing contributions or qualified non-elective contributions for the year ended September 30, 2024.

3. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of September 30, 2024 and 2023.

4. Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Employer's matching contribution, (b) the Employer's discretionary profit sharing contribution, (c) the Employer's qualified non-elective contributions and (d) investment income (loss) net of administrative expenses. Allocations are based on participant compensation or account balances, as defined.

Changes in a participant's deferral percentage for future contributions may be made monthly during the Plan year. Reallocation of participant investment accounts among the investment options may be made at any time during the Plan year.

5. Vesting

Participants are immediately vested in their employee and the Employer's qualified non-elective contributions. Participants vest in all Employer matching contributions and Employer discretionary profit sharing contributions at the rate of 20% after one year of service, with an additional 20% per year being vested thereafter until the employee is 100% vested after five years of service, as defined by the Plan. Only whole years of service are calculated for vesting. The Employer may elect to make a special fully vested discretionary contribution to the Plan in lieu of or in addition to the regular discretionary contribution.

6. Payment of Benefits

Upon termination of service due to death, disability, retirement or termination of employment, a participant may receive a lump sum or installment payments equal to the participants vested account balance. Participants with balances of \$5,000 or less are subject to involuntary lump sum distributions.

7. Notes Receivable from Participants

Notes receivable from participants from a participant's vested balance are permitted up to the lesser of one-half of the vested balance or a maximum of \$50,000 for each participant. The minimum note amount is \$1,000. The notes shall bear a reasonable rate of interest, be adequately secured, and have a definite repayment schedule, with a maximum term of five years.

8. Advisory Fees

The Christianson Group has fiduciary responsibilities which were given from the management of the Plan sponsor. The fiduciary charges an advisory fee of .25% on the funds in the Plan. Payments are made from the participant accounts and paid quarterly.

9. Forfeited Accounts

Forfeited accounts are used to defray the cost of administrative expenses or reduce Employer contributions of the Plan. As of September 30, 2024 and 2023, the balance of unapplied forfeitures of non-vested accounts is approximately \$4,800 and \$10,800, respectively. Employer contributions paid from forfeitures totaled approximately \$10,000 for the year ended September 30, 2024.

10. Risks and Uncertainties

The Plan is comprised of investments in a combination of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net asset available for benefits.

**NOTE D – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Money market and mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE D – FAIR VALUE MEASUREMENTS – CONTINUED**

*Collective trust fund:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E – FEDERAL INCOME TAXES**

The plan was restated in 2020 to use a non-standardized pre-approved profit sharing plan of Fidelity Management & Research Co. (FMR, LLC). FMR, LLC obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust is tax-exempt as of the financial statement date. See Note I for reconciliation of financial statements to Form 5500 as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

**NOTE E – FEDERAL INCOME TAXES - CONTINUED**

The Plan's policy is to evaluate the likelihood that any uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence. The federal income tax returns of the Plan are subject to examination by the IRS, generally for three years after they were filed.

**NOTE F – PARTY IN INTEREST TRANSACTIONS**

Fidelity Management Trust Company (Fidelity) is the trustee of the Plan. Fidelity holds the Plan's investments and executes transactions. The Christenson Group is the Plan advisor and acts as the fiduciary to the Plan.

**NOTE G – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to reduce, suspend, or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE H – ADMINISTRATIVE EXPENSES**

The Plan pays administrative expenses that consist primarily of administrative fees to the trustee and advisory fees to the fiduciary. These expenses are reported on the statement of changes in net assets available for benefit as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Employer on behalf of the Plan.

**NOTE J - SECURE ACT 2.0**

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as "SECURE Act 2.0". SECURE Act 2.0 contains over 90 new retirement provisions continuing the reforms that began with the 2019 SECURE Act. These provisions have varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. There is no material impact to the Plan's 2024 financial statements.

**NOTE K - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through July 14, 2025, the date which the financial statements were available to be issued.

We have audited the financial statements of Engage Technologies Corporation 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) for the year ended September 30, 2024 and we will issue our report thereon dated July 14, 2025. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter dated May 19, 2025. Professional standards also require that we communicate to you the following information related to our audit.

#### Significant Audit Matters

##### *Qualitative Aspects of Accounting Practices*

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note A to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The financial statement disclosures are neutral, consistent, and clear.



*Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

*Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

*Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are clearly trivial and communicate them to the appropriate level of management. There were no misstatements identified as a result of audit procedures. The following misstatements detected as a result of audit procedures were corrected by management:

*Reportable Findings*

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:



### Compliance Testing Corrections

During our audit, we noted there are insufficient controls in place to ensure annual compliance testing is completed timely. We noted the audit year's compliance testing was not completed until after 2 months and 15 days after the plan year end. According to IRS regulation, excise taxes are owed on certain corrections made more than 2 months and 15 days after the plan year end, with the statutory correction period being 12 months after the plan year end. When annual compliance testing is not performed timely, the plan is put at risk for potential excise taxes if corrections are needed but were not corrected timely.

We recommend Plan management consult with its service providers to ensure no excise taxes are owed for previous late corrections. We also recommend Plan management implement policies and procedures to ensure instructions provided by the compliance testing preparer are followed in order to complete annual compliance testing and corrections, if any, in a timely manner.

### *Disagreements with Management*

For purposes of this letter, a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### *Other Matters*

With respect to the ERISA-required supplemental schedule accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedule to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

### Internal Control

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of the Plan as of and for the year ended September 30, 2024 in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.



We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Reliance Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified a deficiency in internal control that we consider to be a significant deficiency.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency or combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statement will not be prevented, or detected and corrected on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiency in the Plan's internal control to be a significant deficiency:

- The Plan's management is responsible for ensuring the financial statements are prepared in accordance with accounting principles generally accepted in the United States of America. Although the Plan's financial statements were prepared by the audit team, the audit team cannot be considered to be a part of the Plan's internal control, which includes preparing the Plan's financial statements. While it is simply not cost beneficial for the plan this size to recruit and retain personnel with sufficient experience and skill in accounting and financial reporting to adequately address these deficiencies in the internal control, you should be aware of this condition.



*Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention. The following matters were discussed with you:

- During the course of the audit, we found that the forfeitures balance had not been used by the end of the following year after the forfeitures are generated pursuant to Plan provisions. The Plan calls for forfeitures to be used to offset plan expenses or reduce employer contributions. We recommend that Plan management use the forfeitures in a timely manner.

This information is intended solely for the use of the Board of Directors and management of the Plan and is not intended to be, and should not be, used by anyone other than these specified parties.
