Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1: Description of Plan and Summary of Significant Accounting Policies

The following description of the Studio of Elegance, Inc. – Profit Sharing and 401(k) Plan (the Plan) provides only a general description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible full-time employees of Studio of Elegance, Inc. and its subsidiaries (the Company) who have completed one thousand (1,000) hours of service in any given year and are twenty or older. The Plan follows the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Plan's current custodian is John Hancock Retirement Plan Services. M2B Retirement Consulting, LLC administers the Plan on behalf of the Company.

Contributions

The Company's board of directors determines contributions to the Plan annually, and the Plan allocates the contribution to each eligible employee based upon that employee's eligible wages as defined by the plan agreement. The Company amended the Plan to include a 401(k) portion whereby participants may contribute a certain percentage of pretax annual compensation, as defined in the Plan. Participants who are at least 50 years old before the end of the plan year may make catch-up contributions. Participants direct the investment of their contributions into various investment options under an insurance investment contract maintained by the Plan. Certain regulatory requirements limit the amount of contributions.

Participant Accounts

The Plan credits each participant's account with his or her contribution, allocations of the Company's contribution, if any, the net earnings or loss of the Plan, and forfeitures of the nonvested account balances of terminated participants. Since participants direct their investments, the Plan segregates the participants' accounts for purposes of determining the earnings or loss on those investments. Individual accounts do not share in the investment performance of other participants who have directed their own investments. The Plan entitles a participant to a benefit that the Plan can provide from the participant's account.

Vesting

The Plan permits vesting in the Company's contributions and actual earnings thereon based on a participant's years of continuous service. A participant will become 100% vested in such contributions after six years of credited service, becoming totally and permanently disabled while an employee of the Company, or attaining normal retirement age while an employee of the Company. For plan years in which the Plan is considered to be a "top heavy plan" (as defined by the Internal Revenue Code), a participant, who has completed one hour of service, will vest in the Company's contributions and earnings thereon in accordance with the Plan's vesting schedule. For the plan years ended September 30, 2024 and 2023, the Plan was not a "top heavy plan."

Participants' contributions, including actual earnings thereon, are immediately vested.

Participant Loans

Participants may borrow from their accounts. The Plan permits loans to range from a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding balance of loans in the past twelve months, or one-half the present value of the participant's vested account balance. Interest rates range from 5.25% to 10.5%, which are commensurate with local prevailing rates, and their terms may not exceed five years except for the purchase of a principal residence. The maximum loan term for a principal residence loan is thirty years. The Company deducts loan payments, including interest, from a participant's salary or wages.

Benefits

A participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a fixed period of time when the participant terminates service with the Company because of death, disability, or retirement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Generally, the Plan records benefits when paid.

Forfeitures

Forfeitures represent the nonvested portion of a terminated participant's account and the balance remains in the Plan. The Company may add the forfeitures to any employer contribution, use them to reduce future employer contributions or use them to cover plan expenses. For the year ended September 30, 2024, forfeitures amounted to \$465. There were no forfeitures for the year ended September 30, 2023.

Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan values its investments at fair value. The Plan values shares of mutual funds at the quoted net asset value of shares held by the Plan at the period or year end. The Plan values participant loans at their outstanding balances, which approximate fair value.

The Plan records purchases and sales of securities on a trade-date basis and dividends on the ex-dividend date. The Plan's net appreciation or depreciation in investments includes realized gains and losses on investments bought and sold as well as held during the year. The Plan pays certain administrative costs, and the plan sponsor pays certain administrative costs.

Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of significant unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The Plan measures fair value generally using Level 1 inputs because they provide the most reliable evidence of fair value.

Subsequent Events

Management evaluated subsequent events through July 3, 2025, which is the date the financial statements were available to be issued.

Note 2: Investments

Approximately 85% of the Plan's investments are shares of mutual funds managed by John Hancock Life Insurance Company (John Hancock). John Hancock is the trustee of the Plan, and therefore, transactions in the mutual funds qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services in the years ended September 30, 2024 and 2023, amounted to \$26,453 and \$23,686, respectively. These party-in-interest transactions are exempt from prohibited transaction rules of ERISA.

Note 3: Participants' Loans

The Plan's assets include loans to participants as permitted by the Plan. As of September 30, 2024 and 2023, the outstanding balance of those loans amounted to \$18,387 and \$19,072, respectively.

Note 4: Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

Note 5: Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan follows the guidance of the Financial Accounting Standards Board Accounting Standards Codification topic on income taxes. No amounts have been recognized within the financial statements for taxes, interest, or penalties relating to uncertain tax positions. In addition, the Plan does not anticipate any changes to its tax positions within the next twelve months. In general, the Plan's tax positions for open tax years (fiscal years 2022 forward) remain subject to examination by the tax authorities in the jurisdiction in which the Plan operates.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities and money market funds. Various risks such as interest rate, market, and credit may affect the value of the investment securities. Money market balances may, at times, exceed the balance insured by the Federal Deposit

Insurance Corporation. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Note 7: Unaudited Information Certified by the Plan Trustee

The plan administrator prepared the 2024 and 2023 statements of assets available for benefits, the investment activities included on the 2024 and 2023 statements of changes in assets available for benefits, and the accompanying notes to the financial statements in part or entirely from information certified by the trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The trustee certified total investments of \$2,911,596 and \$2,406,377 as of September 30, 2024 and 2023, respectively, and related investment income of \$563,669 and \$272,555 for the years ended September 30, 2024 and 2023, respectively.
