Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of the Stryker Corporation 401(k) Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description available from the plan sponsor, Stryker Corporation (the Company), for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees, as defined, who have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Each year, participants may contribute up to 75% of compensation, as defined, on a pretax or Roth after-tax basis, not to exceed the maximum annual amount allowed by the Internal Revenue Code (the IRC). If automatically enrolled, a participant's deferral is set at 3% of eligible compensation until changed by the participant. Annually, in March or in a month of the participant's choosing, the participant's election will be automatically increased by 1% until 15% is attained. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company matches 50% of the first 8% of compensation that a participant contributes to the Plan. The matching contribution for the first 4% of compensation that a participant defers will be made in company common stock and may be reallocated by the participant into other investment fund options. Matching contributions of company common stock totaled \$71,464,294 in 2024. Cash contributions are invested in accordance with the participant's election and totaled \$54,063,172 in 2024. Additional amounts may be contributed to eligible non-sales representatives at the discretion of the Company. Discretionary contributions totaled \$179,934,012 in 2024.

Generally, participants must be credited with at least 1,000 hours of service during the year and be employed on the last day of the plan year to be eligible for matching and discretionary contributions.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and the Plan's earnings (losses) and is charged with an allocation of administrative expenses. Plan earnings (losses) are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings, is based on years of continuous service. A participant is gradually vested over a period of five years of credited service.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. Forfeited balances will be restored if the participant is rehired before incurring five consecutive vesting breaks in service and repays to the Plan the vested amount previously distributed within five years after being rehired. Forfeited balances of a terminated participant's non-vested accounts are used to reduce future company contributions or pay for certain plan expenses. Unallocated forfeiture balances as of December 31, 2024 and 2023, totaled \$12,617,423 and \$10,567,730, respectively. Unallocated forfeitures were used to reduce contributions made in 2024 and 2023 applicable to the prior year.

Investment Options

Upon enrollment in the Plan, a participant may direct employer and employee contributions in 1% increments in various investment options as provided under the Plan.

The Plan allows participants to elect to transfer amounts from the portion of their matching contribution accounts invested in the Stryker Corporation Stock Fund to other investment funds offered under the Plan. Transfers out of the Stryker Corporation Stock Fund may at a later date be transferred back into the Stryker Corporation Stock Fund.

1. Description of the Plan (continued)

Participant Loans

Participants may borrow from their salary deferral and rollover accounts a minimum of \$1,000 up to a maximum of the lesser of either \$50,000 or 50% of their vested account balance. Participants may elect a loan term up to a maximum of 54 months, and up to 174 months for a principal residence loan. The loans issued by the Plan are secured by the balance in the participant's account and bear interest at prime plus 1%. Interest rates on current participant notes receivable range from 4.25% to 9.50%. Principal and interest are paid through payroll deductions. A participant can only obtain one loan in any 12-month period and can only have one loan outstanding at any time. Loans are restricted to reasons of financial hardship, as defined by the Plan.

Hardship Withdrawals

Hardship withdrawals are available in limited instances from a participant's salary deferral and rollover accounts. Only one withdrawal may be taken during any 12-month period.

Payment of Benefits

On termination of service (including retirement), participants may receive their vested benefits in one of the following forms: a lump-sum payment; cash payments in roughly equal annual, quarterly, or monthly installments for a specific number of years, not to exceed life expectancy; or a combination of a lump-sum cash payment and cash payments in annual, quarterly, or monthly installments. Notwithstanding any other provision of the Plan, if a participant or beneficiary is eligible to request a distribution and the vested amount in the participant's account does not exceed \$5,000, the plan administrator shall distribute the vested amount to the participant or beneficiary in a lump-sum payment.

Upon the attainment of age 59½, participants may elect to withdraw all or a portion of their salary deferral and/or rollover accounts.

Acquisitions and Plan Mergers

During 2024, the Company completed six acquisitions, which resulted in three contribution plans being merged into the Plan. In conjunction with the acquisitions, acquired employees became eligible to participate in the Plan as of the dates listed below. The legacy defined contribution plans were merged into the Plan as listed below.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting. The preparation of financial statements in conformity with United States generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition

The Plan's investments, including those in the Stryker Corporation Master Trust (the Master Trust), are stated at fair value. Vanguard Fiduciary Trust Company is the Trustee and Northern Trust is the Custodian of certain investments. The Stryker Corporation Stock Fund is tracked on a unitized basis. The fund consists of Stryker Corporation common stock and funds held in a money market fund sufficient to meet the fund's daily cash needs and other miscellaneous assets and liabilities. Unitizing the fund allows for daily trades. The fair value of a unit is based on the combined fair value of Stryker Corporation common stock (closing price in an active market on which the securities are traded), the net asset value (NAV) of the money market fund, and other miscellaneous assets and liabilities held by the fund at year-end. Fair values of investments in mutual funds are based upon the last reported market value of the funds on the last business day of the plan year. The fair values of the participation units owned by the Plan in the common trust funds are based on the NAVs at year-end. The NAVs are based on the fair value of the underlying investments as determined by the fund sponsor. Common stock, American depositary receipts (ADRs), and real estate investment trusts are all exchange traded with readily determinable values.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The realized gain or loss on investments is the difference between the proceeds received and the average cost of investments sold. The realized gain or loss on investments, plus the annual change in the difference between fair value and the cost of investments, is reflected on the statement of changes in net assets available for benefits as a component of net appreciation in fair value of investments and as net investment gain from the Master Trust.

2. Summary of Significant Accounting Policies (continued)

Investment securities are generally exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

3. Investments

Certain investment information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, net investment gain from Stryker Corporation Master Trust, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee and Custodian.

4. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability

4. Fair Value Measurements (continued)

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

5. Investment in Master Trust

The Plan has specific interests in certain investments of the Master Trust based on account balances of the participants and their investment options. The Master Trust's assets are allocated among the participating plans by assigning to each plan those transactions (primarily contributions, benefit payments, and plan-specific expenses) that can be specifically identified and by allocating among all plans, in proportion to the fair value of the assets assigned to each plan, income and expenses resulting from the collective investment of the assets of the Master Trust.

6. Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service (the IRS) dated April 19, 2016, stating that the Plan is qualified under Section 401(a) of the IRC, and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related-Party and Party-in-Interest Transactions

The Plan holds shares of mutual funds and units of common trust funds managed by the Trustee of the Plan. The Master Trust also invests in the common stock of the Company and units of a common trust fund managed by the Custodian. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. During 2024, the Master Trust received \$7,167,522 in common stock dividends from the Company.

8. Subsequent Events

Plan management evaluated subsequent events for the Plan through June 26, 2025, the date these financial statements were available to be issued.
