Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Wellesley Community Children's Center Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Wellesley Community Children's Center Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Wellesley Community Children's Center Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of the Plan

The following description of Wellesley Community Children’s Center Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for more complete information regarding the terms of the Plan.

General

The Plan is an IRS Code Section 403(b) defined contribution plan covering all employees of Wellesley Community Children’s Center (“the Organization” or “Plan Sponsor”). The Plan was established on January 1, 1996, was amended effective February 1, 2020, and serves as a systematic savings plan for eligible employees (“the Participants”). The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA).

The Plan Sponsor has appointed TIAA as investment custodian, (“the Custodian”), to execute investment transactions, hold the Plan’s assets, and administer the Participants’ accounts.

Amendments

Effective January 1, 2025, the Plan was amended to accommodate the provisions of the SECURE Act 2.0 which include the “Super Catch-up” provision for Participants between the ages of 60 to 63.

Effective for the Plan Years ended December 31, 2024 and 2023, the employer contributed a matching contribution to each eligible participant in the Wellesley Community Children’s Center Retirement Plan equal to 100% of each Participant’s salary deferrals that did not exceed 5% of compensation for the Plan Year.

Eligibility

Employees are immediately eligible to make elective deferrals to the Plan upon hire. Participants who have attained age 18 and have completed one year of service, defined as 1000 hours, are eligible for employer matching contributions.

Contributions

The Plan provides for employee pre-tax and Roth contributions. Participants may contribute up to 100% of their pre-tax eligible compensation, subject to limitations under federal law (\$23,000 and \$22,500 for 2024 and 2023, respectively). Rollover contributions from other qualified plans are allowed. The Plan provides that Participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make a catch-up contribution of up to \$7,500 in 2024 and 2023. The Plan Sponsor may make discretionary matching contributions to the Plan.

Vesting

Participants are immediately vested 100% in all voluntary and employer matching contributions plus actual earnings thereon.

Note 1 - Description of the Plan (continued)

Participant Accounts

Each Participant's account is credited with the Participant's contributions and allocations of Plan earnings and losses and charged with an allocation of administrative expenses, if any. Allocations are based on Participant earnings or account balances as defined. The benefit to which a Participant is entitled is that which can be provided from the Participant's vested account.

Loans

Plan loans are allowed. Participants may borrow from their fund account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The term of any loan under this provision cannot exceed five years, except for loans for the purpose of acquiring a principal residence, where such loans may have a reasonable repayment period not to exceed ten years. Loans are collateralized by the Participants' vested account balances. No such loans were outstanding at December 31, 2024 and 2023.

Plan Investments

The Plan's investments are held by the Custodian in various mutual funds, pooled separate accounts, and fixed income annuity contracts. Participants have the option to allocate their individual accounts among the various investment alternatives and to make transfers as specified in the Plan document. Participant accounts are updated daily for any investment earnings or losses.

Benefits and Withdrawals

Vested benefits are paid to Participants or their beneficiaries upon retirement, death, disability, or termination of employment. In the event of the above, a Participant or their beneficiary may elect to receive either a lump-sum amount equal to the value of his or her account or installments. Once this cash payment is made, the Participant will not be entitled to any further benefits under this Plan. There may be a 10% federal tax penalty on the withdrawal if the Participant is under age 59-1/2. The benefits provided under this Plan may not be assigned or attached unless otherwise provided by law.

Hardship withdrawals are allowed under the provisions of the Plan and cannot exceed the amount required to meet the immediate financial need created by the hardship.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Fair Value Measurements

FASB ASC 820-10, “*Fair Value Measurements*,” applies to reported balances that are required or permitted to be measured at fair value under an existing accounting pronouncement. ASC 820-10 emphasizes that fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability and establishes a fair value hierarchy. The fair value hierarchy consists of three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs that utilize quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – Inputs that include quoted prices for similar assets and liabilities in active markets and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument. Fair values for these instruments are estimated using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows.

Level 3 – Inputs that are unobservable for the asset or liability, which are typically based on an entity’s own assumptions, as there is little, if any, related market activity.

In instances where the determination of the fair value measurement is based on inputs from different levels of the fair value hierarchy, the level in the fair value hierarchy within which the entire fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Investment Valuation and Income Recognition

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds* – valued at redemption values as quoted on major exchanges for shares held by the Plan at year end.
- *Pooled Separate Accounts* – Unregistered pooled separate accounts are divided into separate investment divisions which invest in shares of an underlying mutual fund. Division values are measured, unitized values multiplied by the underlying mutual fund Net Asset Value (NAV) minus any applicable surrender charges.
- *Guaranteed group annuity investment contracts* – Fixed interest annuity contracts are valued at contract value based on accumulated cash contributions, interest credited and transfers in, less any withdrawals and transfers out. Contract value is considered fair value.

Investment Valuation and Income Recognition (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the Fair Value Measurements policy above for discussion of fair value measurements

Purchases and sales of securities are recorded on a trade-date basis at market price for mutual funds, at net asset value for pooled separate accounts, and contract value for insurance contracts. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Contributions

Participants' contributions are recorded in the period in which their payroll deductions are withheld.

Benefits Paid Directly to Participants

Benefits payments are recorded when paid.

Expenses

Expenses associated with the administration of the Plan are paid by the Plan or by the Plan Sponsor.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

In accordance with Subtopic 820-10 (Note 2), certain investments that are measured at fair value using the Net Asset Value (NAV) per share (or its equivalent) practical expedient have not be classified in the fair value hierarchy. The NAV amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

For the year ended December 31, 2024 the Plan’s investments (including gains and losses on investments bought and sold during the year) appreciated in value by \$870,863.

The TIAA Traditional Benefit Responsive Investment Contracts (“investment contracts”) are not actively traded and significant other observable inputs are not available. Thus, the fair value of the investment contracts is calculated as contract value less a surrender charge which represents discontinuation value. This is the amount the Plan Participants would receive currently if they were to withdraw or transfer funds prior to maturity.

Note 5 – Investment Contract with Insurance Company

The Plan maintains fully benefit-responsive and non-benefit responsive investment contracts with TIAA (“the insurance company”). The insurance company maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified rate that is guaranteed to the Plan.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Contract value for the non-benefit responsive contracts is representative of fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The value of the investment contracts was \$131,400 and \$129,308 as of December 31, 2024 and 2023, respectively. The crediting interest is based on a formula agreed upon by the issuer but may not be less than zero. Such interest rates are reviewed on a semiannual basis for resetting. Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan would limit the Plan's ability to transact at contract value with the insurance companies.

Note 6 – Exempt Party-in-Interest Transactions

Certain Plan investments are guaranteed group annuity investment contracts, pooled separate accounts, and shares of mutual funds managed by TIAA. TIAA is also the Plan's Investment Custodian, as defined by the Plan therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid to Angell Pension Group during the Plan years ended December 31, 2024 and 2023 were \$3,933 and \$3,655, respectively.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Further, due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect Participants' account balances and the amounts reported in the accompanying financial statements.

Note 8 – Tax Status

The Plan's Custodian has provided the Plan Sponsor with the Internal Revenue Service's latest determination letter, which covers its determination of the Custodian's prototype plan in effect. In its most recent letter, the Internal Revenue Service has determined and informed the Custodian that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan is designed and is

currently being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan Sponsor is of the opinion that the Plan was tax exempt as of and for the years ended December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes it is no longer subject to income tax examinations for years prior to 2021.

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as SECURE 2.0. These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan Administrator has elected to adopt the “Super Catch-up” provision for Participants between the ages of 60 and 63, effective for the Plan year ending December 31, 2025. No other optional provisions were adopted.

Note 9 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 10 – Subsequent Events

FASB ASC 855-10, “*Subsequent Events*,” defines further disclosure requirements for events that occur after the balance sheet date but before financial statements are issued. In accordance with ASC 855-10, the Plan's Sponsor has evaluated events subsequent to December 31, 2024 through June 24, 2025 which is the date the financial statements were available to be issued. There were no material events noted during this period that would impact the results reflected in this report or the Plan's results going forward.
