As a result, the Plan has presented the financial statements using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**MAGELLAN 401(k) PLAN**  
Notes to the Financial Statements  
September 26, 2024 and December 31, 2023

**A - TERMINATION AND LIQUIDATION OF THE MAGELLAN 401(k) PLAN**

On May 14, 2023, ONEOK, Inc. (ONEOK), Otter Merger Sub, LLC and Magellan Midstream Partners, L.P. (Magellan) announced the signing of the Agreement and Plan of Merger. On September 25, 2023, ONEOK and its subsidiaries completed the acquisition. On September 19, 2023, the Compensation Committee of the Magellan GP, LLC Board of Directors adopted a resolution terminating the Magellan 401(k) Plan (the Plan) effective September 24, 2023, making liquidation of the Plan imminent. Beginning on September 25, 2023, legacy Magellan employees were given the option to roll their 401(k) balances into the existing ONEOK 401(k) Plan, another individual retirement account, take a lump sum distribution or remain in the Plan until the final disbursement of assets at a later date. On September 26, 2024, the Magellan 401K plan was liquidated and closed. Any investment balances that were not rolled out of the plan or distributed to a participant, in accordance with participant elections, were transferred to a separate retirement account outside of the plan.

Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan's termination also ceased employee and employer contributions into the Plan and ceased new participant notes receivable from the Plan.

**B - DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

1. General

Prior to termination, the Plan was a defined contribution plan covering substantially all employees of Magellan Midstream Holdings GP, LLC (the "Employer") and was adopted January 1, 2004. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

2. Eligibility

Prior to termination, any non-excluded employee was eligible to become a participant in the Plan upon date of hire.

3. Administration

Prior to termination, the Plan was administered by the Magellan Midstream Holdings GP, LLC Administrative Committee (the "Administrative Committee"), which consists of members appointed by the Chief Executive Officer of the Employer.

4. Contributions

Prior to termination, in accordance with the Plan document and Internal Revenue Service (IRS) regulations, participants could elect to make pre-tax, after-tax and Roth contributions for any percentage of their annual eligible compensation provided that the total contribution did not exceed 30% of their eligible compensation per pay period. Participants could also contribute amounts representing rollover contributions from other qualified plans. Certain participants could also make catch-up contributions as defined in the Plan document. The Employer made a matching contribution equal to the participant contributions; however, Employer contributions were limited to 6% of each participant's eligible compensation per pay period. The Employer could make discretionary contributions as authorized by the Board of Directors of Magellan GP, LLC, an affiliate of the Employer (Employer's Member). No

discretionary contributions were made since the inception of the Plan. Participants could direct the allocation of their contributions and employer matching contributions to any of the Plan's investment funds or to a permitted investment in their self-directed brokerage account under the Plan.

#### 5. Participant Accounts

Prior to termination, each participant's account was credited with the participant's contributions, the Employer's contributions, a monthly revenue share credit, earnings and losses and administrative fees. Subsequent to the termination of the Plan, all contributions ceased. Plan earnings and losses are allocated based on units, shares, or the cash method of accounting consistently followed and uniformly applied, as described in the Plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### 6. Vesting

Prior to termination, a participant had a non-forfeitable vested interest in the current fair value of the assets purchased with their contributions. A participant became 20% vested in the Employer's contributions made on their behalf after one year of service. Such vesting increased an additional 20% for each year of a participant's service, becoming 100% vested upon five years of service. In addition, a participant's account became 100% vested by reason of their death, total and permanent disability, reaching age 65, early retirement under a pension plan of the Employer, permanent layoff, permanent reduction in work force or termination or partial termination of the Plan.

As of September 24, 2023, all participants became fully vested in all contribution sources, regardless of status or years of vested service.

#### 7. Forfeitures

Prior to termination, employer contributions, which were not vested at the time a participant withdrew from the Plan by reason of termination of employment, were forfeited and could be used for certain items as specified in the Plan document, including payment of expenses of the Plan or to reduce the Employer's contributions. The amount of forfeitures included in the Plan's total investments as of December 31, 2023, was \$83,041.

#### 8. Benefit Payments

Prior to termination, distribution of a participant's vested account was available upon the participant's retirement, death, disability, termination of employment or attainment of age 59½ and two years of service. Distributions were available to satisfy a financial hardship meeting the requirements of the IRS regulations. Other in-service withdrawals were also available to participants subject to certain limitations as defined in the Plan document.

#### 9. Notes Receivable from Participants

Prior to termination, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and were permitted to carry up to two loans at any one time. Loan terms could not exceed five years unless the loan principal was used to acquire a primary residence, and, in those instances, the loan term could not exceed 10 years. If a participant terminated employment for any reason, any outstanding loan the terminated participant has with the Plan becomes immediately due and payable within 90 days. The loans were secured by up to 50% of the participant's non-forfeitable accrued benefit and such other collateral required by the Administrative Committee and bore interest at a fixed rate equal to the prime lending rate plus one percentage point at the initiation of the loan as determined by the Administrative Committee. Interest income was calculated by the trustee as the stated interest rate for the loan applied to the outstanding loan balance. Interest payments made by participants were credited to that participant's account balance.

## 10. Expenses

Empower Retirement served as the recordkeeper and Empower Trust Company, LLC served as the trustee/custodian of the Plan, collectively "Empower." Third party expenses associated with the administration of the Plan were charged to the participants' accounts and paid to the Plan's trustee unless the Employer elected to pay for such expenses. The Employer paid Plan expenses, other than certain trust fees.

### C - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### 1. Basis of Accounting

As a result of the decision to terminate the Plan effective September 24, 2023, and in accordance with U.S. generally accepted accounting principles, the Plan's financial statements as of September 26, 2024 and December 31, 2023, and for the period January 1, 2024 to September 26, 2024 and the year ended December 31, 2023, are presented using the liquidation basis of accounting.

Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. There are no material changes to the financial statements as a result of the change under the liquidation basis of accounting. All investments of the Plan were stated at fair value (the estimated net realizable cash value for investments as of December, 31, 2023, are equivalent to fair value).

#### 2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

#### 3. Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. See Note D for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Prior to the termination, dividend income was recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, for the period January 1, 2024 to September 26, 2024.

#### 4. Benefit Payments

Benefit payments were recorded when paid.

#### 5. Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued interest. Delinquent loans were reclassified as benefit payments based upon the terms of the Plan document.

#### 6. Recently Issued Accounting Standards Update

Changes to generally accepted accounting principles are established by the Financial Accounting Standards Board (FASB) in the form of Accounting Standards Updates (ASU) to the FASB Accounting Standards Codification. The Plan considers the applicability and impact to all ASUs. There were no recently issued ASUs adopted by the Plan for the period of January 1, 2024 to September 26, 2024.

## D - FAIR VALUE MEASUREMENTS

The Plan adhered to FASB Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*. ASC 820 establishes a fair value hierarchy that distinguishes between assumptions based on market data (observable inputs) and the Plan's assumptions (unobservable inputs). The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. For our level 2 investments, prices per unit values for variable annuity options were calculated daily by the annuity provider according to the methods described in the annuity contract.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The units of the common collective trusts that are not exchange-traded or quoted in an active market are valued at fair value using the NAV practical expedient. The NAV was based on the fair value of the of the underlying assets using NAV per share (or its equivalent) and are not classified in the fair value hierarchy.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There were no assets held in trust for the Plan as of September 26, 2024. The following table sets forth the Plan's investments recurring fair value measurements for each level within the fair value hierarchy at December 31, 2023:

#### E - PARTY-IN-INTEREST TRANSACTIONS

The Plan held notes receivable from participants. Certain Plan investments were shares of a collective trust managed by Putnam Investments, a party-in-interest to Empower. In addition, our self-directed brokerage funds were held with Empower. These transactions qualified as party-in-interest transactions. Fees incurred by the Plan for investment management services, record keeping, and administrative services were included in net appreciation in fair value of investments because they were paid through revenue sharing rather than a direct payment. The Plan incurred expenses associated with the administration of the Plan.

#### F - INCOME TAX STATUS

The Plan has received a determination letter from the IRS dated April 3, 2018, stating the Plan was qualified under Section 401(a) of the Internal Revenue Code (the "Code") and, therefore the related trust was exempt from taxation. Once qualified, the Plan was required to operate in conformity with the Code to maintain its qualification. Subsequent plan amendments have been executed since receiving the determination letter but the Plan Administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### G - RISKS AND UNCERTAINTIES

The Plan's investments at December 31, 2023, consisted of various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risk.

#### H - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 C.F.R. 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

Investments and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of September 26, 2024 and December 31, 2023.

Investment income and interest on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the period January 1, 2024 to September 26, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

#### I - SUBSEQUENT EVENTS

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through June 27, 2025, which is the date the financial statements were available to be issued.
