The annual report has been filed with the Employee Benefits Security Administration, formerly known as the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Plan expenses were \$14,899. These expenses included \$14,899 in administrative expenses, \$0 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 11 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan was \$2,553,107 as of 12/31/2024 compared to \$2,135,294 as of 01/01/2024.
