Report of Independent Auditors

To the Participants and Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Brunner & Lay Employees' Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America; and
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

Note 1. Description of the Plan

General - The Plan is a defined contribution retirement plan covering eligible employees of Brunner & Lay, Inc. (the Company). Any employee of the Company who has attained the age of 18 and has not previously enrolled in the Plan, is eligible to participate. Each new employee is also eligible to contribute to the Plan on the first of the month following their date of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

Employee Contributions - Each year, participants may contribute up to 60% of pre-tax annual compensation, as defined in the Plan, subject to Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various mutual fund investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated mutual fund. Such deferrals automatically increase each year by 1% to a maximum of 6%. Employees may opt out of the automatic enrollment features or revise their elections.

Employer Contributions - The Company may make discretionary matching contributions. Discretionary matching contributions, if made, will be computed based on eligible compensation deferred into the Plan each Plan year. Participants become eligible for matching employer contributions only if they make deferral contributions. For purposes of determining matching contributions under the Plan, contributions will not include age 50 and over catch-up contributions. Participants must complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the contribution period to be eligible to receive any matching contributions that may be made for that Plan year. For each of the years ended September 30, 2024 and 2023, the Company approved a matching contribution of \$65,000 which was allocated to participants based on their prorata share of the lower of 50% of the total deferrals made or 50% of the first 6% of base compensation. For the years ended September 30, 2024 and 2023, employer contributions are shown net of forfeitures of \$20,000 and \$30,000 respectively. Although the Company may also make a discretionary non-elective employer contribution to the Plan as approved by the Company's management, the Company did not make any non-elective employer contributions for the years ended September 30, 2024 and 2023.

Note 1. Description of the Plan (continued)

Participant Accounts - Each participant's account is credited with the participant's contributions, allocations of any Company matching contributions made to the Plan, as well as allocations of investment earnings or losses and certain administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments - Participants may direct contributions into various investment options offered by the Plan. Participants must evaluate their own investment goals and objectives and choose investments best suited to achieve those goals and objectives. Poor investment performance by the investments selected by the participants may cause their balances to be lower than the amounts contributed to the Plan on their behalf.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in non-elective employer matching contributions made on behalf of participants is based on years of service. A participant is 100% vested after six years of credited service, as follows:

Notes Receivable from Participants - Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, and may be extended to 10 years for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at rates which ranged from 5.25% to 10.50% during the years ended September 30, 2024 and 2023, and are rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. These loans mature at various dates through March 2029.

Payment of Benefits - Payments of benefits are made in accordance with Plan provisions. Upon termination of service, participants will receive either a lump-sum amount equal to the value of the vested interest in their account, periodic payments or any other lawful method of payment. The Plan also provides for in-service withdrawals in the event of financial hardship, as defined by the Plan.

Note 1. Description of the Plan (continued)

Forfeited Accounts - At September 30, 2024 and 2023, net assets available for benefits included unallocated amounts totaling \$30,374 and \$52,918 respectively, which represent forfeited nonvested accounts. Forfeitures are retained in the Plan and may first be used to pay administrative expenses. Any remaining amounts will be used to reduce future employer contributions. Forfeitures incurred during the years ended September 30, 2024 and 2023 totaled \$4,616 and \$2,849 respectively. Forfeitures used to pay administrative expenses totaled \$678 and \$141 during the years ended September 30, 2024 and 2023, respectively. During the year ended September 30, 2024, the forfeiture account was used to reduce employer contributions related to the year ended December 31, 2023 by \$30,000. During the year ended September 30, 2023, the forfeiture account was used to reduce employer contributions related to the year ended December 31, 2022 by \$50,000. The forfeiture account is also credited with investment earnings and charged with administrative fees, which netted to \$3,518 and (\$764) for the years ended September 30, 2024 and 2023, respectively.

Participants should refer to the Plan document for more complete information.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements are prepared using the accrual basis of accounting.

New Accounting Pronouncement - In June 2016, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) No. 2016-13, *Financial Instruments - Credit Losses* (Topic 326), which is effective for the Plan for the year ended September 30, 2024. This new standard provides financial statement users with more decision-useful information about the expected credit losses on financial instruments and other commitments to extend credit held by a reporting entity at each reporting date. The standard replaced the incurred loss impairment model with a methodology that reflects expected credit losses and requires consideration of a broader range of reasonable and supportable information to inform credit loss estimates. The standard was considered immaterial for recognition and disclosure.

Investments - The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of securities are reflected on a trade-date basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of September 30, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent participant notes receivable are classified as distributions based on the terms of the Plan document.

Note 2. Summary of Significant Accounting Policies (continued)

Excess Contributions Payable - Amounts payable to participants totaling \$6,515 and \$6,526 at September 30, 2024 and 2023, respectively, for contributions in excess of amounts allowed by the Internal Revenue Code are recorded as excess contributions payable, with a corresponding deduction from net assets. The Plan made the corrective distributions prior to December 15, 2024 and 2023, respectively.

Payment of Benefits - Benefits are recorded when paid. There were no participants who elected to withdraw from the Plan but were not yet paid at either September 30, 2024 or 2023.

Expenses - Certain administrative expenses of maintaining the Plan are paid by the Company and are excluded from the financial statements. Fees and expenses included in the financial statements represent direct charges to participants' accounts related to investment management fees and processing of notes receivable. Certain investment related expenses are included in net appreciation in fair value of investments.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events - Subsequent events were evaluated through July 10, 2025, which is the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The following provides a description of the three levels of the fair value hierarchy:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

Note 3. Fair Value Measurements (continued)

The Plan's investments in mutual funds are classified within Level 1 of the fair value measurements hierarchy. The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

Note 4. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fidelity Workplace Services is the recordkeeper of the Plan. Administrative expenses paid to the Trustee and recordkeeper amounted to \$3,030 and \$3,771 for the years ended September 30, 2024 and 2023, respectively.

Note 5. Priorities upon Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant's account shall become fully vested. In no event may any of the Plan assets revert to the Company.

Note 6. Tax Status

Effective January 14, 2013, the Plan was amended as a Volume Submitter ("Volume Submitter") Profit Sharing Plan sponsored by the Trustee and adopted by the Plan. The Volume Submitter Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Volume Submitter Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not requested its own determination letter. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 8. Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and these changes could materially affect the participant account balances and amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

The Plan has a significant portion of its assets invested in the Fidelity Contrafund investment. The investment represented approximately 23% of the Plan's net assets available for benefits as of September 30, 2024. There were no investment concentrations as of September 30, 2023.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across the participant directed fund elections. Additionally, the investments within each participant directed fund election are further diversified into varied financial instruments. Investment decisions are made, and the resulting risks are borne, exclusively by the Plan participant who made such decisions.
