### **Opinion**

We have audited the accompanying financial statements of San Diego County Theatrical Training Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of September 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The San Diego County Theatrical Training Fund (the "Plan") was organized on March 1, 2007 for the purpose of providing training and education for eligible employees and others covered by Collective Bargaining Agreements. The Plan is administered pursuant to a trust agreement (the "Trust") dated March 1, 2007 by and between San Diego Theatrical Union and such other contributing employers who may hereafter become parties of the Trust.

FOR A FULL DESCRIPTION OF THE TRUST, PARTICIPANTS SHOULD REFER TO THE TRUST AGREEMENT AND ANY AMENDMENTS FOR MORE COMPLETE AND CURRENT INFORMATION.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The accounts of the Plan are reported on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**C. Employer Contributions**

Contributions as reported are contributions made for hours worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

**D. Employer Payroll Compliance Program**

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

**E. Tax-Exempt Status**

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(3) and the state of California under Revenue and Taxation Code Section 23701a.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**F. Investment Valuation and Income Recognition**

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments include a mutual fund valued based on quoted prices in an active market.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes gains and losses on investments bought and sold as well as held during the year.

**NOTE 3 - RELATED PARTY TRANSACTIONS**

Through a lockbox system, a related fund, the San Diego Theatrical Group Insurance Trust Health and Welfare Fund ("Health Plan") collects employer remittances on behalf of the Plan, and transmits to the Plan the amounts collected on the Plan's behalf. The Plan was owed \$3,000 by the Health Plan at September 30, 2024 and 2023.

The Plan provides funding to the San Diego County Theatrical Training Corporation ("Training Corp"); any unused funds are recorded as unearned income and any owed funds are categorized as advances. The Plan owed the Training Corp \$8,000 at September 30, 2024 and 2023.

The Plan was owed \$8,967 by the San Diego County Theatrical Pension Plan ("Pension Plan") at September 30, 2024 and 2023.

**NOTE 4 - PLAN TERMINATION**

The Plan shall remain in effect for the period set forth in any applicable collective bargaining agreement, or as determined by the Trustees, or by mutual consent of the parties of the Trust Agreement.

In the event of the termination of the Plan, any remaining funds shall be expended exclusively for the Plan's purposes.

**NOTE 5 - RISKS AND UNCERTAINTIES**

Plan investments are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is reasonably possible that changes in risks in the near term would materially affect the amounts reported in the financial statements.

**NOTE 6 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through June 11, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
