## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator  
Guarantee Electrical Company  
Employee Security Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Guarantee Electrical Company Employee Security Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Guarantee Electrical Company Employee Security Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Guarantee Electrical Company (the Company). All employees, excluding those covered by collective bargaining agreements, are eligible to participate in the Plan on date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Charles Schwab Trust Bank serves as the custodian. EPIC Retirement Plan Services provides recordkeeping services to the Plan. An officer of the Company is the plan administrator and has overall responsibility for the operation and administration of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

The Plan allows participants to contribute not less than 1% of their payroll period compensation and up to 100% of their plan compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan permits after-tax voluntary contributions and an in-plan Roth conversion election on such contributions. The minimum amount that may be transferred is \$1,000 and the transfers may only be made from accounts which are 100% vested. The Company utilizes automatic enrollment for employees at 3% unless they choose to decline participation.

The Company makes matching contributions equal to 35% of the participant's elective deferral on the first 6% of compensation.

Contributions are subject to certain limitations. Participants may also transfer funds to the Plan from other qualified retirement plans. Participants elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and the Company's contribution and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary and Company matching contributions plus actual earnings thereon.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability or retirement, participants may elect to receive the value of their accounts as a lump-sum distribution.

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship or at the age of 59 ½. Hardship withdrawals are subject to specific statutory and regulatory requirements.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions and Contributions Receivable**

Contributions from participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Plan expenses primarily consist of recordkeeping fees and custodian management fees. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Certain Plan investments make revenue sharing payments that are expense reimbursements and administrative service fees paid from some mutual funds and collective trust funds to the Plan. The amount of revenue sharing varies by investment. Any revenue sharing payments are paid to the trust and allocated to participant accounts as a dividend.

**Subsequent Events**

Subsequent events were evaluated through July 9, 2025 which is the date the financial statements were available to be issued.

**NOTE 3 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at September 30, 2024 and 2023.

*Mutual Funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end.

*Common/Collective Trust:* Valued at the NAV of the fund, which is based on the estimated market value of the underlying investments. The fund is valued at NAV, the practical expedient to estimate fair value.

**NOTE 4 — CERTIFIED INVESTMENTS**

Investments and notes receivable from participants held at September 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended September 30, 2024, disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from data provided to the plan administrator and certified to as complete and accurate by Charles Schwab Trust Bank, the custodian.

**NOTE 5 — PARTY IN INTEREST TRANSACTIONS**

Charles Schwab is the custodian as defined by the Plan and is paid for investment management services through the administrative fee paid to the Plan's record keeper, EPIC Retirement Plan Services, LLC (EPIC RPS). These transactions are party-in-interest transactions. The Plan made direct payments to EPIC RPS of \$64,347 for investment management services provided by Charles Schwab for the year ended September 30, 2024. Operating payables to EPIC RPS was \$21,736 and \$-0- at September 30, 2024 and 2023, respectively. The plan sponsor pays directly any other fees related to the Plan's operations.

**NOTE 6 — PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

**NOTE 7 — DELINQUENT PARTICIPANT CONTRIBUTIONS**

During the year ended September 30, 2024, the Company failed to remit to the Plan's custodian certain employee contributions totaling \$953 within the period prescribed by the Department of Labor's regulations. These instances were corrected and the Company has made contributions to the affected participants' accounts for potential lost income due to the delays.

**NOTE 8 — TAX STATUS**

As this Plan is a pre-approved defined contribution plan, the IRS issued a letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this plan will be considered to have a plan qualified under Code Section 401(a) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan agreement.

**NOTE 9 — RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
